## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Ampro ADLink 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Ampro ADLink 401(k) Profit Sharing Plan (the “Plan”) (formerly known as Ampro Computer, Inc. Profit Sharing Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan that was established in 2002 by Ampro ADLINK Technology, Inc. (formerly known as Ampro Computer, Inc.) (the “Company” or “Employer”) to provide benefits to eligible employees, as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (“IRC” or the “Code”), as amended, and the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

#### Administration

The Company has appointed a 401(k) Committee to manage the operation and administration of the Plan. The Company has contracted with Reliance Trust Company to act as the custodian, ADP Retirement Service, a third-party administrator to process and maintain the records of participant data; and Blackbridge Financial, as an investment advisor and consultant.

#### Eligibility

Full time employees of the Company who are at least 18 years old are eligible to participate in the Plan immediately upon hire.

#### Participant Contributions

Participants may elect to have the Company contribute their eligible pre-tax compensation or make after-tax Roth deferrals to the Plan up to the amount allowable under the Plan document and current income tax regulations. Participants who have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Participants who have attained the age 50 before the end of the Plan year are eligible to make catch-up contributions.

#### Rollover Contributions

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant’s direction and the Plan’s provisions.

### NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

#### Employer Contributions

The Company may make matching and/or discretionary nonelective profit sharing contributions under the Plan subject to certain eligibility requirements. In 2024, the Company matched 50% of the first 4% of a participant's eligible compensation.

For any discretionary nonelective Employer profit sharing contribution, each Participant will receive an allocation of the Employer profit sharing contribution on an annual basis in the same ratio as each participant's compensation bears to the total of such compensation of all participants. At the end of every year, a true-up calculation is performed. There were no discretionary nonelective Employer profit sharing contributions made for the year ended December 31, 2024.

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution and Employer discretionary nonelective profit sharing contribution portion of their accounts is based on years of continuous service.

Participants vest in the Company's employer matching contributions based on the following schedule:

##### Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, rollovers from qualified plans of the participant's previous employers, Company contributions, if any, and allocations of the Plan's earnings and administrative expenses. The benefit to which a participant is entitled to is the benefit which can be provided by the participant's vested account.

##### Investment Options

Participants must direct their salary deferral contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options any time throughout the year via the Internet website or by using the automated telephone system offered by the custodian.

##### Payment of Benefits

A participant that reaches age 59 1/2 may request a distribution for the entire vested balance, in his or her account. Before age 59 1/2, a participant may request an in-service distribution from accounts attributable to their rollover contributions. Upon a participant's retirement, termination of employment, death, or disability, the participant (or the participant's beneficiary in the event of death) may elect to receive a lump sum distribution equal to the value of his or her account, equal installment payments over the period of the life expectancy of the participant or the life expectancy of the designated beneficiary, or direct trustee to trustee rollovers. The Plan allows for the automatic lump sum distribution of participant vested account balances that do not exceed \$5,000.

##### Financial Hardship Distributions

The Plan allows hardship withdrawals in accordance with the Internal Revenue Service ("IRS") regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes.

##### Notes Receivable from Participants

The Plan allows participants to borrow up to the lesser of \$50,000 or 50% of their account balance with a minimum of \$1,000 per loan. The notes are secured by the participant's vested balance. Such notes bear interest at the prime rate in the Wall Street Journal plus 1% and must be repaid to the Plan within a five-year period unless the note is used for the purchase of a principal residence in which case the maximum repayment period is thirty years. A participant can have one loan currently outstanding from the Plan at any time. The specific terms and conditions of such notes are established by the Company. Outstanding notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50% and mature through 2029. Outstanding notes receivable from participants at December 31, 2023 carry interest rates ranging from 4.25% to 9.50% and mature through 2026.

#### Forfeitures

Participant forfeitures occur when the Employer contribution portion of a participant's account has not fully vested at the time of withdrawal. These forfeited amounts are utilized first to pay Plan expenses and then to reduce future Employer contributions. As of December 31, 2024 and 2023, there were forfeited non-vested accounts of \$10 and \$10, respectively. In 2024, \$31,137 of forfeitures were applied to reduce Employer contributions.

### NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

Management fees charged to the Plan for investments in registered investment companies are based on assets invested and are deducted on a daily basis. Management fees are reflected as a reduction of investment return for such investments.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document. The delinquent notes receivable from participants were \$6,704 and \$6,337 as of December 31, 2024 and 2023, respectively. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

##### Benefit Payments

Benefit payments are recorded when paid.

##### Plan Expenses

Plan expenses will be charged on a pro-rata basis to the value of the participants account balances if not paid out of the forfeitures account.

##### Income Taxes

The Plan has adopted a non-standardized pre-approved plan. The pre-approved plan has received an opinion letter from IRS as to the pre-approved plan's qualified status. The plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC. Therefore, no provisions for income taxes have been recorded in the Plan's financial statements.

##### Risks and Uncertainties

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits and the statement of changes in net assets available for plan benefits.

##### Subsequent Events

In 2025, the Company changed the investment advisor and consultant to New Front Retirement Service, Inc.

The Plan has evaluated subsequent events through October 2, 2025, which is the date the financial statements were available to be issued.

### NOTE 3 – FAIR VALUE MEASUREMENT

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies (mutual funds)*

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Investment Trust*

Units held in the collective investment trust (“CIT”) are valued using the net asset value practical expedient (NAV practical expedient) of the CIT as reported by the CIT managers. The NAV practical expedient is based on fair value of the underlying assets owned by the CIT, minus its liabilities, and then divided by the number of units outstanding. The NAV of a CIT is calculated based on a compilation of primarily observable market information. The CIT has daily redemption frequency, daily redemption period, no restrictions and has no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- Net appreciation in fair value of investments, interest and dividend income, other income, and interest income on notes receivable from participants reflected in the accompanying statement of changes in net assets available for plan benefits for the year ended December 31, 2024;
- Investments and notes receivable from participants reflected in the supplemental schedule: Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

#### **NOTE 5 – UNCERTAIN TAX POSITIONS**

U.S. GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS or the DOL. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
