**NOTE 1: DESCRIPTION OF PLAN**

The following description of the Full Stack Finance 401(k) Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan was originally effective on September 1, 2014, and most recently restated July 1, 2024, and is a defined contribution plan established by Full Stack Finance, LLC (the "Company") under the provisions of Section 401(k) of the Internal Revenue Code (IRC), which includes a deferred arrangement for the benefit of eligible employees of the Company. The Plan is structured to comply with the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Merger** - On December 26, 2024, the Board of Directors of Escalon Services, LLC (the "Parent Company") adopted a resolution to allow the merger of the Plan into the Escalon Services, Inc. 401(k) Savings Plan effective January 1, 2025. The Board of Directors also adopted a resolution to allow the transfer of assets to the Escalon Services, Inc. 401(k) Plan. Assets of \$3,125,486 were transferred from the Plan on December 31, 2024, in accordance with Code 414(1) and regulations thereunder. Since the Plan still had ownership of these assets as of December 31, 2024, these Plan assets are reflected as cash in transit on the statements of net assets available for benefits.

**Eligibility** - All employees, except for union employees, leased employees, and nonresident aliens who have no U.S. sourced earned income, are eligible to enter the Plan upon attaining 18 years of age. There is no service requirement. Entry into the Plan is the first day of the pay period after or coincident with the date eligibility requirements are met.

**Contributions** - Participants may elect to contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants could also elect to contribute after-tax Roth contributions. A Roth contribution is defined as being made in lieu of all, or a portion of, the pretax elective deferral the participant is otherwise eligible to make under the Plan and treated by the employer as includible in the participant's income. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions are invested in a designated fund until changed by the participant. The Company makes an enhanced safe harbor matching contribution equal to 100% of participant contributions up to 4% of eligible compensation. Each year, the Company may contribute, at its discretion, a profit-sharing contribution to participants in the Plan. For the years ended December 31, 2024 and 2023, no profit-sharing contribution was made by the Company. Contributions are subject to limitations to comply with the nondiscrimination requirements of the IRC.

**NOTE 1: DESCRIPTION OF PLAN - CONTINUED**

**Participant Accounts** - Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings, as well as charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant-initiated transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their salary deferral contributions and the Company's safe harbor matching and nonelective contributions, plus actual earnings thereon. Safe harbor match contributions are fully vested when made.

**Notes Receivable from Participants** - Participants with a vested account balance of \$2,000 or more may borrow a minimum loan of \$1,000 and a maximum amount of the lesser of 50% of the participant's vested account balance or \$50,000 reduced by the highest outstanding loan balance during the previous 12 months. The loans are secured by the balance in the participant's account. All loans pay a rate of interest based on the prime rate plus 1%. Loan rates are determined on the date the loan is requested. The loans are secured by the balances in the participants' accounts. The loan agreement provides that loan repayments will be made through payroll deduction and repaid within a five-year period. Upon termination, the entire outstanding principal and accrued interest shall be immediately due and payable, or the participant will be deemed to have received a taxable distribution from the Plan. Only one loan can be outstanding at a time.

**Payment of Benefits** - Upon termination of service due to death, disability, retirement (age 65), or separation from service, a participant may elect to receive all or any portion of his or her eligible account balance paid in a lump-sum, or a direct rollover to an individual retirement account or another eligible retirement plan. An automatically enrolled participant has 90 days from the day of the first automatic deferral to request a permissible withdrawal. If a terminated participant's account is \$1,000 or less and the participant does not make an affirmative election to take a lump-sum distribution or rollover the balance, the plan administrator will issue a mandatory lump-sum distribution to the participant. A participant who has reached age 59½ may elect to withdraw all or a portion of his or her entire account while still employed.

As required under Section 401(a)(9) of the Code, a participant who is not a five percent or more owner of the Company must begin receiving required minimum distributions from the Plan by April 1 of the calendar year following the later of (i) the calendar year following the year in which the participant reaches age 73, or (ii) the calendar year in which the participant retires.

**NOTE 1: DESCRIPTION OF PLAN - CONTINUED**

*Hardship Withdrawals* - Participants may withdraw their vested account balances in the form of a hardship withdrawal to satisfy an immediate and heavy financial need as defined by the Plan. The minimum amount of a hardship distribution is \$1,000 and a participant may take no more than two hardship distributions during a plan year.

*Forfeitures* - Forfeitures occur in the plan year that a participant receives a distribution of the entire vested account balance, or if the participant does not receive a distribution, after five consecutive one-year breaks in service. Forfeited amounts are used to reduce employer contributions or pay administrative expenses. There were no forfeited nonvested accounts as of December 31, 2024 and 2023, and no forfeitures were used to reduce the employer contributions.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting* - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

*Use of Estimates* - The preparation of financial statements, in accordance with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* - Investments are reported at fair value. Fair value is the price that would be received to trigger the sale of an asset or paid for the transfer of a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Participant Contributions Receivable* - As of December 31, 2024 and 2023, the Plan had \$0 and \$15,480, respectively, in contributions receivable from participants.

*Employer Contributions Receivable* - As of December 31, 2024 and 2023, the Plan had \$0 and \$8,686, respectively, in contributions receivable from participants.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED**

*Notes Receivable from Participants* - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

*Payment of Benefits* - Benefits are recorded when paid.

*Administrative Expenses* - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees associated with participant-initiated transactions are charged directly to participants' accounts and are included in administrative expenses. Some administrative expenses are paid from the annual operating expenses of the Plan's designated investment alternatives.

*Subsequent Events* - The Plan's policy is to evaluate events and transactions subsequent to its year end for potential recognition in the financial statements or disclosure in the notes to the financial statements. The plan administrator has evaluated events and transactions through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

**NOTE 3: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the principal valuation methodologies used for assets measured at fair value. There have been no change in the methodology used as of December 31, 2024 and 2023.

**Registered Investment Companies (Mutual Funds)** - Registered Investment Companies (Mutual Funds) are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common Collective Trusts** - Common collective trusts are valued at the NAV of units held by the Plan at year end. The NAV is determined by the custodian of the trust and is based upon the fair value of the underlying assets held by the trust. NAV is used as a practical expedient to estimate fair value. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5: RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan has not considered normal plan operations such as participant and employer contributions to the Plan or benefits accrued or paid by the Plan for participants as party-in-interest transactions that require separate disclosure.

The Plan issues loans to participants, which are secured by the balances in the participants' accounts. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.

**NOTE 6: PLAN TERMINATION**

The Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their account balances. See Note 1 regarding the Plan's merger into the Parent Company's plan effective January 1, 2025.

**NOTE 7: TAX STATUS**

Effective January 1, 2022, the Plan was restated to adopt the Guideline Inc. non-standardized pre-approved profit-sharing plan with cash or deferred arrangement (CODA), which has received an opinion letter from the Internal Revenue Service (IRS) dated November 18, 2020, stating that the form of the Plan is qualified under the IRC and therefore, the related trust is tax exempt. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification.

Effective July 1, 2024, the Plan was restated to adopt the ADP, LLC non-standardized pre-approved profit-sharing plan with CODA, which has received an opinion letter from the IRS dated October 6, 2020, stating that the form of the Plan is qualified under the IRC and therefore, the related trust is tax exempt. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS or DOL. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's federal Form 5500 is subject to examination by the IRS and DOL, generally for the three years after it was filed.

**NOTE 8: RISKS AND UNCERTAINTIES**

The Plan invests in shares of registered investment companies and a common collective trust that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9: COMMITMENTS AND CONTINGENCIES**

In the normal course of business, there may be various commitments and contingencies outstanding which are not reflected in these financial statements. In the opinion of the plan administrator, the outcome of such events, if any, would not have a material effect on the Plan's financial position or operations.

**NOTE 11: PROHIBITED TRANSACTIONS**

As required by ERISA Section 2510.3-102, the Company is required to segregate employee contributions and loan repayments to the Plan from its general assets as soon as practicable. The Plan has contributions totaling \$17,434, all of which represented employee salary deferrals and loan repayments, that were not remitted in a timely manner. These contributions are considered prohibited transactions. The Company has calculated and deposited lost investment earnings to correct the prohibited transactions.

**NOTE 12: PLAN RESTATEMENT AND TRANSFER**

Effective July 1, 2024, the Plan was restated to adopt the ADP, LLC non-standardized pre-approved profit-sharing plan with CODA. The Plan changed its custodian and recordkeeper from Benefit Trust Company and Guideline to ADP Retirement Plan Services and ADP Retirement Trust Services, LLC. Effective July 19, 2024, all assets were transferred from the Benefit Trust Company to ADP Retirement Trust Services, LLC.

**NOTE 13: SUBSEQUENT EVENTS**

On December 26, 2024, the Board of Directors of Escalon Services, LLC (the “Parent Company”) adopted a resolution to allow the merger of the Full Stack Finance 401(k) Plan into the Escalon Services, Inc. 401(k) Savings Plan effective January 1, 2025. The Board of Directors also adopted a resolution to allow the transfer of assets to the Escalon Services, Inc. 401(k) Plan. Assets of \$3,125,486 were transferred from the Full Stack Finance 401(k) Plan on December 31, 2024, in accordance with Code 414(1) and regulations thereunder. Since the Plan still had ownership of these assets as of December 31, 2024, these Plan assets are reflected as cash in transit on the statements of net Assets available for benefits. Escalon Services, Inc. 401(k) Plan did not receive the transfer of assets until 2025. As of December 31, 2024, the Plan only held investments of \$1,848, which were transferred to the Escalon Services, Inc. 401(k) Savings Plan in 2025.
