INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Belnick, Inc. Retirement Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Belnick, Inc. Retirement Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Belnick, Inc. Retirement Trust Notes to Financial Statements

Note 1: DESCRIPTION OF PLAN

The following description of the Belnick, Inc. Retirement Trust (the Plan) provides only general information. Refer to Plan documents for a more complete description of Plan provisions.

General

The Plan is a defined contribution plan, which was adopted as of January 1, 2006, covering all full-time employees of Ubique Group (the Plan Sponsor, Company, the Plan Administrator and the Employer). Effective February 1, 2023, the Company announced a rebranding where the company name transitioned from Belnick Inc. to Ubique Group. The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Reliance Trust Company, the trustee and qualified institution for the Plan, which invests contributions and Plan earnings, makes investment transactions as directed by the Plan's management. ADP Retirement Services acts as the recordkeeper for the Plan, which performs certain recordkeeping services and annual ERISA compliance testing.

Eligibility

Employees who are at least 19 years of age, except for employees represented by a collected bargaining agreement, leased employees, and nonresident aliens who do not receive any United States source earned income, are eligible to become a participant of the Plan once they have reached three months of service. An eligible employee may enter the Plan on the next quarterly entry date after all entry requirements have been met.

Contributions

Each year, participants may contribute up to 100 percent (%) of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. These amounts can be either pre-tax 401(k) contributions or after tax Roth 401(k) deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer matches a percentage of the participant's pre-tax contributions. The Plan provides for a safe harbor matching contribution of 100% of each participant's contribution not exceeding 3% of the participant's compensation, plus 50% of each participant's contribution in excess of 3% but not to exceed 5% of the participant's compensation. In total, the safe harbor match contribution will not exceed 4% of a participant's compensation. Participants are immediately eligible for the safe harbor match upon meeting the eligibility requirements to participate in the Plan.

Note 1: DESCRIPTION OF THE PLAN (Continued)

Contributions (continued)

The Employer may also make a discretionary matching contribution to the Plan equal to a percentage of each participant’s contribution. Participants must complete one year of service to be eligible for the discretionary match. There were no discretionary matching contributions for the years ended December 31, 2024 and 2023.

The Employer may also make a discretionary profit-sharing contribution to the Plan. Participants must complete one year of service to be eligible for the discretionary profit-sharing contribution. There were no discretionary profit-sharing contributions for the years ended December 31, 2024 and 2023.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Company’s matching contributions, as well as allocations of the Company’s discretionary matching contributions and profit-sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are always 100% invested in their employee contributions and employer safe harbor contributions. Participants become 100% vested in the Employer’s matching contributions and profit-sharing contributions and earnings thereon when the participants reach normal retirement age. Prior to normal retirement age, the participants become vested in the discretionary matching contributions and profit-sharing contributions, earnings and forfeitures based on the following schedule:

Years of Credited Service	% Vested
Less than 1	0%
1, but less than 2	20%
2, but less than 3	40%
3, but less than 4	60%
4, but less than 5	80%
5 or more	100%

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000 or 50% of the vested portion of his/her account balance, repayable within five years (unless the proceeds were used to purchase the participant’s principal residence), bearing interest at a reasonable rate of interest as determined by the Plan Administrator. The loans are secured by the balance in the participant’s account. Principal and interest is paid ratably through scheduled payroll deductions.

Note 1: DESCRIPTION OF THE PLAN (Continued)

Benefit Payments

The participant's vested portion of his/her account balance is available for distribution in the event of retirement, early retirement (age 55 and 5 years of service), death, disability or termination of employment, subject to the Plan's provisions. If the value of the participant's account is \$5,000 or less it is paid in a lump sum payment. If the value of the participant's account is greater than \$5,000, the participant could elect to receive the distribution in a lump-sum payment, substantially equal installments and partial withdrawals.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0.

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC), a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments generally are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are recorded as distributions per the plan document.

Payment of Benefits

Distributions to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the administrative expenses in the accompanying statements of changes in net assets available for benefits.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, October 7, 2025, and determined there were no events that required disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies at December 31, 2024 and 2023.

Money market mutual fund: Valued at net asset value (NAV) of \$1 as reported by the fund manager.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: TAX STATUS

Belnick Inc. has adopted the ADP Prototype Non-Standardized 401(k) Profit Sharing Plan. The prototype plan received a favorable opinion letter from the IRS in March of 2008 stating that the form of the prototype plan is qualified under §401 of the IRC, and therefore, the related trust is tax exempt. The prototype plan has been amended subsequent to the receipt of the favorable opinion letter to comply with various law changes and to make certain operational changes. However, the Plan itself has not received a determination letter from the IRS. The Plan Administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, the Plan was qualified and the related trust was tax-exempt at December 31, 2024 and 2023.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6: PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Reliance Trust Company. Reliance Trust Company is the trustee and custodian for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Certain expenses of the Plan are paid directly by the Plan. In addition, certain services to the Plan by the Employer were performed at no charge.

Note 7: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
