Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of All American Homecare Agency Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. 1. Description of the Plan

The following description of the All American Homecare Agency Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan's agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of All American Homecare Agency Inc. (the Company). Employees become eligible to participate in the Plan immediately upon their hire date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Contributions are made to the Plan by participants who may elect to defer either a fixed amount or a percentage of their annual compensation by a salary reduction election, subject to certain Internal Revenue Code (the Code) imposed limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common collective trust as investment options for participants.

The Company also makes discretionary profit-sharing contributions. To be eligible to receive the discretionary contribution, the employee must be an eligible participant in the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, the employer's contributions, and investment earnings, and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, as well as the employer discretionary profit-sharing contribution, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts an amount equal to the lesser of \$50,000 or 50% of their account balance. The minimum amount a participant can borrow is \$1,000. Participants can have up to two outstanding loans at the same time, and the number of loans approved for any participant in a 12-month period shall be limited to one. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing lending rates. Interest rates on outstanding loans ranged from 4.25% to 9.50% during the years ended December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence. These loans are subject to certain restrictions, as defined by the Plan document, and applicable restrictions under

the Code. There was \$83,872 and \$95,904 in deemed loans for the years ended December 31, 2024 and 2023, respectively, which is included in benefits paid to participants and beneficiaries in the statements of changes in net assets available for benefits.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or receive a series of cash installments over a period not exceeding the life expectancy of the participant or the participant's beneficiary. For termination of services for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distribution fees are charged directly to each participant's account and are included in administrative expenses. Investment-related expenses are included in the net appreciation in fair value of investments.

Cash-Outs of Accounts and Consent to Distribution

If the value of a participant's vested interest in their account is \$5,000 or less, the participant's account will be cashed out by distributing the participant's vested interest by a single-sum payment or by direct rollover to an individual retirement account, or other eligible retirement plan, as soon as reasonably practicable following the date the participant's employment terminates. Distribution of the account balance cannot be made before the participant's normal retirement date without the participant's written consent.

Net Transfer to Affiliated Plan

The Plan transfers assets from and to All American Homecare CDPAP Employee Savings Plan, an Affiliated Plan, due to changes in participants' employment status. For the years ended December 31, 2024 and 2023, net transfer from the Affiliated Plan totaled \$28,360 and \$47,994, respectively. All benefits accrued under the Plan were incorporated into the Affiliated Plan to the extent required by law. The transfer of the assets is reflected in the statements of changes in net assets.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements were prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes

therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are held in a trust fund maintained by Reliance Trust Company (Reliance). Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisor. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Contributions Receivable

Participant contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Nonelective contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Payment of Benefits

Payments of benefits are recorded when paid.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets and liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.

- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Common Collective Trust - This fund is valued based upon the unit values. Unit value is based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means. Net asset value (NAV) is used as a practical expedient to estimate fair value. There are no restrictions on the redemption of this investment and no unfunded commitments.

Mutual Funds - The mutual funds are valued at the daily closing price, as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Related Party and Party-in-Interest Transactions

Notes receivable from participants qualify as exempt party-in-interest transactions. Administrative fees paid by the Plan to the trustee amounted to \$204,667 and \$177,811 for the years ended December 31, 2024 and 2023, respectively.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

If this Plan should be terminated, the right of all participants to the amounts credited to their accounts as of the date of such termination shall be nonforfeitable.

6. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance, a qualified institution.

7. Risks and Uncertainties

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Tax Status

The Plan has adopted a prototype non-standardized profit-sharing plan with cash or deferred arrangement (CODA). Accordingly, the Plan is permitted to rely on the opinion letter dated October 6, 2020 from the Internal Revenue Service (IRS), which stated that the prototype profit-sharing plan was designed in accordance with the applicable sections of the Code. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualifications. The Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Subsequent Events

There have been no material subsequent events that occurred through October 7, 2025, the date these financial statements were available to be issued, that would require disclosure in these financial statements, except the following:

On April 22, 2024, the final New York State-enacted budget for 2024 through 2025 was released and includes improved oversight and efficiency changes to the CDPAP program. The changes include the establishment of a single fiscal intermediary, thereby eliminating all other fiscal intermediaries of

the CDPAP program, which are currently administering the program throughout New York State. The new system was fully implemented on April 1, 2025.

As a result of these changes, the Company's workforce was significantly reduced in 2025. This reduction may impact the Plan, as participants who separate from the Company may elect to take distributions from their accounts. Management is monitoring the situation and will continue to assess the impact on the Plan's participant base and overall activity. The Plan will continue to operate in accordance with its provisions and applicable regulations.
