Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Arc3 Gases, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Arc3 Gases, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. DESCRIPTION OF PLAN

On December 31, 2014, the Arcet Equipment Company 401(k) Plan ("Arcet Plan") merged into the Machine & Welding Supply Company 401(k) Supplemental Retirement Plan (the "Plan"). All participants in the Arcet Equipment Company 401(k) Plan became participants of the Plan on January 1, 2015. Effective January 1, 2015, the Plan was renamed the Arc3 Gases, Inc. 401(k) Plan and the Plan Sponsor was changed to Arc3 Gases, Inc. with Machine & Welding Supply Company and Arcet Equipment Company named as related and participating employers. Effective June 15, 2015, as part of a branding campaign, Machine and Welding Supply Company, Inc. is now doing business as Arc3 Gases South and Arcet Equipment Company, Inc. is now doing business as Arc3 Gases North.

The following description of the Arc3 Gases, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- a. General - The Plan is a defined contribution plan established October 1, 1999. The Plan is designed to conform to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees of Arc3 Gases, Inc. who are 19 years of age and have completed 2 months of service are eligible to participate in the Plan. Part-time employees are excluded from participation in the Plan.
- b. Contributions - Upon employment, participants may contribute up to 99% of pre-tax and/or after-tax compensation for the plan year, as defined by the Plan. The Plan Participants may also contribute amounts representing distributions from other qualified plans. The Company contributes a safe harbor 100% match of the first 3% of eligible compensation plus 50% of the next 3% of eligible compensation deferred. The Plan document also provides for discretionary matching and profit sharing contributions. The Company did not make a discretionary match or profit sharing contribution for 2024.

The Plan contains an auto enrollment provision which automatically enrolls new participants at a 3% deferral rate that automatically increases 1% each succeeding plan year. Participants direct the investment of all contributions made on their behalf into various investment options offered by the Plan. Contributions are subject to annual limits established by the Internal Revenue Service.

Effective May 4, 2021, the Plan's safe harbor matching contribution was amended to allow for an additional "true-up" contribution. The safe harbor matching contribution will be recalculated based on the ratio of elective deferrals to compensation for the plan year, and true-up contributions will be made accordingly after year end. The true-up match for the plan year ended December 31, 2024 is \$38,897 and was contributed to the Plan on April 17, 2025. The true-up match for the plan year ended December 31, 2023 is \$33,186 and was contributed to the Plan on March 13, 2024. These amounts are recorded as an employer contributions receivable at December 31, 2024 and 2023, respectively.

Effective July 1, 2022, the Plan was amended to add an In-Plan ROTH conversion feature, allowing a portion of a participant's funds that are already in one or more tax-deferred accounts to be converted from a pre-tax basis to a ROTH tax basis.

1. DESCRIPTION OF PLAN (Continued)

- c. Participant Accounts - Each participant's account is credited with (1) the participant's contribution, (2) the employer contributions and (3) allocations of (a) Plan earnings, and (b) plan expenses. Allocations are based on participant's plan compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- d. Vesting – Prior to January 1, 2015, participant contributions and employer safe harbor contributions were automatically 100% vested plus actual earnings thereon. Effective January 1, 2015, vesting on safe harbor contributions and additional matching contributions are based on a 2-year cliff with a 1,000 required hours in each calendar year. Vesting of non-elective contributions and transition contributions funded through February 28, 2013 are vested 20% after 1 year of service with 20% incremental increases each year until 100% vested after five years of service

Participants will automatically become 100% vested upon attainment of normal retirement age, retirement due to disability, upon death or upon the termination of the Plan.

- e. Retirement - Normal retirement age is 65. Retirement is not mandatory.
- f. Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate as determined by the Plan Administrator as of the date of the loan issuance. Interest rates charged on the outstanding loans as of December 31, 2024 range from 4.25% to 9.50%. Loans must be repaid within 5 years unless the loan is for a principal residence, in which case the loan term can be up to 15 years. Principal and interest is paid ratably through biweekly or monthly payroll deductions.
- g. Payment of Benefits - Upon termination of employment, death, disability, retirement or plan termination, the participant or beneficiary may elect to receive either a lump sum or substantially equal installments equal to the vested portion of the value of the participant's account. In addition, during active service a participant can take a distribution of their participant contribution account balance upon reaching the age of 59 ½ or upon meeting certain conditions for a hardship distribution.
- h. Forfeited Accounts – Forfeitures of terminated participants' non-vested accounts are used to reduce employer retirement contributions and pay plan expenses. As of December 31, 2024 and 2023, there were \$1,444 and \$1,372 in forfeited non-vested accounts, respectively. In 2024, \$20,248 of forfeited funds were used to reduce employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by Reliance Trust Company, the Plan's trustee, and Investment Research & Advisory Group, Inc., the Plan's investment advisor. See Note 5 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes are reclassified as deemed distributions based upon the terms of the Plan document and loan agreement.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation or depreciation in fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

3. TRUSTEE AGREEMENT

The appointed trustee of the Plan's assets is Reliance Trust Company. The trustee has the authority and power to purchase and sell securities as directed by the Plan's participants. They also authorize benefit payments under the provisions of the Plan.

4. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Reliance Trust Company, the trustee of the Plan, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule.

5. FAIR VALUE MEASUREMENTS

The Plan follows FASB ASC 820, Fair Value Measurements, which defines fair value as the price that would be received from selling an asset in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

FASB ASC 820 also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The categorization of each investment type within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

FASB ASC 820 establishes three levels of inputs that may be used to measure fair value: Level 1: Quoted prices in active markets for identical assets or liabilities at the measurement date; Level 2: Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active market for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or Level 3: Unobservable inputs that are supported by little or no market activity and that reflect the Plan's own assumptions about market participants and prices.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There have been no changes in the fair value methodology used at December 31, 2024 and 2023.

6. PLAN TERMINATION

Although the Company intends to continue the Plan, it reserves the right to amend or terminate the Plan at any time. In the event of Plan termination, participants will become 100% vested in their account balances.

7. INCOME TAX STATUS

Effective July 1, 2019, the Company adopted ADP, LLC's Prototype Non-Standardized Profit Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on July 16, 2014 which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code. The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Fees paid to ADP, Inc. by the Plan totaled \$54,993 for the year ended December 31, 2024. ADP, Inc. serves as recordkeeper for the Plan, therefore, these transactions qualify as party-in-interest.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

10. CONCENTRATIONS

At December 31, 2024, approximately 20%, 17% and 10% of investments were held in the Vanguard Target Retirement 2030 Fund, Vanguard Target Retirement 2035 Fund, and Vanguard Target Retirement 2025 Fund, respectively.

At December 31, 2023, approximately 20%, 16% and 12% of investments were held in the Vanguard Target Retirement 2030 Fund, Vanguard Target Retirement 2035 Fund, and Vanguard Target Retirement 2025 Fund, respectively.
