There are no material commitments for the acquisition of financial instruments or other assets.
 23. We have no plans or intentions that may materially affect the carrying value or classification of assets and liabilities and have no knowledge of any matters affecting the Sponsor of the Plan that could be significant to the Plan.
 24. We have no intentions to terminate the Plan.
 25. We have complied with all aspects of contractual agreements, including employee benefits related contracts that would have a material effect on the financial statements in the event of noncompliance and have not breached our fiduciary responsibilities.
 26. There are no significant deficiencies, including material weaknesses, in the design or operation of internal controls that could adversely affect the ability of the Plan to record, process, summarize, and report financial data. There have been no significant changes in internal control since December 31, 2024.

27. We have obtained and reviewed the service auditor's SOC 1 reports and are performing the applicable user controls.
28. There are no estimates that may be subject to a material change in the near term that have not been properly disclosed in the financial statements. We understand that near term means the period within one year of the date of the financial statements. In addition, we have no knowledge of concentrations existing at the date of the financial statements that make the Plan vulnerable to risk of severe impact that have not been properly disclosed in the financial statements.
29. There are no conditions or events, considered in the aggregate, that raise substantial doubt about the ability of the Plan to continue as a going concern for at least one year after the date of this letter.
30. We have apprised you of all communications, whether written or oral, with regulatory agencies concerning the operation of the Plan. There have been no communications from regulatory agencies or government representatives concerning investigations or allegations of noncompliance with laws or regulations in any jurisdiction, or deficiencies in financial reporting practices, or other matters that could have a material effect on the financial statements.
31. We have no knowledge of any omissions from the participant data provided to the recordkeeper of the Plan for the purpose of determining the allocations to individual accounts used in the preparation of the financial statements.
32. All required amendments and filings of Airbus U.S. Florida 2, LLC 401(K) Plan documents with the appropriate agencies have been made.
33. Amendments to the instrument of the Plan, including amendments to comply with applicable laws, have been properly recorded or disclosed in the financial statements (if significant) or to the auditors.
34. We recognize that the audit procedures performed did not encompass all of the procedures necessary to determine the tax-qualified status of the Plan, nor the tax consequences of the Sponsor or participants of the Plan. However, we confirm to the best of our knowledge and belief that the Plan is qualified and the associated trust is tax exempt under the appropriate sections of the Internal Revenue Code and we intend to continue them as a qualified Plan and tax exempt trust. The Sponsor of the Plan has operated the Plan and trust in a manner that did not jeopardize this tax status.
35. Required nondiscrimination testing, including testing related to Code Section 401(k) and 401(m) arrangements, as applicable, has been completed for the Plan, and any excess contributions have been disposed of in accordance with regulations.
36. We have chosen to rely on the current Internal Revenue Service pre-approved plan opinion letter issued on behalf of the pre-approved plan, which we have adopted. We have determined, in accordance with IRS guidance, that we are eligible to rely on the pre-approved plan opinion letter and, therefore, have not applied for a determination letter on our adoption of the Plan. We understand that this letter does not cover some of the key requirements of the Internal Revenue Code covering tax qualified plans.
37. The Plan has complied with the fidelity bonding requirements of ERISA.

38. The Plan has complied with the DOL's regulations concerning the timely remittance of participant contributions and loan repayments, if applicable, to trusts containing assets for the Plan (other than as disclosed in the supplemental schedule).
39. We acknowledge our responsibility for presenting the required supplemental schedule in accordance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. We believe the form and content of the required supplemental schedule has been fairly presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
40. We are responsible for making the fair value measurements and disclosures included in the financial statements, including determining the fair value of investments for which a readily determinable fair value does not exist. As part of fulfilling this responsibility, we have established an accounting and financial reporting process for determining the fair value measurements and disclosures, selected appropriate valuation methods, identified and adequately supported any significant assumptions used, prepared the valuation, and ensured that the presentation and disclosure of the fair value measurements are in accordance with U.S. GAAP and ensured that the Form 5500 is reported at fair value. We believe the assumptions and methods used by us, including those used by specialists engaged by us, are appropriate in the circumstances and the resulting valuations and disclosures are reasonable. Our valuation methodologies have been consistently applied from period to period.
41. We are not aware of any potential uncertain tax positions that would, if necessary, meet the more likely than not threshold and require us to record a liability as of December 31, 2024.
42. As Sponsor and Administrator of the Plan, we are responsible for ensuring that all fee disclosure rules under Regulation Section 408(b)(2) of ERISA have been met.

We have obtained the required written agreement(s)/contract(s) and fee disclosures from covered service providers. We are also aware that we are responsible for determining that the fees paid by the Plan are reasonable and have taken action, or will take action, including plan fee/service benchmarking, to make that determination.


