## INDEPENDENT AUDITOR'S REPORT

To the Trustees of the  
J & L Ventures, LLC Retirement Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of J & L Ventures, LLC Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of J & L Ventures, LLC Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. **NOTE A -- DESCRIPTION OF THE PLAN**

---

The following description of the J & L Ventures, LLC Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution savings plan, established by J & L Ventures, LLC (Sponsor), for employees of participating employers, which includes Classic City Beverages, LLC, North Georgia Distributing Co., LLC, Better Brands of South Georgia, LLC, Macon Beverage Co., LLC, Beverage South, LLC, Jackson Beverages, LLC, and Beverage South of Aiken, LLC. An eligible employee is any person who has attained age twenty-one (21) and completed an initial 12-month period of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Trustees oversee governance of the Plan and determine the appropriateness of the Plan's investment offerings, monitor investment performance and report to the Plan Sponsor's Board of Directors.

Contributions: Each year, the employees who are eligible to participate in the Plan may elect to defer from 1% to 80% of their compensation, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various multi-national investment options, at their own discretion. The Plan currently offers various mutual funds and an insurance investment contract as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 2% of eligible compensation. Contributions are automatically invested in a designated balanced fund until changed by the participant. The Sponsor makes a matching contribution equal to 50% of the participants' deferral, up to a maximum of 6% of the participant's compensation (maximum 3% match). The Sponsor may also elect to make a discretionary profit-sharing contribution on the employees' behalf. Sponsor matching contributions and discretionary contributions are invested based on the participant's elections. Contributions are subject to statutory limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Company's discretionary profit-sharing contribution, (b) the Company's matching contributions and, (c) Plan earnings (losses). Allocations are based upon participant compensation or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting on Termination of Employment: Participants are immediately vested in their contributions, plus actual earnings thereon. Participants are entitled to receive vested benefits from employer match contributions and employer discretionary profit-sharing contributions and related actual earnings in accordance with the schedule below:

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the vested balance in the participant's account and bear interest ranging from 4.25% to 9.50%. Principal and interest is paid ratably through weekly payroll deductions.

Payment of Benefits: On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. For termination of service for other reasons, the full value of the participant's vested account shall be payable if the participant consents or his account is \$7,000 or less. If the participant fails to consent to the distribution of his account and his account exceeds \$7,000, he shall receive a lump-sum payment of his account at normal retirement age (age 65). The Plan also permits in-service and hardship withdrawals under certain circumstances.

Forfeited Amounts: The forfeited amounts may be used to reduce future employer contributions or to pay administrative expenses of the Plan. In 2024 and 2023, administrative expenses were reduced by \$25,770 and \$15,232, respectively, from forfeited non-vested accounts.

---

### NOTE B -- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

---

Date of Management's Review: The Plan has evaluated subsequent events through the date of the auditor's report which is the date when the audited financial statements were available to be issued.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts (See Note I) because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's accounts. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Delinquent participant loans are recorded as a benefit payment based on the terms of the Plan document.

Investments Valuation and Income Recognition: Investments are reported at fair value, except for fully benefit-responsive contracts which are reported at contract value (See Note I). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as those held during the year.

Payment of Benefits: Benefits are recorded when paid.

Operating Expenses: Trustee fees and administrative expenses of maintaining the Plan are paid from Plan assets. The costs associated with the audit of the Plan's financial statements are paid by the Sponsor.

---

### NOTE C -- FAIR VALUE MEASUREMENTS

---

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs are defined as assets for which inputs other than quoted market prices included within Level 1 are observable, either directly or indirectly, and are used for input, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available, and Level 3 inputs are only used when Level 1 or Level 2 inputs are not available. There are no plan assets requiring the use of Level 2 or level 3 inputs for the periods presented.

#### *Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

ERISA. Upon termination of the Plan, the participants shall become fully vested in and receive the full value of their accounts after the payment of Plan expenses.

---

### **NOTE G -- TAX STATUS**

---

The Internal Revenue Service determined and informed the Company by a letter that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the third-party administrator believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. No tax liabilities for uncertain positions have been recorded in the accompanying Statements of Net Assets Available for Benefits.

The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

---

### **NOTE H -- RISKS AND UNCERTAINTIES**

---

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.

---

### **NOTE I -- FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

---

The Plan has invested in a collective trust that invested in a fully benefit-responsive guaranteed investment contract (GIC) with The MetLife Insurance Company ("MetLife"). In the MetLife Managed GIC, the assets are invested in a MetLife separate account. MetLife guarantees the contract value which represents contributions, plus interest, less participant initiated withdrawals or transfers. Interest is credited to the contract at fixed interest rates for a fixed period of time that will apply to the entire guaranteed value.

Because the GIC meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIC. The guaranteed investment contract is presented

on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by MetLife, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$1,111,899 and \$1,499,713, respectively. The crediting interest rate is reset every quarter as determined by MetLife with consideration of the fair value of the separate accounts, the anticipated market yields to maturity of benchmark indices of separate accounts, expected payments into and out of the contract, amortization of the difference between the fair value of the separate accounts and the guaranteed value of the contract and the fees allowed under the contract.

Participant directed withdrawals are paid at the guaranteed value. These events include transfers to other Plan investment options and payments because of retirement, termination of employment, disability and death and in-service withdrawals as permitted by the Plan.

Certain events limit the Plan's ability to transact at contract value with MetLife. Such events include the following: (a) participant withdrawals based on advice or direction from the plan sponsor, administrator or other agent of the foregoing, (b) changes to the Plan's prohibition on competing investments, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) any plan withdrawal other than a participant-directed withdrawal. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value.

Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting purposes.
