Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Custom Decorators, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certification from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Custom Decorators, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document and summary plan description for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all full-time employees, other than employees covered by a collective bargaining agreement, of Custom Decorators, Inc. (the Company), who have completed two months of service and attained the age of 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each participant may elect to contribute up to 90% of his or her compensation as defined by the Plan, not to exceed the maximum annual limits of \$23,000 and \$22,500 in 2024 and 2023, respectively, as prescribed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions limited to \$7,500 annually. Participants may also contribute amounts representing distributions from other qualified plans (i.e., rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company contributes safe harbor matching contributions to the account of each eligible participant who has made elective deferrals. The Company contributes 100% of the first 3%, and 50% of the next 2% of the participant's eligible compensation that the participant contributes to the Plan.

The Plan also provides for employer discretionary contributions, which are allocated to eligible participants based on an integrated allocation formula defined in the Plan document. There were no employer discretionary contributions made for 2024 and 2023. Employee elective deferrals and company contributions are recorded in the year in which the employee contributions are withheld from compensation. Contributions are subject to certain limitations as prescribed by the IRC.

Participant Accounts - A separate account is maintained for each participant which is credited with the participant's contributions and Company matching contributions, as well as allocations of Company discretionary contributions and net Plan earnings. Allocations of Plan earnings are based on participant account balances. The benefit to which a participant is entitled is the vested amount in the participant's account.

Vesting - Participants are immediately vested in all contributions and earnings thereon.

Payment of Benefits - Upon reaching retirement age, termination of service or death, a participant or their beneficiary may be paid a lump sum amount equal to the participant's vested account value. Participants may also elect to keep their account in the Plan until a future date. The Plan further provides for in-service distributions upon attaining the age of 59 ½, and hardship distributions. Hardship distributions are available only for the purpose of meeting immediate and heavy financial need. Account balances of terminated participants that are under \$1,000 may be automatically paid out at the discretion of the Company. Balances of terminated participants between \$1,000 and \$7,000 may be transferred to an IRA, also at the discretion of the Company.

Forfeited Accounts - The Plan has a balance of excess employer contributions due to payroll corrections. These excess funds are used to reduce future employer matching contributions or pay plan expenses. Unallocated excess employer funds amounted to \$10 and \$11, as of December 31, 2024 and 2023, respectively. There were no excess employer contributions used to reduce employer contributions for the years ended December 31, 2024 and 2023.

Administrative Expenses - Administrative expenses may be paid by the Company. Expenses not paid by the Company are deducted from investment earnings before allocation to participants' accounts. Expenses of loan administration, distributions and transfers are allocated solely to that participant's account. In addition, certain expenses of plan administration, including computer services, professional fees, office supplies and payroll expenses of administrative and clerical personnel are provided by the Company without charge to the Plan.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments - Benefits are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but are not yet paid at year-end have not been accrued. At December 31, 2024 and 2023, there were no amounts payable to participants.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events - The Plan's management has performed an evaluation of subsequent events through October 6, 2025, which is the date these financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENT

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Basis of Fair Value Measurement

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. Loans must be repaid within five years, unless the loan proceeds are used to acquire the participant's principal residence, in which case longer terms may be permitted. The loans are secured by the balance in the participant's account and bear a reasonable interest rate determined by the plan administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The loans outstanding at December 31, 2024 have interest rates ranging from 4.25% to 9.50% and maturity dates through August 2053. Principal and interest is paid ratably through payroll deductions.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Upon termination, the Company may continue the Plan to pay benefits as they mature or liquidate and distribute the relevant portion of the Plan to a successor defined contribution plan, or in the absence of a successor plan, to the participants. Net assets transferred or distributed shall be allocated to participants in proportion to their interests.

NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The recordkeeper, ADP, Inc. (ADP) provides certain administrative services to the Plan pursuant to an agreement between the Company and ADP. Fees for services provided by ADP were \$5,667 and \$2,533 for the years ended December 31, 2024 and 2023, respectively.

NOTE 8 – CONCENTRATIONS, RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near-term and that such change could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. There were two investments that individually represented more than 10% of the investments held as of December 31, 2024 and 2023. See the Supplemental Schedule of Assets (Held at End of Year) for the complete listing of investments held as of that date.

NOTE 9 – INCOME TAX STATUS

The Plan document, a non-standardized defined contribution pre-approved plan sponsored by ADP, LLC, obtained an opinion letter dated October 6, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition or a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, generally for a period of three years from the date of filing.
