### NOTE A - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES AND GENERAL DESCRIPTION OF THE PLAN

#### **General Description of the Plan**

The following description of the Daily Dove Care Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering substantially all employees of the Daily Dove Care (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The effective date of plan operations was January 1, 2024. The plan had an administrative blackout period until March 1, 2024. As such, there is no comparative information to be presented in the financial statements.

**Participation** - Employees aged 18 years or older become automatically enrolled as a participant of the Plan. Entrance into the Plan occurs on the first day of the month coinciding with or following the date that eligibility requirements are met.

**Auto-enrollment and Auto-escalation** - All eligible employees will be automatically enrolled into the plan with a default deferral rate of 3% unless otherwise elected at the participant's discretion. On the anniversary of the implementation of the participant's automatic deferrals, their deferral rate will be automatically escalated by 1%, continuing to escalate each year up to a maximum of 10% unless otherwise directed by the participant.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and an allocation of Plan earnings. Participants have access to their accounts 24 hours a day/7 days per week via a toll-free telephone number and a website. Fund transfers and investment election changes may be elected daily. A participant may stop, start, or change their 401(k) salary deferral rate at will.

**Contributions** - Participants are able to contribute up to the lesser of IRS deferral limits or 90% of their annual compensation. In addition, participants who reach age 50 or older and contribute the maximum permitted under the Plan may make an additional pre-tax or Roth contribution (a "catch-up contribution") for the year ended December 31, 2024. Participants direct the investment of the contributions into various investment options offered by the Plan. All eligible participants, upon commencement of employment, are provided the option of making a rollover contribution into the Plan in accordance with Internal Revenue Service (IRS) regulations and Plan provisions.

The Plan does not allow for employer contributions to be made to participants.

**Vesting** - Participants are always 100% vested in their own 401(k) salary deferral contributions and rollover contributions.

**Payment of Benefits** - Upon termination of service due to death, disability, or retirement, a participant or their beneficiary may elect to receive either an amount equal to the value of the participant's account. For termination of service due to other reasons, a participant may receive the value of their account balance as a lump-sum distribution. In the event of a "financial hardship," an active employee may elect a withdrawal from their elective deferral contributions.

**Participant Loans Receivable** - Active employees may elect to take loans from the Plan at any given time. As required by law, a loan amount is limited to the lesser of \$50,000 or 50% of the participant's vested account and must be repaid within five years unless the loan is for the purchase of a primary residence. The loans are secured by the balance in the participants account and bear interest at the prime rate plus 1%, which is commensurate with local prevailing rates as determined by the Plan Administrator at the time the loans are made. Principal and interest are repaid through payroll deductions.

**Plan Termination** - Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, the net assets of the Plan will be distributed to the participants in an order of priority determined in accordance with ERISA and its applicable regulations and the Plan document.

**Administrative Expenses** - Administrative expenses, such as auditing, legal fees and investment advisory services incurred in the operation of the Plan are paid out of the Plan's ERISA budget account. The ERISA budget account was established as a result of a negotiated arrangement between the Plan Sponsor and Administrative Service Provider for purposes of allocating some or all of the service fees that the Administrative Service Provider receives from the Plan's investments for the payment of Plan expenses. These Plan expenses are reflected in the accompanying statement of changes in net assets available for plan benefits for the years ended December 31, 2024, respectively. Administrative expenses in excess of the ERISA budget account are paid by the Company.

**Administration of the Plan** - The Plan is administered by the Director/President and the HR Supervisor.

#### **Significant Accounting Policies**

The significant accounting policies of the Plan employed in the preparation of the accompanying financial statements follow.

**Basis of Accounting** - The financial statements are prepared on a modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles

**Investments** - Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offer's several registered investment companies mutual funds with various investment strategies.

**Valuation of Investments** - The Plan's investments are stated at fair value, pursuant to the provisions of Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) No. 820, Fair Value Measurements and Disclosures. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued daily at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. See Note D for discussion of fair value measurements.

**Valuation of Investments** - The Plan's investments are stated at fair value, pursuant to the provisions of Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) No. 820, Fair Value Measurements and Disclosures. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued daily at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. See Note D for discussion of fair value measurements.

**Participant Loans Receivable** - All transactions are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant were to default, the participant's account balance would be offset by the unpaid balance of the loan, and the participant would be subject to tax on the unpaid loan balance. As such, the participant is the only party affected in the event of a default.

**Payment of Benefits** - Benefits are recorded when paid.

**Investment Income Recognition** - Purchases and sales of investments are recorded based on the trade date. Interest and dividend income is recorded when received. Capital gain distributions are included in dividend income. Realized gains or losses on security transactions are determined using the average cost of securities sold on the trade date. Expenses are recorded as paid.

**Use of Estimates** - The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Plan Expenses** - Certain administrative expenses of the Plan are paid by Daily Dove Care (the "Company"). Investment and recordkeeping expenses are paid by the Plan and/or the participants to the extent that such expenses are not paid by the Company. Any investment expenses associated with the Plan's investments are netted with earnings (losses) by Reliance Trust Company, the Plan's trustee, in December 31, 2024, and are reported to the Plan as a net amount. Loan and distribution administration fees paid by participants and are reflected in the Plan's statements of changes in net assets available for benefits--modified cash basis.

**Date of Management's Review** - Management has evaluated subsequent events through September 29, 2025, the date which the financial statements were available to be issued.

### NOTE B - TAX STATUS OF THE PLAN

The Plan participates in a non-standardized pre-approved profit sharing and money purchase plan with CODA sponsored by ADP, LLC. On October 6, 2020, ADP, LLC received a favorable opinion letter from the Internal Revenue Service (IRS), indicating that the Plan is a qualified plan under Section 401(k) of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan believes it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are material to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan has identified certain operational errors and is in the process of correcting these errors.

### NOTE C - PARTY IN INTEREST TRANSACTIONS

The Plan issues loans to participants, which are secured by the balances in the participants' accounts. These transactions qualify as allowable party in interest transactions under ERISA guidelines.

### NOTE D - FAIR VALUE MEASUREMENTS

FASB ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Assets of the Plan for which fair values are determined on a recurring basis are summarized as follows:

Under that section, no auditing procedures are required to be performed with respect to the investment information certified by the trustee of the Plan, Reliance Trust Company in December 31, 2024, other than comparing such information to that contained in the financial statements and supplemental schedule.
