Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the J & J Exterminating Co., Inc. 401(k) P/S Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

Note 1 - Description of Plan -

Description of Plan

The following description of J & J Exterminating Co., Inc. 401(k) P/S Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of J & J Exterminating of New Orleans, J & J Exterminating of Deridder, J & J Exterminating of Crowley, J & J Exterminating of Shreveport, J & J Exterminating of Lake Charles, J & J Exterminating of Alexandria, J & J Exterminating of Texas, John PR Services, LLC and J & J Marine Pest Solutions, LLC (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Management oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Qualified employees of the Company who have attained the age of 21 are immediately eligible to contribute to the Plan and are automatically enrolled at 4% unless the participant makes an affirmative election. In addition, upon eligibility, the participant is eligible to participate in the match.

Contributions

Participants may contribute a portion of their eligible compensation as defined in the Plan up to the maximum amount allowed by Section 401(k) of the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also rollover amounts representing distributions from other qualified defined benefit or contribution plans.

The Company has elected to make discretionary matching contributions totaling 50% of the first 4% of the amount of employee elective deferrals, not to exceed 2% of a participant's salary. For the year ended December 31, 2024, the Company made discretionary matching contributions of \$235,260.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's discretionary matching contributions, the Plan's investment earnings or losses, and certain plan administration costs not covered by the Company. Allocations are based upon participant account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and the actual earnings thereon. Vesting in the Company's discretionary matching contributions is based on years of continuous service with a participant being 20% vested after two years of credited service and 100% vested after six years of credited service. Participants will become fully vested in the Company's discretionary matching contributions and earnings upon death, disability, or normal retirement.

Payment of Benefits

Upon termination of service, a participant or their designated beneficiary may elect to receive a distribution equal to the vested interest in the account. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$29,007 and \$5,169, respectively. Forfeitures may be used to pay administrative expenses, to reduce Company contributions, or may be reallocated to eligible participant accounts. During 2024, forfeited nonvested accounts of \$-0- were used or reallocated.

Note 2 - Summary of Accounting Policies -

Basis of Accounting

The financial statements of the Plan are prepared in accordance with the accrual basis of accounting. At December 31, 2024 and 2023, all assets of the Plan are participant directed.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan. As of December 31, 2024 and 2023, the Plan had no fully benefit-responsive investment contracts.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates, and such differences may be material.

Contributions

Contributions from Plan participants and employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the Plan custodians. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Net investment income includes the Plan's gains and losses on investments sold during the year as well as appreciation and depreciation of the investments held at the end of the year. Benefits are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options in any combination of selected funds held by the custodians. These funds are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with these funds, it is at least reasonably possible that changes in the values of the funds will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

Administrative Expenses

Certain expenses of maintaining the Plan may be paid directly by the Company and are excluded from these financial statements. Fees for certain transactions, such as withdrawals, are charged directly to the account of the participant reporting such a transaction. Investment related expenses are included in net investment income.

Subsequent Events

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through September 29, 2025, the date which the financial statements were available to be issued.

Note 3 - Plan Termination -

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 4 - Tax Status -

The Company has adopted a prototype plan which received a favorable determination from the Internal Revenue Service. The Plan itself has not separately applied for recognition of tax-exempt status. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 5 - Fair Value Measurements -

The fair value measurement accounting literature provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. Level 1 inputs to the valuation methodology are based on unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Level 2 inputs are based primarily on quoted prices for similar assets in active or inactive markets and/or based on inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 inputs are unobservable and are based on assumptions market participants would utilize in pricing the asset.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. When available, valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Interest-Bearing Cash (Money Market): The fair values of these funds are based on preserving the net asset value of \$1.00 per share based on the underlying assets invested in treasury securities, when applicable.

Registered Investment Companies (Mutual Funds): These securities are valued using a net asset value that is not the same as the net asset value reported by the fund house. Rather, after close of the stock market, the daily price is received from each house and adjusted for any dividends and capital gains declared. A gross investment rate is calculated to compute the unit value.

Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7 - Related Party and Party-in-Interest Transactions -

As of and for the year ended December 31, 2024 and for the period September 15, 2023 to December 31, 2023, certain plan investments were held and managed by Ascensus Trust Company and Newport Trust Company, LLC (Ascensus). Since Ascensus was the Plan custodian, these transactions qualify as party-in-interest transactions. For the period January 1, 2023 to September 14, 2023, certain plan investment transactions were held and managed by PAi Trust Company, Inc. (PAi). Since PAi was the Plan custodian, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net investment income, as they are paid through revenue sharing, rather than a direct payment. The Company, a related party, may also directly pay other fees related to the Plan's operations. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 8 - Prohibited Transactions - Late Deposits -

The Plan was selected for a periodic review by the United States Department of Labor (DOL) covering the period from January 2012 through February 2015. The review disclosed that the Company did not routinely remit withheld employee contributions to the Plan on the earliest date on which such contributions or repayments can reasonably be segregated from the employer's general assets. In the Company's response to the DOL's findings, the Company requested that 5 days would be a reasonable timeframe for the Company to consistently remit employee contributions to the Plan. The DOL accepted this request.

During the year ended December 31, 2024, the Plan Sponsor failed to deposit \$10,333 of participant contributions within the DOL agreed-upon timeframe of five business days. The DOL considers late deposits to be prohibited transactions. The Plan Sponsor will deposit lost earnings to the affected participants' accounts to compensate those participants for potential lost income due to the delays.

During the year ended December 31, 2023, the Plan Sponsor failed to deposit \$22,390 of participant contributions within the DOL agreed-upon timeframe of five business days. The DOL considers late deposits to be prohibited transactions. In January 2025, the Plan Sponsor deposited lost earnings to the affected participants' accounts to compensate those participants for potential lost income due to the delays.
