## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
Warabeya USA, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

**NOTE A - DESCRIPTION OF PLAN**

The following description of the Warabeya USA, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- (1) **General** - The Plan is a defined contribution plan covering all employees of Warabeya USA, Inc. (Company). The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA). Employees become eligible upon completion of one year of service, have worked one thousand hours or more during the year, and are at least eighteen years of age.
- (2) **Contributions** - Each year, participants may contribute up to 80% of pretax annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company may make discretionary matching and nonelective contributions to all eligible employees, as defined by the Plan. The Company did not make any discretionary matching or nonelective contributions for the years ended December 31, 2024 and 2023.

- (3) **Participant accounts** - Each participant's account is credited with the participant's contribution, the Company's contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- (4) **Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon and rollover contribution accounts. Vesting in the Company's contribution portion of their accounts is based on years of service. A participant's balance vests at 20% each year after two years of service and is 100% vested at six years of service or in the event of death or disability.

- (5) **Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. The loans are secured by the balance in the participant's account. The interest rate is the prime rate, as defined, plus two percentage points. Principal and interest is paid ratably through payroll deductions.
- (6) **Payment of benefits** - Termination of service due to death, permanent disability, retirement, or other termination of employment with the Company, the participant is entitled to a lump-sum distribution, periodic installments over a fixed period, or partial withdrawals. In addition, hardship distributions are permitted if certain criteria are met.
- (7) **Forfeited accounts** - As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$145 and \$139, respectively. These accounts will be used to pay plan expenses with any remaining amounts to reduce future Company contributions. No forfeitures were used by the Plan during the years ended December 31, 2024 and 2023.
- (8) **Plan termination** - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in Company contributions.

**NOTE B - SIGNIFICANT ACCOUNTING POLICIES**

- (1) **Basis of accounting** - The financial statements of the Plan have been prepared on the accrual basis of accounting consistent with accounting principles generally accepted in the United States of America (U.S. GAAP).
- (2) **Use of estimates** - The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- (3) **Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

- (4) **Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.
- (5) **Excess contributions payable** - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.
- (6) **Payment of benefits** - Benefits are recorded when paid.
- (7) **Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.
- (8) **Subsequent events** - Plan management has evaluated subsequent events through October 6, 2025, the date on which the financial statements were available to be issued. There were no subsequent events that required adjustment of or disclosure in the financial statements.

**NOTE C - CERTIFIED INVESTMENT INFORMATION**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

**NOTE D - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust funds:* Common collective trust funds that are comprised primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective, the issuer reserves the right to 12 months' notification in order to ensure that securities liquidations are carried out in an orderly business manner.

**NOTE E - RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

ADP Retirement Services is the recordkeeper of the Plan, and therefore, these transactions qualify as party in interest transactions. Administrative fees paid to ADP Retirement Services were \$2,107 and \$2,422 for the years ended December 31, 2024 and 2023, respectively.

**NOTE F - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**NOTE G - TAX STATUS**

Effective May 1 2022, the Plan adopted an Automatic Data Processing (ADP) Non-Standardized Defined Contribution Pre-Approved Plan. ADP received an opinion letter from the Internal Revenue Service dated October 6, 2020, specifying the form of the Adoption Agreement and the basic plan document satisfied, as of the date of the opinion letter, IRC Section 401. The Plan has not received a determination letter specific to the Plan itself, however, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and that the related trust is tax-exempt.
