Note 1 - Plan Description

The following description of Moeller Manufacturing Company Aircraft Union 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan, established on January 1, 1995, is a deferred savings plan covering substantially all Aircraft Division union employees of Moeller Mfg. Company LLC (the "Plan Sponsor" or the "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make annual contributions to the Plan on a pretax basis up to the maximum percentage of compensation and dollar amount permissible under Internal Revenue Code Section 401(k). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer nonelective contributions. There was an employer nonelective contribution made of \$0.30 per hour worked by each participant totaling \$29,759 for the year ended December 31, 2024. In addition, there was an employer matching contribution of \$0.25 per dollar each participant contributed to the Plan, not to exceed 1.5 percent of eligible compensation. The total employer matching contributions totaled \$53,467 for the year ended December 31, 2024. The combined employer contributions totaled \$83,226.

Additionally, the Employer may make discretionary matching or profit-sharing contributions to the Plan, as determined by a resolution of the board of directors. There were no discretionary contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Employer's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Benefit Payments

Upon attainment of normal retirement age (59½) or other separation of employment due to death, disability, or other reasons, a participant may elect to receive his or her benefits as either a lump-sum payment or as a direct transfer to another qualified retirement plan or individual retirement account.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. A participant is one-third vested as to employer contributions and earnings thereon after completing two years of service. A participant is two-thirds vested after three years of service and fully vested after four years of service.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Note 1 - Plan Description (Continued)

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited.

Forfeitures, if any, are first applied to restore a participant's previous forfeitures and then to reduce employer contributions.

Termination

While it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances, and disbursements of participants' accounts would be made as of the date of termination in a manner determined by the plan administrator. Furthermore, trustee fees and other operating expenses incurred after the termination date may be paid by the Plan.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company or its affiliates (Principal Trust). Principal Trust is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Administrative Expenses

Various administrative costs are paid by the Plan Sponsor.

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 25, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Principal Trust.

Note 4 - Tax Status

The Plan is a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 5 - Fair Value Measurements (Continued)

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Common/Collective Trust Funds

The common/collective trust funds are valued at net asset value per share (NAV) or its equivalent of the funds, which is based on the fair value of the funds' underlying net assets.

Pooled Separate Accounts

The pooled separate accounts are valued at NAV per share (NAV) or its equivalent of the funds, which is based on the fair value of the fund's underlying net assets.

The Principal Stable Value Fund is a stable value common/collective trust fund. This investment, at the participant level, requires a 90-day equity wash on all participant-directed transfers to competing investments. The requirement means that participant-directed transfers to competing investment options must be held in a noncompeting investment option for a minimum of 90 days before a transfer to a competing option may occur. Generally, competing investment options include: (i) a cash account or money market fund; (ii) a fixed-income fund, the assets of which have a target duration of less than two years; (iii) a guaranteed rate of return; or (iv) the principal amount, which is guaranteed to plan participants.

There were no additional unfunded commitments or redemption restrictions on the investments described above.

Note 6 - Transfers from Related Plans

During the normal course of business, employees transfer between divisions and subsidiaries of Moeller Mfg. Company LLC. As a result, employees may become eligible under different Moeller Mfg. Company LLC defined contribution plans; the related net assets are then transferred to the other plan.
