Note 1 - Plan Description

The following description of Moeller Enterprises 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan, established on January 1, 1995, is a deferred savings plan covering substantially all nonunion employees of Moeller Mfg. Company LLC and Moeller Aerospace Technology (collectively, the "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make annual contributions to the Plan on a pretax basis up to the maximum percentage of compensation and dollar amount permissible under Internal Revenue Code Section 401(k). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain participant notes receivable withholdings in 2023 were remitted after the time frame required by the Department of Labor. The Employer remitted these withholdings during 2023 and remitted related lost earnings to the Plan on August 29, 2024.

The Plan includes a basic matching contribution equal to 100 percent of each participant's elective deferral, not to exceed 3 percent of the participant's compensation, plus 50 percent of each participant's elective deferral in excess of 3 percent, not to exceed 5 percent of the participant's compensation.

The Employer may make discretionary matching or profit-sharing contributions, as determined by a resolution of the board of directors. There were no discretionary matching or profit-sharing contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of the Employer's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in employee salary, rollover contributions, employer basic matching contributions, and any income or loss thereon. Participants are vested in employer discretionary matching and profit-sharing contributions according to the following table contained in the plan agreement and become 100 percent vested after six years of continuous service.

**Note 1 - Plan Description (Continued)**

***Benefit Payments***

Upon attainment of normal retirement age (59½) or other separation of employment, a participant may elect to receive benefits as either a lump-sum payment or as a direct transfer to another qualified retirement plan or individual retirement account.

Participants may request that all or a portion of their vested accounts be distributed in the case of financial hardship, as defined in the plan document.

***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures, if any, are first used to pay administrative expenses and then to reduce employer contributions. Any remaining forfeitures, if any, are then allocated to participants based on participants' compensation, as defined. Allocations of forfeitures are considered additional employer contributions and are subject to the vesting provisions of employer contributions.

***Termination***

While it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances, and disbursements would be made as of the date of termination in a manner determined by the plan administrator. At the discretion of the Employer, trustee fees and other operating expenses incurred after the termination date may be payable by the Plan.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company or its affiliates (Principal Trust). Principal Trust is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Administrative Expenses***

Various administrative costs are paid by the Employer.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 25, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Principal Trust.

**Note 4 - Tax Status**

The Plan has adopted a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Note 5 - Fair Value Measurements (Continued)**

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

**Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets.

**Common/Collective Trust Funds**

The common/collective trust funds are valued at net asset value per share (NAV) or its equivalent of the funds, which is based on the fair value of the funds' underlying net assets.

**Pooled Separate Accounts**

The pooled separate accounts are valued at NAV per share or its equivalent of the funds, which is based on the fair value of the funds' net underlying assets.

**Note 5 - Fair Value Measurements (Continued)**

The Principal Stable Value Z Fund is a stable value common/collective trust fund. This investment, at the participant level, requires a 90-day equity wash on all participant-directed transfers to competing investments. This requirement means that participant-directed transfers to competing investment options must be held in a noncompeting investment option for a minimum of 90 days before a transfer to a competing option may occur. Generally, competing investment options include: (i) a cash account or money market fund; (ii) a fixed-income fund, the assets of which have a target duration of less than two years; (iii) a guaranteed rate of return; or (iv) the principal amount, which is guaranteed to plan participants.

There were no additional unfunded commitments or redemption restrictions on the investments described above.

**Note 6 - Transfers from Related Plans**

During the normal course of business, employees transfer between divisions of Moeller Mfg. Company LLC and Moeller Aerospace Technology. As a result, employees may become eligible under different Moeller Mfg. Company LLC and Moeller Aerospace Technology defined contribution plans; the related net assets are then transferred to the other plan.
