**A. Description of the Plan**

The following description of the Denbury Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. On July 13, 2023, the Company entered into a definitive merger agreement (“Merger Agreement”) with Exxon Mobil Corporation (“ExxonMobil”), providing for the Company to merge with a wholly owned subsidiary of ExxonMobil and survive as a wholly owned subsidiary of ExxonMobil. Upon the terms and subject to the conditions set forth in the Merger Agreement, on November 2, 2023 (the closing date of the Merger, as defined below), Denbury merged with and into ExxonMobil (the “Merger”), with the Company surviving the Merger as a wholly-owned subsidiary of ExxonMobil. The Company remains an ExxonMobil wholly-owned subsidiary as of December 31, 2024. The Plan is sponsored and administered by Denbury Inc. (the “Company”, “Plan Sponsor” or “Plan Administrator”). Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Company’s corporate offices are located at 5851 Legacy Circle, Suite 1200, Plano, Texas 75024.

**General** – The Plan, which was originally established effective March 1, 1995, and subsequently amended and restated from time to time, is a defined contribution pension plan generally covering all employees of the Company and certain subsidiaries who are age 18 or older. The Plan Sponsor and certain designated officers of the Plan Sponsor control and manage the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Effective January 1, 2003, the Plan adopted a safe harbor design and has continued to operate as a safe harbor plan since that time. The Plan was amended to update the Plan sponsor and administrator from Denbury Resources Inc. to Denbury Inc., effective September 18, 2020.

**Contributions** – Participants may contribute up to 75% of pretax and/or after-tax Roth contributions from annual compensation, as defined in the Plan, subject to statutory limitations. The Company’s safe harbor matching contribution per participant was up to 100% for the first 6% of eligible compensation for the years ended December 31, 2024 and 2023. There was no discretionary employer match made by the Company to the Plan during 2024 or 2023.

**Participant Accounts** – A separate account is maintained for each participant and is credited with the participant’s contributions, the Company’s contributions, and actual earnings or losses thereon.

**Vesting** – Plan participants are immediately vested in all employee and employer contributions plus actual earnings or losses thereon; as such, there are no forfeiture amounts in the ordinary course of Plan administration.

**Investment Options** – Upon enrollment in the Plan, a participant may direct employer and employee contributions into a variety of investment options, which vary in degree of risk. Participants may change their investment options daily.

***Notes Receivable from Participants*** – Participants are allowed to borrow from their accounts. Loans must have a minimum balance of \$1,000 and cannot exceed the lesser of 50% of the participant’s vested balance or \$50,000. Loans must be repaid through payroll deductions within five years unless the funds are used for the purchase of a primary residence, in which case the term may be extended.

***Payment of Benefits*** – Upon termination of service due to death, disability, retirement, or termination of employment, a participant or designated beneficiary is entitled to receive the value of the participant’s vested interest in his or her account as defined by the Plan. Payment shall be made as soon as administratively feasible following the participant’s actual retirement following his normal retirement date, disability, termination of employment, or death, as the case may be. Certain in-service withdrawals are allowed. A participant may also elect to withdraw all or a portion of their vested balance while employed after reaching age 59½. A participant may receive a hardship distribution of his or her salary reduction contributions if the distribution is: (1) due to medical expenses incurred by the participant, his or her spouse or dependents; (2) to purchase (excluding mortgage payments) a principal residence of the participant; (3) for the payment of post-secondary tuition expenses; (4) needed to prevent eviction of the participant from his or her principal residence or foreclosure upon the mortgage of the participant’s principal residence; (5) for the payment of burial or funeral expenses for the participant’s parent, spouse, children or dependents; or (6) to repair damage to a participant’s principal residence that would qualify for the casualty deduction under the Internal Revenue Code.

Payment of benefits to participants with balances less than \$5,000 may be made in a lump-sum distribution or in certain circumstances to an individual retirement rollover account.

***Plan Expenses*** – Employees of the Company perform certain administrative functions with no compensation from the Plan. Plan expenses paid by the participant (e.g., in the case of a participant’s loan or rollover) are described in the Plan document, summaries and corresponding forms and agreements.

***Expense Offset Arrangements*** – Fees incurred by the Plan for the investment management services and recordkeeping are paid through revenue sharing, rather than a direct payment, presented net in benefits paid to participants.

**B. Summary of Significant Accounting Policies**

***Basis of Accounting*** – The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”). Benefit payments are recorded when paid.

***Use of Estimates*** – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

***Investment Valuation and Income Recognition*** – Investments held by the plan are stated at fair value, which is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date (see Note E). Investment gains and losses are accounted for using the average cost basis of the securities sold.

The Plan’s investments are subject to market or credit risks customarily associated with equity investments. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

The net realized and unrealized gains and losses on investments include realized gains and losses on sales of investments during the year and unrealized increases or decreases in the market value of investments held at year end. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

***Notes Receivable from Participants*** – Participant loans transferred to the ExxonMobil Savings Plan (EMSP) were valued at amortized cost.

***Contributions*** – Contributions from the participants are accrued in the period in which they are deducted in accordance with salary deferral agreements and obligations of the Company as determined by the Company.

**C. Tax Status**

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan was amended and restated effective as of January 1, 2022, and executed on June 11, 2022, to comply with legislative and regulatory changes set forth in accordance with IRS Notice 2017-37, which resulted in no material changes to the Plan.

The Plan Sponsor updated the Merrill Lynch, Pierce, Fenner & Smith Inc., defined contribution pre-approved plan with a favorable opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the written form of the prototype plan is acceptable under Section 401(a) of the Internal Revenue Code (the “Code”) and that any employer adopting this prototype plan document will be able to rely on the letter with respect to whether the Plan is qualified in form under Section 401(a) of the Code to the extent provided by IRS guidance.

The Plan Sponsor believes that the Plan is currently designed and being operated in material compliance with the applicable requirements of the Code and, except for any failures which have been, or will be,

corrected in all material respects in accordance with Revenue Procedure 2021-30, to restore the qualified status of the Plan, and believes the Plan was qualified and the related trust was tax exempt as of December 31, 2024 and 2023.

**D. Parties-In-Interest**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

Merrill Lynch is the Plan record keeper as defined by the Plan and Bank of America, N.A. is the trustee of the Plan (the "Trustee"). Participant loans qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. The Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA, which are exempt from the prohibited transaction rules.

**E. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). We utilize market data or assumptions that market participants would use in pricing the asset or liability, including assumptions about risk and the risks inherent in the inputs to the valuation technique. These inputs can be readily observable or market corroborated. We primarily apply the market approach for recurring fair value measurements and endeavor to utilize the best available information. Accordingly, we utilize valuation techniques that maximize the use of observable inputs. We are able to classify fair value balances based on the observability of those inputs. The Financial Accounting Standards Codification establishes a fair value hierarchy that prioritizes the inputs used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy are as follows:

Level 1 – Inputs are unadjusted quoted prices for identical assets in active markets. The certificates of deposit represent interest bearing cash, and mutual funds are public investment vehicles valued at their closing quoted market prices on the reported date, all of which are considered Level 1 measurements.

Level 2 – Inputs other than quoted prices included in Level 1 are observable in the marketplace, either directly or indirectly, for the substantial term of the investment. Level 2 measurements included investments in the Putnam Stable Value Fund, which are valued at the net asset value of units of the common/collective trust as determined by the issuer of the trust based on the fair values of the underlying net assets divided by the number of units outstanding. The net asset value per unit is a

quoted price in a market that is not active; therefore, these investments are classified within Level 2 of the fair value hierarchy.

Level 3 – Inputs are unobservable in the marketplace and significant to the valuation. At December 31, 2024 and 2023, the Plan had no Level 3 recurring measurements.

**G. Termination of the Plan**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. All assets of the Plan would be distributed to the participants at the discretion of the Company or would continue to be held in a trust fund to be distributed to each participant upon retirement, death, permanent disability, or termination of employment. See Note H to the Financial Statements for further discussion.

**H. ExxonMobil Savings Plan Merger**

On November 2, 2023, Denbury merged with and into Exxon Mobil Corporation, and on December 31, 2024, the Plan merged into the ExxonMobil Savings Plan (EMSP). At that time, Plan assets were valued at approximately \$164 million.
