To the Investment Committee and Participants of the Nucor Corporation Employee Stock Ownership Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Nucor Corporation Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Nucor Corporation Employee Stock Ownership Plan (the "Plan") provides only general information concerning the provisions of the Plan. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan was established, effective January 1, 1977, principally for the purpose of allowing the employees of Nucor Corporation ("Nucor") to acquire equity ownership in Nucor.

Eligibility - Employees became eligible to participate in the Plan as of the first day of the month following the completion of six months of continuing service. Effective January 1, 1987, no additional employees are eligible to become participants.

Contributions - Prior to 1987, employer contributions to the Plan resulted in a tax credit for federal income tax purposes. Contributions to the Plan were based on an applicable percentage of aggregate compensation paid during the year to all employees who were participants in the Plan on the last day of such fiscal year and were in the form of either cash or Nucor stock or any combination of the two.

As a result of the Tax Reform Act of 1986, employer contributions no longer resulted in a tax credit. Consequently, Nucor decided to discontinue further contributions to this Plan.

Participant Accounts - The Plan is a defined contribution plan under which a separate individual account is established for each participant. Nucor's contributions to the trust fund were allocated as of the last day of the fiscal year to the individual participants' accounts, for those participants employed on the last day of such fiscal year, in the ratio that the compensation of each such participant, for that fiscal year, bears to the total compensation of all such participants for that fiscal year; provided that no more than one-third of Nucor's contribution could be allocated to the group of employees consisting of officers, shareholders owning 10% of the total value of all shares of stock or 10% of the total voting power of all classes of stock, and employees whose compensation for a fiscal year exceeded \$60,000.

Nucor stock purchased from proceeds of investment income earned is allocated to the participants' accounts in proportion to the Nucor stock balances in their accounts as of the record date or the dividend or cash distribution date.

Investment earnings are allocated to active participants' accounts based on the fair value of their individual account to total remaining net assets.

Investment of Contributions - The assets of the trust must be invested in as many full shares of Nucor common stock as is practicable or in temporary investments in order to meet anticipated cash requirements.

Vesting - Each participant's account is fully vested and non-forfeitable at all times including termination, partial termination of the Plan, and at the complete discontinuance of Nucor's contributions. A participant's account is not subject to divestiture except in connection with adjustment because of errors or payment of taxes or expenses imposed upon the trust.

Forfeited Accounts - The nonvested portion of terminated participants' account balances is used to pay the Plan's administrative expenses or be allocated to participants as additional income, as determined by the Employer at its sole discretion. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$1,500 and \$2,400, respectively. No forfeited nonvested accounts were used during the year ended December 31, 2024. During the year ended December 31, 2023, forfeited nonvested accounts totaling \$20,500 were allocated to participants as additional income.

Payment of Benefits - Upon termination, including normal retirement, voluntary termination by the employee, permanent disability or death, the participant or beneficiary will receive their share of accumulated benefits under the Plan in the form of full shares of Nucor stock plus cash, in the case of fractional shares. Additionally, participants aged 55 or older who have completed ten years of service may withdraw a portion of their accumulated benefits, subject to certain limitations defined in the plan document.

Administrative Expenses - As provided in the plan document, administrative expenses may be paid either by the Plan or by Nucor. Nucor has historically paid the operating expenses for the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, the actual amounts could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Investment Valuation and Income Recognition - The shares of Nucor's common stock are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - Management has evaluated subsequent events through October 3, 2025, which is the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY TRUSTEE

The following is a summary of the Plan's investment information as of December 31, 2024 and 2023, and for the years then ended, included in the financial statements and supplemental schedules, that was prepared by, or derived from, information prepared by Fidelity Management Trust Company, the Trustee of the Plan, and furnished to management. Management has obtained certifications from the Trustee that such information is complete and accurate as of and for the years ended December 31, 2024 and 2023.

4. FAIR VALUE MEASUREMENTS

GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under GAAP are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Common stock: Valued at the closing price reported on the active market (New York Stock Exchange ticker: NUE) on which the individual securities are traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement as of the reporting date.

5. RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The Plan invests in Nucor’s common stock. This activity results in related party and party in interest transactions. As described in Note 1, Nucor pays all plan expenses. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

6. PLAN TERMINATION

Although Nucor has not expressed any intent to do so, in the event of termination of the Plan, the Trustee will distribute all assets in the trust, after payment of applicable expenses, to the participants in accordance with the value of their accounts at the date of termination. The distributions shall be in a manner determined by Nucor provided, however, that no Nucor stock may be distributed to a participant within 84 months after the end of the month in which the Nucor stock was allocated to the participant’s account except through the participant’s termination of employment from Nucor.

7. TAX STATUS

The Internal Revenue Service (“IRS”) has determined and informed Nucor by a letter dated October 17, 2013, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Management and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits of any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan’s investment consists of Nucor’s common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
