### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Taconic Biosciences, Inc. 401(k) Profit Sharing Plan and Trust (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The following brief description of the Taconic Biosciences, Inc. 401(k) Profit Sharing Plan and Trust (Plan) is provided for general information purposes only. The Plan is sponsored by Taconic Biosciences, Inc. (Company). The Plan was most recently restated on January 1, 2021.

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan provisions.

*a. General*

The Plan is a defined contribution profit sharing plan with a 401(k) feature covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan assets are held by State Street Bank and Trust Company, the Trustee of the Plan. Company contributions, participant elective deferrals, and participant accounts are managed by Transamerica Retirement Solutions, the Recordkeeper of the Plan. The Plan administrator and investment adviser are responsible for oversight of the Plan and for determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

*b. Contributions*

Each year, participants may contribute a percentage or a fixed dollar amount of their pre-tax annual compensation to the Plan. In addition, participants may contribute after-tax Roth deferral contributions to the Plan. Contributions are subject to certain limitations as defined by the Plan and the Internal Revenue Code (IRC). The maximum participant deferral was \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions up to a maximum of \$7,500 for the years ended December 31, 2024 and 2023. Participants may also contribute rollover amounts representing distributions from other qualified plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. The initial deferral rate for automatically enrolled participants was 4% for each of the years ended December 31, 2024 and 2023. The Plan includes an automatic elective deferral escalation feature to increase deferral rates for automatically enrolled participants by 1% annually, up to a maximum deferral rate of 10%.

The Company contributes a safe harbor match equal to 100% of the first 4% of a participant's eligible compensation. A safe harbor matching contribution is a minimum contribution made by the Company that allows the Plan to be exempt from 401(k) non-discrimination tests.

The Company may contribute additional matching contributions and profit sharing contributions at the discretion of the Board of Directors. There were no additional discretionary matching or profit sharing contributions for the years ended December 31, 2024 or 2023.

Participants direct the investment of their contributions as well as the Company's contributions into various investment options offered by the Plan.

*c. Plan Eligibility*

Employees are eligible to participate in the Plan with respect to elective deferral contributions once they complete three months of service and have reached 18 years of age. To participate in the Company's safe harbor match, discretionary match, and discretionary profit sharing contributions, employees must reach 18 years of age and complete one year of service. In addition, participants must have 1,000 hours of service and be employed on the last day of the Plan year to share in the Company's discretionary profit sharing contributions, if any.

*d. Participant Accounts*

Each participant's account is credited with (a) the participant's contribution, the Company's safe harbor matching contribution, and allocations of the Company's discretionary matching and profit sharing contributions, if any; (b) forfeitures, if any; (c) the Plan's investment earnings (losses), net of investment expenses; and (d) administrative expenses paid by the Plan. Allocations are based on participant compensation, account balances, or specific participant transactions as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*e. Vesting*

Participants are 100% vested immediately in their contributions, the Company's safe harbor matching contributions and any discretionary matching or profit sharing contributions, plus actual earnings thereon.

Prior to January 1, 2021, participants were subject to vesting in the Company's discretionary matching and profit sharing contributions based on years of continuous service. A participant was 100% vested upon (a) disability, (b) death, (c) normal retirement at age 65, or (d) the termination of the Plan. Vesting in the Company's discretionary matching and profit sharing contributions that were made prior to January 1, 2021 is as follows:

*f. Participant Notes Receivable*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participant notes are secured by the balance in the participant's accounts and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through regular payroll deductions. In general, loans must be repaid within five years.

*g. Payment of Benefits*

Upon death, disability, retirement, or the termination of service, a participant (or their beneficiary upon death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or annual installments, as defined by the Plan document. Participants may receive in-service distributions upon reaching age 59½ or on account of financial hardship. Rollover contributions may be withdrawn from the Plan at any time.

*h. Forfeited Accounts*

At December 31, 2024 and 2023, unallocated forfeitures totaled approximately \$5,650 and \$700, respectively. Forfeited non-vested accounts may be used to (a) restore a participant's account upon rehire, (b) reduce the employer's discretionary matching and profit sharing contributions, (c) pay Plan administrative expenses, and (d) add to the employer's profit sharing contribution. Forfeitures used to pay administrative expenses totaled approximately \$30,049 and \$3,800 for the years ended December 31, 2024 and 2023, respectively. Forfeitures allocated to participants' accounts totaled approximately \$6,759 and \$900 during the years ended December 31, 2024 and 2023, respectively.

**Note 2. Summary of Significant Accounting Policies**

*a. Basis of Accounting*

The accompanying financial statements are prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) for defined contribution plans.

*b. Estimates*

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*c. Investment Valuation and Income Recognition*

Investments are reported at fair value, which is the price that would be received to sell an asset in an orderly transaction between market participants on the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the Plan's Trustee and investment adviser.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

*d. Participant Notes Receivable*

Notes receivable from participants are stated at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. Loans treated as distributions totaled approximately \$125,900 and \$6,100 for the years ended December 31, 2024 and 2023, respectively.

*e. Contributions*

Contributions from Plan participants and the matching contributions from the Company are recorded in the year the employee contributions are withheld from compensation.

*f. Payment of Benefits*

Benefits are recorded when paid.

*g. Administrative Expenses*

Administrative fees are paid by the Plan and the Company. Administrative expenses paid by the Company are excluded from these financial statements. Fees related to the administration of participant notes receivable and distributions are charged directly to the participant's account and are included in administrative expenses. Recordkeeping fees paid by the Plan are allocated proportionately to participants based on the value of their account balances. Investment-related expenses are included in net appreciation in fair value of investments.

*h. Subsequent Events*

The Plan has evaluated subsequent events for potential recognition or disclosure through September 24, 2025, the date the financial statements were available to be issued.

**Note 3. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including cash, investments and participant notes receivable held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income from participant notes receivable for the years then ended, was obtained by management and agreed to, or derived from, information certified as complete and accurate by the Trustee of the Plan.

**Note 4. Investments and Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3).

The following three levels of inputs may be used to measure fair value:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 or 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust funds:* Valued based on the NAV of units of a bank collective trust. The NAV, as provided by the fund's trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Plan transactions (issuances and redemptions) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Company paid \$15,400 of expenses on behalf of the Plan for the year ended December 31, 2023. There were no expenses paid by the Company on behalf of the Plan for the year ended December 31, 2024.

Certain administrative functions are performed by officers or employees of the Company. No such officers or employees receive compensation for such functions from the Plan.

Certain investment options are managed by the Recordkeeper and the Trustee of the Plan.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event that the Plan terminates, participants will become 100% vested in their accounts.

**Note 7. Tax Status**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

The Plan's management evaluates tax positions taken by the Plan and recognizes a tax liability or asset if an uncertain tax position was taken and it is more likely than not that the tax position would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events that could impact the value of investment securities, such as international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
