Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of the Plan

The following description of the Socotec, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers employees of Socotec, Inc. (the Plan Sponsor or the Employer) who has satisfied the Plan's eligibility requirements. The Plan was effective January 1, 1997 and was restated effective January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Trustees.

The Plan sponsor adopted the Volume-Submitter Profit-Sharing Plan with Cash or Deferred Arrangement prepared by CCH Incorporated DBA ftwilliam.com. Thus, CCH Incorporated DBA ftwilliam.com is listed as the sponsor of the plan on the Internal Revenue Service (IRS) opinion letter. Empower Trust Company, LLC (Empower) is the Trustee and custodian of the Plan.

The Plan provides retirement benefits to all eligible employees for the following controlled group of employers:

- Socotec, Inc.
- Socotec Engineering, Inc. (previously known as Lucius Pitkin, Inc.)
- Socotec AE Consulting, LLC (previously known as CBI Consulting, LLC)
- Socotec Advisory, LLC (previously known as C2G Consulting, LLC)
- Exterior Research and Design L.L.C.
- Russo Barr Associates, Inc.
- Spinnaker Group, LLC
- Conversano Associates, Inc.
- DSS Condo, LLC

Eligibility

An employee is eligible to participate in the Plan and make elective deferral contributions on the first day of the calendar month, coincident with or next following the date the employee attain age 21 and complete two months of service. Employees are eligible for employer matching contribution and non-elective contribution once attain age 21 and complete at least 1,000 hours of services and 12 months of employment.

Contributions

Each year, participants may elect to contribute up to 75% of their compensation per payroll period, as defined in the Plan, and subject to certain limitations as prescribed by the Internal Revenue Code (the Code). The Plan has an eligible automatic contribution arrangement for eligible employees whose participation date is January 1, 2020 or later and have not made an elective deferral election. The initial amount of the automatic enrollment is 3%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer may, at its discretion, contribute a set-matching percentage that is allocated proportionate to the amount of the salary deferral. During 2023, the Employer made discretionary matching contributions to the account of each eligible employee equal to 50% of the first 6% of eligible compensation that a participant contributes to the Plan. Additional non-elective employer amounts may be contributed at the option of the Employer. There were no non-elective employer contributions for the current Plan year. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's matching contribution, an allocation of the Employer's non-elective matching contributions, and Plan earnings, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, participant earnings or account balances, or specific requested transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their own deferrals plus earnings thereon. Vesting in the Employer's matching contribution and non-elective matching contribution portion of participant accounts plus actual earnings thereon is based upon years of continuous service and begins after two years of service. A participant is 100% vested over a six-year graded period of credited service.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or annual installments. In certain circumstances, participants may make hardship withdrawals as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

If the value of a participant's vested interest in their account is \$5,000 or less, the participant's account will be "cashed out" by distributing the participant's vested interest by a single-sum payment or by direct rollover to an individual retirement account or other eligible retirement plan as soon as reasonably practicable following the date the participant's employment terminates. The participant's account will be cashed out even if the participant does not consent to the distribution. If the value of the participant's vested interest is more than \$5,000, distribution of the account

balance cannot be made before the participant's normal retirement date without the participant's written consent.

Forfeitures

Forfeitures of Employer contributions are used to offset administrative expenses of the Plan. Any remaining forfeitures shall be used to reduce employer contributions otherwise payable to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$75,142 and \$70,052, respectively. For Plan year 2024, \$89,427 was used to reduce employer contribution.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 from their fund accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Participants are allowed to have only one loan at any time. The loans are secured by the balance in the participant's account and range in term from one to five years, although the Employer may permit a longer term for the purchase of a primary residence. The loan interest rate is set at 1% above the prime rate. All loans are covered by demand notes and are repayable through payroll withholding or periodic payments.

Contributions Receivable

Participant contributions and any related employer discretionary matching and non-elective contributions are recognized in the period during which the Employer makes the respective payroll deduction from the participant's compensation. Matching contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Revenue Sharing

The Plan has a revenue sharing agreement with Empower for the reimbursement of certain administrative expenses. Revenue earned from this agreement is included in other income in the statement of changes in net assets available for benefits. The revenue sharing income amounted to \$128,874 for the year ended December 31, 2024. Fund expense paid from this account is \$130,049 and the net revenue reported as other income is \$0 for the year ended December 31, 2024. At December 31, 2024 and 2023, the account totaled \$35,842 and \$32,999, respectively.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements were prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Defaulted notes receivable from participants are deemed distributed and recorded as benefits paid to participants in the statement of changes in net assets available for benefits.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures. Actual results could differ from these estimates.

Administrative and Investment Management Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

3. Fair Value Measurements

GAAP establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that inputs that are most observable be used when available. The input hierarchy is broken down into three levels based on the degree to which the exit price is independently observable or determinable, as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the overall fair value measurement.

The following description of the valuation method and assumptions used by the Plan to estimate the fair values of investments apply to investments held by the Plan.

Mutual Funds - The Plan has investments in mutual funds. Investments in the mutual fund accounts are valued at net asset value (NAV) of shares held by the Plan at year-end. The mutual funds are traded at daily quoted prices through the National Securities Clearing Corporation. These investments are priced by the Plan's custodian using nationally recognized pricing services based on observable market data.

Stable Value Fund - The stable value fund is a common collective trust composed primarily of fully benefit-responsive investment contracts. The stable value fund is valued at NAV, which is based on the fair value of the underlying investments less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions may occur daily. There are no restrictions on the redemption of this investment. There are no unfunded commitments as of December 31, 2024 and 2023. The stable value fund is a direct filing entity.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Information Certified by Empower

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, a qualified institution.

5. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan agreement to discontinue contributions at any time and to terminate the Plan, subject to provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions and net assets of the Plan will be distributed, as prescribed by ERISA and the Plan provisions.

6. Tax Status

The Plan sponsor adopted the non-standardized pre-approved profit sharing plan with Cash or Deferred Arrangement (CODA). Accordingly, the Plan is permitted to rely on CCH Incorporated DBA ftwilliam.com's opinion letter. The IRS has determined and informed CCH Incorporated DBA ftwilliam.com, by a letter dated June 30, 2020, that the Plan is designed in accordance with the applicable sections of the Code. Plans that adopt prototype documents are no longer required to file for an individual determination letter. Although the Plan has been amended from the original prototype document, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the Code.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investments that are exposed to various risks, such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Related Party Transactions and Party-in-Interest Transactions

Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid by the Employer. Notes receivable from participants also qualify as party-in-interest transactions. The Plan has a revenue sharing agreement with Empower for the reimbursement of certain administrative expenses which also qualify as party-in-interest transactions. Such transactions are permitted under the Plan and are exempt from the prohibition of party-in-interest transactions.

9. Subsequent Events

Effective January 1, 2025, SLS Consulting, LLC 401(k) Plan merged into the Plan. Total assets transferred into the Plan were approximately \$4,817,000.

Effective July 1, 2025, the Future Tech Consultants of NY, INC. Profit Sharing Plan merged into the Plan. Total assets transferred into the Plan were approximately \$5,204,000.

Plan management has evaluated subsequent events for recognition and disclosure through October 6, 2025, the date these financial statements were available to be issued. There were no other subsequent events requiring adjustment to or disclosure in the financial statement, except the events mentioned above.
