We used employee and financial data submitted by the plan sponsor without further audit. This information would customarily not be verified by a plan's actuary. We have reviewed the information for internal consistency and we have no reason to doubt its substantial accuracy.

No actuarial accrued liability is included for participants who terminated non-vested prior to the valuation date.

The plan sponsor provides us with data on all employees as of the valuation date, but only those employees who have completed the plan's eligibility requirements are included in the valuation of liabilities.

Liabilities for transfers to other pension plans have been included with liabilities categorized as "terminated with deferred benefits".

No past, present, or future compensation in excess of IRC Section 401(a)(17) compensation limits were considered in the calculation of benefits.

Funding Methodology

The funding methodology prescribed by ERISA is consistent with the plan accumulating adequate assets to make benefit payments when due, assuming that all actuarial assumptions will be realized and that the contributions will be made when due. In this valuation, we are determining market-consistent present values, which may be volatile as economic circumstances change. This may incent the plan sponsor to choose an asset allocation that reduces said volatility.

Effective Date of Plan and Plan Year

The original effective date of the plan was February 11, 1992. The latest restatement was effective January 1, 2013 and was executed on October 28, 2015. The plan year is the calendar year.

Eligible Employees

Salaried or hourly paid supervisory, office, and clerical employees of CANTEX INC. Participants eligible to participate in another defined benefit pension plan of CANTEX INC. are not eligible to participate in this plan. Participation begins on the January 1 coinciding with or immediately following the attainment of age 20 1/2, provided that at least six months of continuous employment has been worked. Participants in the Harsco Administrative Employees Pension Plan immediately prior to February 11, 1992 automatically began participating in this plan on that date.

No employee is eligible to participate in this plan after December 31, 2008.

Type of Plan

Self-administered, trustee defined benefit pension plan.

Contributions to the Plan

Employer contributions to the trust will be made in such amounts and at such times as are required to maintain the plan and trust in compliance with ERISA and IRC Section 412. Participant contributions are not required or permitted.

Credited Service

Number of years and months (not to exceed 40 years) employed as a plan participant. If participation begins on February 11, 1992 (effective date of the plan), then credited service begins accruing as of February 1, 1992. No credited service is earned for any employment after January 31, 2009.

Vesting Service

Continuous service periods calculated from the later of employment date (including employment prior to February 11, 1992 and excluding employment prior to the attainment of age 18) and the date of merger or acquisition. All periods of employment are aggregated for purposes of determining vesting service. Also, vesting service credits under the Harsco Administrative Employees Pension Plan are included.

Plan Compensation

Total wages for the plan year including any bonuses but excluding any severance pay. Amounts employees elect to be deferred under the 401(k) plan or flexible spending plan are included. Plan compensation is subject to maximum limits imposed by the IRS (i.e., \$230,000 for 2008).

Compensation subsequent to January 31, 2009 is not recognized in determining final average compensation.

Final Average Compensation

Average of five highest paid consecutive plan years of employment out of the last ten years of employment.

Plan Formula

1.3% of final average compensation multiplied by credited service up to 33 years, plus 1.5% of final average compensation multiplied by credited service in excess of 33 years. The plan's normal form of payment is life only with 120 monthly payments guaranteed. A participant's accrued benefit as of January 31, 2009 will not be increased for any credited service or compensation after January 31, 2009.

Normal Retirement Benefit

Eligibility is the later of (i) age 65 and (ii) the earlier of five years of vesting service and the fifth anniversary of plan participation.

Late Retirement Benefit

The benefit is determined as for normal retirement considering credited service and final average compensation up to actual retirement. Payments begin at actual retirement without actuarial increase because of age. In no event will this late retirement benefit be less than the actuarial equivalent of the normal retirement benefit.

Early Retirement Benefit

Eligibility is the later of (i) age 55 and (ii) 15 years of vesting service. Benefits can commence at age 65. If benefits are requested earlier, early retirement reductions apply. The reductions are 3.6% per year for the first three years, and 7.2% for each year thereafter.

If an employee retires at or after age 62 with at least 30 years of vesting service, the employee is eligible to begin receiving benefit payments immediately without reduction.

Termination Benefit

If employment is terminated before any retirement age, benefits are 100% vested as long as there is at least five years of vesting service. Benefits can commence at age 65. Early commencement can be elected as early as age 55 as long as the employee has completed at least 15 years of vesting service. Reductions are the same as for early retirement. Accrued benefits for participants in active employment on January 31, 2009 and who terminate employment on or after this date are 100% vested.

Disability Benefit

Upon a participant's disability with at least 15 years of vesting service (before early retirement), the accrued benefit would begin immediately for life only, with payments continuing until the earliest of normal retirement, death, or recovery from disability. The same reduction factors used for early retirement would be applied.

Pre-Retirement Death Benefit

Upon a participant's death, the eligible spouse will begin receiving benefits on the participant's earliest retirement age. The benefit amount is based on the vested benefit that the participant would have received had he survived until his earliest retirement date, retired immediately with a 50% joint and survivor annuity, and then died the following day.

Optional Forms of Benefits

Optional forms include a lifetime only annuity, a 50% joint and survivor annuity, a 100% joint and survivor annuity, 10 and 15 year certain and life annuities, or a lump sum payment. Actuarial equivalent forms of annuity payments are determined based on an interest rate of 6.0% and the 1983 Group Annuity Mortality Table for males with a one-year setback for participants and a five-year setback for beneficiaries and spouses.

Automatic Cash Out

Upon termination of service, if the lump sum value of the accrued benefit is less than \$5,000, the lump sum amount is paid as soon as practical after termination.

Expenses

Paid by the trust if not paid by the employer.
