The following brief description of the Care Design NY 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more information and a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide retirement benefits to employees of Care Design NY, LLC (the Company) who meet certain eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Vanguard Group, Inc. (Vanguard) has subcontracted the recordkeeping services for the Plan to Ascensus, LLC (Ascensus). Ascensus Trust Company (Ascensus Trust), an affiliate of Ascensus, serves as the Plan's directed trustee and custodian.

Eligibility

Prior to January 1, 2024, eligibility to participate in the Plan varied based on hire date and employment status. In 2023, employees over the age of 21 who were not otherwise immediately eligible became eligible after completing one year of service during which at least 1,000 hours were rendered. Eligibility commenced on the first day of the quarter following the completion of these requirements.

Effective January 1, 2024, the eligibility requirements were amended. Employees are eligible to participate in the Plan after attainment of the age 21 and completing six months of service, with entrance to the plan quarterly. In addition, to receive discretionary profit-sharing contributions, participants must be employed on the last day of the Plan year.

Contributions

Active participants may make voluntary pre-tax and Roth contributions in the form of salary deferrals up to the maximum amount permitted by the Internal Revenue Code (IRC) under Section 401(k). Eligible participants, who attain the age of 50 before or by the end of the Plan year, are eligible to make catch-up contributions, subject to certain limitations of the IRC.

For the Plan years ended December 31, 2024 and 2023, the Company made non-elective safe harbor contributions equal to 3% of eligible participants' compensation. In addition, the Company may elect to make discretionary matching contributions. For the years ended December 31, 2024 and 2023, the Company matched 25% of eligible participants' deferrals, up to a maximum match of 1% of participant compensation. The Company may also make discretionary profit-sharing contributions to the Plan, as determined by the Board of Directors. No discretionary profit-sharing contribution were made during 2024 and 2023.

Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan.

1. DESCRIPTION OF PLAN (Continued)

Participant Accounts

An account is maintained for each participant. The fair value of each participant's account is determined as of each valuation date. The change in the fair value of each participant's account includes the effect of employer and participant contributions, income collected or accrued, realized and unrealized appreciation or depreciation of assets, distributions, withdrawals, and all other transactions affecting the assets.

Net investment income by fund is allocated to each participant's account based on the portion in which the value of each participant's account bears to the total value of all participants' accounts. Participants may elect to transfer amounts between funds and change their allocations of contributions to the funds periodically. All investments are participant directed.

Vesting

Participants are immediately and fully vested in their voluntary contributions, the Company's non-elective safe harbor contributions and actual earnings or losses thereon. The Plan provides that all employer matching and profit-sharing contributions vest at a rate of 20% upon completion of two years of credited service and increase 20% for each additional service year, up to 100% upon completion of six years of credited service.

Benefits Paid to Participants

Upon retirement, permanent disability, death, or termination, a participant or their beneficiary will receive a lump-sum amount equal to the value of the participant's interest in his or her account. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of a lump sum cash payout or IRA depending on the balance. Participants may elect to defer their distributions from the Plan until age 72½.

Hardship withdrawals are permitted in the event of immediate financial need. Participants may elect to receive a hardship withdrawal in an amount equal to the value of their vested account balance. Active participants may withdraw all or part of their share of each fund upon reaching age 59½ or earlier, if they suffer a financial hardship as described in the Plan Document.

Notes Receivable from Participants

Plan participants may borrow up to the lesser of \$50,000 or 50% of their vested account balance (reduced by the highest outstanding loan balance in the previous 12 months) and have a maximum of one outstanding loan. The minimum loan amount is \$1,000. Notes receivable must generally be repaid over a period not longer than 5 years, except in the case of a loan taken for the purpose of purchasing a primary residence. All loans bear interest at the prime rate plus 1%. Defaulted loans are deemed as distributions to the extent the law allows.

Forfeitures

Forfeitures of non-vested account balances are used to reduce the Company's contributions or to pay administrative expenses of the Plan. Approximately \$200,700 in forfeitures were used to reduce the Company's contributions in 2024. No forfeitures were used to reduce the Company's contributions or pay administrative expenses of the Plan in 2023. Unallocated forfeitures amounted to approximately \$27,600 and \$169,300 at December 31, 2024 and 2023, respectively.

Plan Administration Costs

Administrative expenses of the Plan are paid from assets of the Plan or by the Company.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company, as applicable.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurement

Accounting Standards Codification (ASC) 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

A description of where the Plan's investments fall within the fair value hierarchy is provided in Note 4.

Payments of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying financial statements.

Use of Estimates

The preparation of financial statements in accordance with generally accepted accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from these estimates.

Employer Contributions Receivable and Allowance for Credit Losses

The Plan records a receivable for employer contributions that are remitted to the Plan subsequent to the Plan's year-end. The Plan considers an expected allowance for credit losses that is updated to reflect any changes in credit risk since the receivable was initially recorded. The estimated allowance for credit losses is based on historical, current, and future conditions.

The Plan has not experienced any historical credit losses relative to contributions receivable, current and future economic conditions are not expected to change relative to historical financial information, and the full amount outstanding was received subsequent to year end. Therefore, management has determined that no allowance for credit losses is necessary as of December 31, 2024 and 2023.

There were no changes to the valuation methodologies used during 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

- *Money market fund and registered investment companies:* valued at fair value using quoted market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. TAX STATUS

The Plan adopted a pre-approved plan offered by Ascensus, LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PARTY-IN-INTEREST TRANSACTIONS

Ascensus, as an agent for Vanguard, is the recordkeeper of the Plan and Ascensus Trust serves as the Plan's directed trustee and custodian. As such, transactions between Ascensus, Vanguard, Ascensus Trust and the Plan qualify as party-in-interest transactions.

In addition, notes receivable from participants qualify as party-in-interest transactions.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through September 12, 2025, which is the date the financial statements were available to be issued.
