Opinion

We have audited the financial statements of HC Employee Stock Ownership Plan (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.



NOTE 1 - Plan Description

The following brief description of the HC Employee Stock Ownership Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for complete information.

Hy Cite Corporation (the “Company”) established the Plan effective as of January 1, 2024. The Plan operates, in relevant part, as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (“IRC”) and is subject to the applicable provisions of the Employer Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by the Plan Trustee.

The Plan purchased the Company common stock using the proceeds of a borrowing from the Company (See Note 7) and holds the common stock in a trust established under the Plan. As the Plan makes debt payments, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the IRC.

The borrowing is collateralized by the unallocated shares of common stock. The Company has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024, and for the year ended December 31, 2024, present separately the assets and liabilities and changes therein pertaining to:

1. The accounts of employees with vested rights in allocated common stock (allocated), and
2. Common stock not yet allocated to employees (unallocated).

Eligibility - Employees of the Company are generally eligible to participate in the Plan after one year of service providing, they worked at least 1,000 hours during such Plan year and attain the age 21. Participants who do not have at least 1,000 hours of service during such Plan year or are not employed on the last working day of a Plan year are generally not eligible for an allocation of Company contributions for such year.

Contributions - For each Plan year, the Employer will contribute the amount necessary to enable the Plan to make the payment due on the loan. The Employer may also contribute to the Plan an additional discretionary amount above what is require to repay the loan. These additional ESOP contributions may be made in Hy Cite Corporation shares or cash. Employer contributions for loan repayment shall be made in cash to the Trustee. Employer stock shall be valued at its fair market value at the time of the contribution. Cash contributions must be immediately applied to pay or prepay any outstanding exempt loans. Employees are not permitted to make contributions.

Payment of Benefits - Distributions on account can occur at any time after the end of the Plan year in which the participant's employment terminates. Termination of employment is when a participant no longer provides any services to the Company or related employers, in accordance with the Company's personnel policy. A termination of employment can result from quitting, being fired, death, disability, or retirement. For vested balances less than \$7,000, a lump sum distribution will occur in the following plan year. Terminated participants may elect to have the distribution paid directly to themselves or rolled over to a qualified IRA. If no election is made, vested balances under \$1,000 will be paid directly to the participant, and vested balances over \$1,000 but less than \$7,000 will be automatically rolled over to a qualified IRA.

NOTE 1 - Plan Description - Continued

For vested balances over \$7,000, terminated participants can elect between leaving their vested balance in the plan, taking a distribution, or rolling it over to a qualified retirement plan. If the terminated participant elects to keep their money in the Plan, then they are allowed to take a distribution at a later date, but no later than at the end of the Plan year of their normal retirement date. If the terminated participant, who was terminated for reasons other than retirement, death or disability, elects for a distribution, then installment payments will begin at the end of the fifth plan year following the Plan year of termination. For terminated participants, who were terminated due to retirement, death or disability, and elects for a distribution, then the distribution will be made as soon as administratively feasible after the end of the Plan year when the participant was terminated. Under the provisions of the Plan, the Plan is obligated to repurchase participant shares. The Plan did not have any distributions and did not repurchase any shares in 2024.

Administrative Expenses - As provided in the Plan document, administrative expenses may be paid either by the Plan or by the Company.

Voting Rights - Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee will vote the shares held under the plan on most issues, but the participant has the right to direct the Trustee to vote the shares held in their account on certain major corporate issues. Major corporate issues include merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of the Employer, or similar transactions affecting the Employer. Participants will be notified if they are entitled to vote on a particular issue.

Plan Termination - The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. Upon termination of the Plan, all participant's accounts become 100 percent fully vested, and the Plan committee should direct the Trustee to pay all liabilities and distribute all affected assets remaining to participants.

Participant Accounts - The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's shares to the total of all participants' shares.

Vesting - If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Vesting schedule is as follows:

Put Option - Under federal income tax regulations, the employer stock that is held by the Plan and its participants, not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current value of the stock. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification - Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution. Participants eligible to diversify make their election after year end based on the number of shares of the Company's stock held in their account at year end.

Forfeitures - Plan forfeitures are left in the plan and allocated to the remaining participants in the same manner as ESOP contributions. Forfeitures are not returned to the Company. There were no forfeitures for the Plan year ended December 31, 2024.

NOTE 2 - Summary of Significant Accounting Policies

Basis of Accounting and Presentation - The financial statements of the Plan are prepared on the accrual basis of accounting and are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) as codified by the Financial Accounting Standards Board.

Use of Estimates - The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Allocations - The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition - Investments are reported at fair value. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions for the shares of Company common stock are reported on the valuation date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - The Plan has evaluated subsequent events through October 2, 2025, the date which the financial statements were available to be issued.

NOTE 4 - Administration of Plan Assets

The Plan's assets, which consist of Hy Cite Corporation shares, are held by the Trustee of the Plan and an independent third-party administrator.

Company contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants. The Trustee also administers the payment of interest and principal on the loan.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE 6 - Fair Value Measurements

The Company has determined the fair value of certain assets in accordance with the provisions of U.S. GAAP, which provides a framework for measuring fair value under generally accepted accounting principles.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used at December 31, 2024 for assets measured at fair value. The carrying values of receivables, cash, and payables included in the accompanying statements of net assets available for benefits approximated fair value at December 31, 2024, and are thus not included in the following table.

- *Common Stock*: Valued based upon an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques. The appraiser took into account historical and projected cash flow and net earnings, return on assets, return on equity, and market comparables. Plan management has concluded that a market participant would also recognize a discount for lack of marketability.

Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a preliminary report which plan management, along with the ESOP trustee, reviews in detail, discusses and approves.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of a different methodology or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7 - Loan Payable

In 2024, the Plan entered into a \$5,000,000 term loan agreement with the Company. The proceeds of the loan were used to purchase Company common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments divided by the total of this year's payment plus all future years' principal and interest payments. This resulted in 6,667 shares being released and allocated for the plan year ended December 31, 2024.

The agreement provides for the loan to be repaid over 150 years. The balance of the note payable as of December 31, 2024 was \$4,912,145. The scheduled amortization of the loan for the next five years and thereafter is as follows:

NOTE 8 - Tax Status

The Plan has received a determination letter from the IRS dated July 14, 2025, stating that the Plan is qualified under the IRC and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE 9 - Related Party and Party-In-Interest Transactions

The Plan invests in Company common stock and has a loan payable to the Company. These are related party and party-in-interest transactions. As described in Notes 1 and 4, the Company may pay expenses of the Plan. The Plan has a few service providers which are considered parties-in-interest under ERISA. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

NOTE 10 - Risks and Uncertainties

The Plan invests in company stock. Company stock is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with certain investment securities and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
