Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated May 19, 2025. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by Superior Products Support, LLC 401(k) Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosures affecting the financial statements were:

The disclosure related to unaudited information certified by the custodian and trustee in Note 3 to the financial statements.

The disclosure of Plan Investments and fair value and contract measurements in Notes 3 through 5 to the financial statements.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. The attached schedule summarizes uncorrected misstatements of the financial statements. Management has determined that their effects are immaterial, both individually and in the aggregate, to the financial statements taken as a whole. The uncorrected misstatements or the matters underlying them could potentially cause future period financial statements to be materially misstated, even though, in our judgment, such uncorrected misstatements are immaterial to the financial statements under audit. In addition, none of the misstatements detected as a result of audit procedures and corrected by management were material, either individually or in the aggregate, to the financial statements taken as a whole.

Reportable Findings

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention. We identified the following reportable findings:

Timeliness of Enrollment for Newly Eligible Participants

During our testing of newly eligible participants, we discovered there were two participants that were enrolled into the Plan prior to meeting eligibility requirements within the Plan Document. Per discussion with Plan Management, a total of eight participants were identified through the Plan Management's internal review of participant data during the year. Plan Management worked with the TPA, Ascensus, LLC (Ascensus) to properly correct this error by distributing the funds to the impacted participants and issuing them a 1099R.

Delinquent Loan

During our audit, we tested a new loan that was initiated through John Hancock Life Insurance Company (former recordkeeper) prior to the transfer of Plan assets to Ascensus in April 2024. The loan tested was transferred to the Ascensus, but participant repayments were not withheld from payroll. As a result, the loan was delinquent at December 31, 2024. Plan Management and Ascensus identified this issue in June 2025 and followed the IRS guidelines to fix the issue, with the participant electing to re-amortize the loan and to make payments through payroll withholdings.

Plan Distributions

Under the terms of the agreement with Ascensus, participants can request a distribution through their access to the Plan website without the authorization of the Plan Sponsor. During our audit, we were not able to inspect any authorized distribution requests from the Plan Sponsor's files to determine that these payments were made to the correct individuals and for the correct amounts. Alternatively, we reviewed a distributions report generated by Ascensus evidencing participants' requests throughout the year. Additionally, during our distribution testing, we identified that excess taxes were withheld from participants that received an excess contribution disbursement in 2024 due to a systemic error within the Ascensus software. There is no further action required by the Plan Sponsor or Ascensus to correct this error, as any excess withholdings would have been returned to the affected participants when they filed their 2024 Income tax return with the Internal Revenue Service.

We recommend the Plan Sponsor generate the distributions report via the Ascensus website on a periodic basis (i.e. monthly) to monitor Plan disbursements initiated by the participant to timely identify unusual type of distribution activity and for improper calculations. This control is also recommended within the Ascensus' System and Organization Controls 1 (SOC 1) Report and is part of the Plan Sponsor's fiduciary duty to oversee plan operations.

Employee File Retention

During participant data and eligibility testing, we found that one participant selected for testing was missing their required I-9 documentation from their employee file. Per discussion with Plan Management, employee files for all employees terminated as a result of the sale of Key-Link Fencing & Railing, Inc. subsequent to year end, were given to the acquiring company. No copies of these documents were retained by the Plan Sponsor.

Additionally, we noted that the Plan website did not provide historical evidence of a participant's elections to opt-out of Plan participation, including electronic evidence of a date/time stamp. This was the result of a payroll transmission error in March 2025 that reflected certain participants from the Plan had terminated. Ascensus quickly remedied this error; however, for those impacted participants, historical deferral and investment allocation changes were overwritten. Plan Management was advised to obtain confirmation of current participant elections. Confirmations were either returned or the participants updated elections directly in the Plan website.

Plan Management should establish a comprehensive record retention policy to ensure compliance with Department of Labor (DOL) and Internal Revenue Service (IRS) requirements related to the administration of the retirement plan. The DOL requires that plan records be retained for at least six years after the filing date of the Form 5500 to support the information reported. However, underlying plan records-including participant account data, payroll records, election forms, distributions, and loan documentation-must generally be maintained for as long as they are relevant to the determination of benefits. Failure to retain adequate participant records can result in increased risk of audit findings, penalties, or enforcement actions by the DOL or IRS and/or potential disputes with participants regarding eligibility, contributions, or benefit entitlements that the Plan may be unable to resolve without supporting documentation.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated October 2, 2025.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditors' opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues


We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

Our responsibility for the ERISA-required supplemental schedules accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).
