#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Onyx Specialty Papers, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

### 1. DESCRIPTION OF PLAN:

#### General

The following description of the Onyx Specialty Papers, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan established to provide benefits to substantially all eligible employees of the Onyx Specialty Papers, Inc., (the "Company") who are eighteen years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### Contributions

Employees are automatically enrolled to reduce their salaries by contributing 3% of their annual compensation. Employees may elect to contribute a different percentage of their annual compensation, subject to limits determined by the Internal Revenue Code (IRC), or may elect not to contribute to the Plan. The limits are \$22,500 and \$20,500 in 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, which are limited to \$7,500 and \$6,500 in 2024 and 2023, respectively. Participants may elect to make after-tax contributions to a Roth Contribution Account. Such Roth elective deferrals are salary deferral contributions that are made in lieu of all or a portion of the participant's pre-tax salary deferral contribution.

The Company may contribute to each eligible participant's account a matching discretionary contribution equal to a percentage of each participant's pre-tax contribution, as determined by the Company's Board of Directors (50% of employee deferrals on the first 6%, up to 3% of eligible compensation). The Company may also make a discretionary profit sharing contribution to participants who are actively employed at the end of the Plan year. There were no profit sharing contributions for Plan years 2024 or 2023. The total annual contributions may not exceed the maximum amount deductible for income tax purposes.

#### Notes receivable from participants

Participants may borrow against their vested account balances. The minimum borrowing amount is \$1,000 and may not exceed the lesser of \$50,000 or fifty percent of the participant's vested benefits. The interest rate on outstanding loans ranges from 4.25% to 9.50%. Loans are for a period not to exceed five years (except longer terms are available for loans issued for the purchase of a principal residence). Principal and interest is paid through payroll deductions. If an employee is no longer with the Company, the outstanding loan is immediately due and payable.

#### Participant accounts

Each participant's account is credited with the participant's contribution plus an allocation of any additional contributions made by the Company and allocations of Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based upon participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### 1. DESCRIPTION OF PLAN: (CONTINUED)

#### Vesting

Participants are fully vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service. Any participant who attains normal retirement age, becomes disabled, or dies, becomes fully vested regardless of length of service. For vesting purposes, an employee earns a year of service upon completing 1,000 hours of service during a vesting computation period. The Company's contributions vest according to the following schedule:

<u>Years of service</u>	<u>Percent vested</u>
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

#### Investment options

Upon enrollment in the Plan, a participant may direct employee and Company contributions among various investment options. Participants may change their investment options any business day during the Plan year.

#### Payment of benefits

Distribution of the accounts of a participant shall be made in the form of a single sum cash payment. Participants with a vested balance greater than \$5,000 may elect to receive installments not to exceed the participant's life expectancy in regular installments.

#### Forfeited accounts

If participants terminate service prior to being fully vested in the Company's contribution account, they forfeit the amount which is not vested. The balance in the forfeited non-vested account can be used to pay administrative expenses of the Plan or be used to reduce the Company's matching contribution for the Plan year. As of December 31, 2024 and 2023, forfeited non-vested accounts were \$15,604 and \$8,693, respectively. Forfeitures added were \$18,643 and \$23,212 during 2024 and 2023, respectively. Approximately \$12,000 and \$20,000 of forfeitures were used to cover employer discretionary match in 2024 and 2023, respectively.

#### Death benefits

Upon the death of a participant, the amount held for the benefit of that participant shall be paid in one lump sum to the participant's designated beneficiary.

### 1. DESCRIPTION OF PLAN: (CONTINUED)

#### **SECURE 2.0 Act of 2022**

The SECURE 2.0 Act of 2022 (the “Act”) was signed into law on December 29, 2022, to increase retirement savings, improve retirement rules, and lower employer costs of setting up a retirement plan. Plan amendments required by the Act generally need not to be made until the end of the first plan year beginning on or after January 1, 2026, however, plans must operate in accordance with effective date of each new provision.

Major provisions of this Act that may effect the Plan include:

- Effective January 1, 2024, the limit for mandatory cash outs was raised from \$5,000 to \$7,000.
- Effective January 1, 2026, catch up contributions for any participants over age 50 who earn over \$145,000 are now required to be made on a Roth basis.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

#### **Basis of accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

#### **Investment valuation and income recognition**

Investments held by the Plan are stated at fair value with the exception of the fully benefit-responsive investment contract which is stated at contract value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). Contract value reflects the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan and is the relevant measure for the portion of assets attributable to fully benefit-responsive investment contracts. All investments are participant directed.

Plan management is responsible for determining the Plan’s valuation policies and analyzing information provided by the investment advisors and record keeper that is used to determine the fair value of the Plan’s investments. See Note 4 for further discussion of fair value measurements.

In accordance with the policy of stating investments at fair value, net unrealized appreciation or (depreciation) for the year is reflected in the statements of changes in net assets available for benefits. The net appreciation (depreciation) in the fair value of the Plan's investments consists of realized gains or losses and unrealized appreciation (depreciation) on those investments.

Purchase and sales of securities are recorded on a trade date basis. Interest and other investment income is recorded as earned on an accrual basis. Dividend income is recorded on the ex-dividend date.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES: (CONTINUED)

##### Investment valuation and income recognition

Earnings on investments, with the exception of participant loans, are allocated on a pro rata basis to individual participant accounts based on the type of investment and the ratio of participant's individual account balance to the aggregate of participant account balances. The portion of interest included in each loan payment made by a participant is recognized as interest income in the participant's account.

##### Notes from receivable from participants

Notes receivable from participants are recorded at their unpaid balance plus any accrued but unpaid interest. Since the participant's remaining vested investment balance is sufficient to cover the outstanding loan amount, there is no allowance for doubtful accounts at December 31, 2024 and 2023. Interest is calculated and included in the repayment terms of the loan when the loan is initiated and is recognized with the amortization of the loan as each payment is remitted. Loans are monitored for repayment under the original loan terms and defaulted when active participants cease payments past the allowed grace period. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. For terminated participants, once a distribution is requested, the outstanding loan balance will be netted against the remaining vested investment balance.

##### Payments of benefits

Benefits are recorded when paid.

##### Administration costs

The Plan's administrative expenses are paid by either the Plan (included as expenses in these financial statements) or the Company, (not included in these financial statements) as provided by the Plan document. The Company absorbs certain costs of Plan administration.

##### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America and the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### 3. INFORMATION CERTIFIED BY TRUSTEES:

Plan management has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company LLC ("Empower"), the trustees of the Plan, certified to Plan management the fair value and physical custody of investments, notes receivable from participants and investment transactions to be complete and accurate as of December 31, 2024 and 2023, and for the years then ended, and interest and dividend income and net appreciation included in the Statements of Changes in Net Assets Available for Benefits, the information contained in Notes 4 and 5, and the information included in the Supplemental Schedule of Assets (Held at End of Year).

**4. FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 Quoted prices (unadjusted) in active markets for identical assets or liabilities. Market price is generally obtained from exchange or dealer markets.
- Level 2 Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. Inputs are obtained from various sources including market participants, dealers and brokers.
- Level 3 Unobservable inputs that are supported by little or no market activity as they trade infrequently or not at all and that are significant to the fair value of the assets or liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes to the methodologies used at December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are valued at the closing price recorded on the active market in which these individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT:

The Plan has a fully benefit-responsive investment contract with Empower that invests contributions in the Key Guaranteed Portfolio Fund. Empower maintains the contributions in its general account. The contract is included in the financial statements at contract value as reported to the Plan by Empower. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate was 1.41% and 1.23% for 2024 and 2023, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

#### 6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### 7. TAX STATUS:

The Plan adopted the Pension Alliance, Inc. Volume Submitter Profit Sharing Plan, which received a favorable opinion from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable provisions of the IRC. Although the Plan has been amended and restated since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**8. RELATED PARTY TRANSACTIONS:**

Plan assets include investment products of Empower, who is the trustee of the Plan and transactions with the trustee, including expenses, qualify as party-in-interest transactions. Fees paid by the Plan to Empower for investment management and record keeping services for the years ended December 31, 2024 and 2023 were \$95,655 and \$80,315, respectively.

**9. RISKS AND UNCERTAINTIES:**

The Plan provides for various investment options in any combination of certain investment products of Empower noted herein. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**10. SUBSEQUENT EVENTS:**

Management has evaluated subsequent events through October 7, 2025, the date on which the financial statements were available to be issued.
