1. Description of Plan

The following description of the PrimePay, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective June 1, 1992, as restated July 1, 2021. The Plan covers all employees, excluding union, non-resident alien employees, of PrimePay, LLC (the “Company”) who have completed 3 full months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Retirement Plan Benefit Committee is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (“IRC”). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company contributes a discretionary match of 50 percent of the first 5 percent of base compensation that a participant contributes to the Plan. Additional profit sharing amounts may be contributed at the option of the Retirement Plan Benefit Committee. For the year ended December 31, 2024, there were no profit sharing contributions to the Plan. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer's matching contributions, and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 20 percent vested after 2 years of credited service and continues to vest in increments of 20 percent until 100 percent vested after 6 years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined daily, is set at 2 percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Terms range up to 5 years or greater for the purchase of a primary residence.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of a lump-sum distribution. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited Accounts

There were no forfeited nonvested accounts at December 31, 2024 or 2023. Forfeitures are used to decrease the amount of Company contributions or to pay reasonable plan expenses to the extent specified in the plan agreement. For the year ended December 31, 2024, the forfeited amounts used to reduce the employer contributions were \$60,004.

Revenue Sharing

The Plan holds assets in a Plan Expense Reduction Account ("PERA") which receives deposits as a result of a revenue sharing arrangement with the insurance company. During 2024, \$55,185 was received from a revenue sharing arrangements and recorded as other income in the Statement of Changes in Net Assets Available for Benefits. During the year ended December 31, 2024, \$44,254 was used to pay administrative expenses, and \$8,229 was allocated back to participants. At December 31, 2024 and 2023, the unallocated balance in the PERA was \$14,920 and \$12,218, respectively.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Benefit Committee is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. As of December 31, 2024 and 2023, the refundable excess contribution liability amounted to \$0 and \$4,951, respectively. The Plan distributed the 2023 excess contributions to the applicable participants on May 29, 2024. The Company filed Form 5330, *Return of Excise Taxes Related to Employee Benefit Plans* and remitted 10% excise tax on October 1, 2025.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company, unless otherwise paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Investments measured at net asset value: Pooled separate accounts are valued at the net asset value ("NAV") or equivalent based on units of the separate account. The NAV, as provided by the insurance company, is used as a practical expedient to estimating fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The following presents investment strategies relative to Plan investments reported on NAV at December 31, 2024 and 2023:

a) Target date funds: Invest in a variety of combinations of equity and fixed income instruments. These funds provide varying degrees of long-term appreciation and capital preservation based on an investor's age or target retirement date through a mix of asset classes. The mix changes over time to become less focused on growth and more focused on income. These funds are also known as "target date retirement" or "age-based" funds. As of December 31, 2024 and 2023, amounts invested in these investment funds were \$5,442,799 and \$4,768,081, respectively.

b) Target risk funds: Invest in a number of underlying funds ranging from conservative to aggressive. The investment strategy of these portfolios is designed to maintain a consistent level of risk over time regardless of the market environment. Each target-risk portfolio is diversified across a mix of stocks, bonds, and other capital preserving investments, and while this may reduce the overall portfolio risk and volatility, diversification does not guarantee a profit or eliminate the risk of a loss. As of December 31, 2024 and 2023, amounts invested in these investment funds were \$6,784,932 and \$6,156,287, respectively.

c) Aggressive growth funds: Invest primarily in equity securities. These funds take higher risk of loss in return for potentially higher returns or gains. As of December 31, 2024 and 2023, amounts invested in these investment funds were \$5,134,705 and \$3,962,643, respectively.

d) Growth funds: Invest primarily in equity instruments of public companies with above-average risk in return for potentially above-average gains. These companies often pay small or no dividends and their stock prices tend to have the most price fluctuations from day to day. As of December 31, 2024 and 2023, amounts invested in these investment funds were \$3,597,668 and \$3,668,009, respectively.

e) Growth and income funds: Invest in a variety of combinations of equity and fixed income instruments. These funds have a dual strategy of growth or capital appreciation and current income generation through dividends or interest payments. As of December 31, 2024 and 2023, amounts invested in these investment funds were \$660,155 and \$600,337, respectively.

f) Income funds: Invest primarily in fixed income instruments. These funds primarily seek current income rather than capital appreciation. As of December 31, 2024 and 2023, amounts invested in these investment funds were \$673,174 and \$730,856, respectively.

g) Conservative funds: Invests primarily in equity and debt securities, as well as cash and cash equivalents,

with a focus on the preservation of principal capital through larger debt and cash investments. As of December 31, 2024 and 2023, amounts invested in these investment funds were \$446,018 and \$773,700, respectively.

Guaranteed investment contract (not fully benefit-responsive): Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

4. Information Certified by Insurance Company

Accordingly, John Hancock Life Insurance Company (U.S.A.), an insurance company, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

Fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. John Hancock Life Insurance Company (U.S.A.) receives revenue from investment fund service providers for services John Hancock Life Insurance Company (U.S.A.) provides to the funds. This revenue is used to offset certain amounts owed to John Hancock Life Insurance Company (U.S.A.) for its administrative services to the Plan. If the revenue received by John Hancock Life Insurance Company (U.S.A.) from such investment fund service providers exceeds the amount owed for its services, John Hancock Life Insurance Company (U.S.A.) remits the excess to the Plan's trust on a quarterly basis. The Plan or Plan Sponsor may make a payment to John Hancock Life Insurance Company (U.S.A.).

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

7. Tax Status

The Plan adopted a pre-approved plan offered by CCH Incorporated DBA ftwilliam.com. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

7. Tax Status (Continued)

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Subsequent Events

On March 5, 2025, the Company announced that it was merging with CoAdvantage Corporation, a Professional Employer Organization ("PEO"). The merger closed on June 30, 2025 and on September 20, 2025, the trustees of the Plan notified the insurance company that the Plan would be discontinued as of January 9, 2026 and be merged with and into, the CoAdvantage Corporation Retirement Savings Plan. As of December 31, 2024, the financial statements do not reflect the effects of this merger. Management does not expect the merger to have a material effect on the Plan's financial position as of December 31, 2024.

Subsequent events were evaluated through October 7, 2025, the date the financial statements were available to be issued.
