## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Youth In Need, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of Youth In Need, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan was established January 1, 2002, as a defined contribution plan for the benefit of employees of Youth in Need, Inc. (the "Organization"). It is a salary reduction plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Organization is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Organization's management team manages the operation and administration of the Plan. The Organization has contracted with Newport Trust Company, LLC and one of its affiliates, (collectively "Newport") to provide trustee and recordkeeping services, respectively. During 2022, Newport Trust Company, LLC merged with Ascensus Trust Company, and during 2023, the assets held by Newport Trust Company, LLC were transferred to Ascensus Trust Company. For the year ended December 31, 2024, trustee services were provided by Ascensus Trust Company. For the year ended December 31, 2023, trustee services were provided by Ascensus Trust Company and Newport Trust Company, LLC, (collectively the "Trustees").

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan Sponsor has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0.

Participation

Employees are eligible to participate in the Plan upon completion of twelve months of service and attaining the age of 18. Participants are eligible to receive the employer matching contribution immediately upon participation in the Plan.

Contributions

Participants may elect to contribute a portion of their eligible compensation not to exceed the Internal Revenue Code limits. Participants may elect to roll over contributions into the Plan from a previous employer's qualified plan. Certain employees meeting age criteria may also be eligible to make "catch-up" contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 2% of eligible compensation. Additionally, the Plan has an auto-deferral feature that increases pre-tax contributions by 1% each January up to a maximum of 8% deferral rate unless participants have elected otherwise.

Contributions (continued)

The Organization matches 100% of the employee's elective deferral not to exceed 3% of compensation that a participant earns. In addition, the Organization may make an annual discretionary non-matching contribution to the Plan. No discretionary contributions were made in 2024. The matching and discretionary contributions are invested based upon the investment options chosen by the participant. Contributions are subject to certain limitations.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of: (a) the Organization's contributions, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants shall at all times be one hundred percent (100%) vested in their salary deferral contributions plus actual earnings thereon.

Participants vest in employer matching and non-matching discretionary contributions in accordance with the following schedule:

Participants are fully vested at their normal retirement date, death or disability, regardless of the number of years of participation.

Participant investment options

Upon enrollment in the Plan, participants may elect to invest their contributions and any Company matching and non-matching discretionary contributions in one or more of the Plan's investment options. The investment options are trusted registered investment companies with a range of investment objectives. Participants may change the manner in which their current contributions are invested and are allowed to transfer between investment accounts.

1. DESCRIPTION OF THE PLAN (continued)

Notes receivable from participants

A participant may borrow from the Plan a minimum of \$500 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account. A participant may have no more than two loans outstanding at a time, which must be repaid in five years for general purpose loans, or ten years for the purchase of a primary residence. The interest rate for loans issued by the Plan are commensurate to the Prime rate plus one percent. Interest rates at December 31, 2024 range from 3.25% to 9.50% with various maturity dates through November 2029. After a loan is issued, the rate remains fixed for the duration of the loan principal and interest are collected ratably through payroll deductions.

Payment of benefits

Upon termination of service, death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in annual installments over a period not exceeding life expectancy. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may also withdraw certain basic contributions and related earnings thereon only in the event of financial hardship as defined by the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investment valuation and income recognition (continued)

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

Contributions and contributions receivable

Contributions from participants and related receivables are recorded based on the date the contributions have been separated from a participants' pay (pay date). Contributions from the Company are recorded in the year earned to coincide with the year in which the Company records the contributions to its general ledger. The Plan records receivables for contributions based upon the contribution recognized, less amounts received by the Plan as of the last day of the Plan year. Rollover contributions from participants are recorded based on the date the contributions are received by the Custodian.

Payment of benefits

Benefits are recorded when paid.

Expenses

Significant administrative expenses are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. All other administrative fees are applied to participant accounts based on transactions. Investment related expenses are included in net appreciation in fair value of investments.

Forfeited accounts

Any portion of a terminated employee's account that is not vested is forfeited, subject to the possibility of being reinstated. Forfeitures may be used to reduce future employer contributions. At December 31, 2024 and 2023, the ending balance in the forfeiture account was \$32,295 and \$33,091, respectively. During the year ended December 31, 2024, Employer contributions were reduced from forfeited non-vested accounts by \$28,037.

Subsequent events

Subsequent events were evaluated through September 25, 2025, which is the date the financial statements were available to be issued.

3. INVESTMENT INFORMATION CERTIFICATIONS BY THE TRUSTEES (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, the Trustees, determined to be qualified institutions by the plan administrator, have certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants as shown on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Investments and notes receivable from participants reflected on the schedule of assets (held at end of year) as of December 31, 2024, ("supplemental schedule").

Accordingly, as requested by the plan administrator, the Plan's independent auditor performed no procedures on the certified information other than to agree the certified information to the related information included in the financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quote prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* The fair values of the Plan's mutual fund holdings are recorded at the quoted daily closing price as reported by the funds. The mutual funds held by the Plan are deemed to be actively traded.

5. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

ERISA defined party-in-interest similar to a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Plan management did not identify any related parties to the Plan that were not also considered to be parties-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Newport is the recordkeeper as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative services totaled \$53,906 for the year ended December 31, 2024. Fees paid by the plan for investment fees are reflected in net appreciation in fair value of investments.

6. INCOME TAX STATUS

The Plan operates under a prototype plan agreement of Newport Group Inc. This prototype plan agreement received a determination letter dated November 30, 2020, stating that the prototype plan and the related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the prototype plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
