To the Participants and Trustees of

Opinion

We have audited the financial statements of International Union of Operating Engineers Local 399 Participating Employers Deferred Compensation Employee Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of International Union of Operating Engineers Local 399 Participating Employers Deferred Compensation Employee Savings Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Responsibilities of Management for the Financial Statements (continued)

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit;
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements;
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed;
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements; and
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

December 31, 2024 and 2023

Note 1. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements of International Union of Operating Engineers Local 399 Participating Employers Deferred Compensation Employee Savings Plan (the Plan) have been prepared using the accrual basis of accounting.

Investments - The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of the investments are reflected on a trade-date basis.

Dividend income is recorded on the ex dividend date. Interest income is recorded on the accrual basis.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are recorded when incurred. No allowance for credit losses has been recorded as of either December 31, 2024 or 2023.

Contributions Receivable - Contributions due but not received at year end are recorded as contributions receivable. Contributions due as determined by payroll compliance audits are recognized upon settlement with the employer. An allowance for uncollectible amounts is considered unnecessary and has not been provided.

Property and Equipment - Property and equipment are recorded at cost. Major additions are capitalized while replacements, maintenance and repairs which do not improve or extend the lives of the respective assets are expensed currently. Depreciation is computed by the straight-line method over estimated useful lives of five years.

Note 1. Summary of Significant Accounting Policies (continued)

Revenue Recognition - Employers may make non-elective contributions to the Plan as determined by the collective bargaining agreement between the employer and the union. These contributions are based on the straight rate of pay earned in covered employment. Revenue derived from non-elective employer contributions is recognized in the period in which covered work is performed. The Plan carries out its purpose described in Note 2 within a jurisdiction primarily located in certain counties of the states of Illinois and Indiana.

Payment of Benefits - Benefits payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan but were not yet paid at either December 31, 2024 or 2023.

Expenses - Certain investment related expenses are included in net appreciation in fair value of investments.

Reclassifications - Certain reclassifications have been made to prior year amounts to conform to the current year presentation.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Subsequent Events - Subsequent events have been evaluated through October 3, 2025, which is the date the financial statements were available to be issued.

Note 2. Description of the Plan

The Plan is a multiemployer defined contribution retirement plan established pursuant to a collective bargaining agreement between International Union of Operating Engineers Local 399 (the Union) and participating employers to provide benefits for eligible participants upon termination or retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Benefits under the Plan are not insured by the Pension Benefit Guaranty Corporation.

Individuals become a participant of the Plan on the first day of the month that coincides with or next follows the date hired as an eligible employee.

Note 2. Description of the Plan (continued)

Once eligible, participants may contribute pre-tax contributions up to 100% of annual compensation, as defined by the Plan. Participants may also make after-tax Roth contributions. Contributions are subject to certain limitations established by the Internal Revenue Code. Additionally, participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. As described in Note 1, certain employers make non-elective contributions on behalf of participants. Rollover contributions from another qualified retirement plan are also permitted.

Participants direct the investment of contributions into various investment options offered by the Plan. In the absence of participant direction, contributions are invested in a default target date investment fund. Participants must evaluate their own investment goals and objectives and choose the investments best suited to achieve those goals and objectives. Poor investment performance by the investment options selected by the participants may cause their vested account balance to be lower than contributions made to the Plan.

An individual account is established for each participant. Participants' accounts are credited with the participant's contribution, the employer's contribution, if any, and allocations of Plan investment earnings or losses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. Participants were charged a monthly administrative fee equal to \$4 per participant per month through September 2023. Effective in October 2023, participants are charged a quarterly administrative fee equal to \$45 per participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Net assets available for benefits at December 31, 2024 and 2023 include unallocated accounts of \$468,451 and \$369,939 respectively, which are available to pay administrative costs of the Plan.

Under current provisions of the Plan, each participant is immediately vested in their participant and employer contributions, if any, and the earnings thereon.

In accordance with specific provisions of the Plan, upon termination of service due to death, disability, retirement or termination of employment, a participant (or beneficiary, in the case of death) will receive a distribution of the participant's account balance. Hardship distributions are also available under current Plan provisions. However, before requesting a hardship distribution, participants must apply for any participant loan available under the Plan.

Participants may borrow from their accounts up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance of the participant's account and are repayable through payroll deductions over periods ranging up to five years, except for loans for the purchase of a principal residence, which are repayable over ten years. Notes bear interest at 1% higher than the prime lending rate. Interest rates on participant loans ranged from 4.25% to 9.5% during the years ended December 31, 2024 and 2023. If a participant does not make repayments, the note will be considered to be in default, and the note balance will be recorded as a benefit payment based on the terms of the Plan document.

Participants should refer to the summary plan description for more complete information.

Note 3. Priorities upon Termination

It is the intent of the Trustees to continue the Plan in full force and effect; however, the right to discontinue the Plan is reserved to the Trustees. Termination shall not permit any part of the Plan assets to be used for or diverted to purposes other than the exclusive benefit of the participants and their beneficiaries, except that provision may be made for the payment of necessary expenses resulting from termination of the Plan. In the event of termination, the net assets of the Plan will be allocated to pay benefits in priorities as prescribed by ERISA and its related regulations. Whether or not a particular participant will receive full benefits should the Plan terminate at some future time will depend on the sufficiency of the Plan's net assets at that time and the priority of those benefits.

Note 4. Tax Status

The Plan obtained a determination letter dated March 28, 2013, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of Section 401(a) of the Internal Service Revenue Code and was, therefore, exempt from federal income taxes under the provisions of Section 501(a). The Plan has been amended since receiving the determination letter. The Plan's administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. They therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Fair Value Measurements

The *Fair Value Measurements and Disclosures* Topic of the FASB Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

The following table sets forth, by level within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. As required, assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. In accordance with generally accepted accounting principles, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the following table is intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

Level 1 Measurements

The fair values of the mutual funds are determined by reference to the funds' underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value on the last business day of each period presented.

Measurements Using Net Asset Value as a Practical Expedient

Certain investments are valued at the net asset value per share, used as a practical expedient to estimate fair value. The net asset value is based on the fair values of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value.

The stable value fund is a direct filing entity (DFE) and files a Form 5500 annual report with the U.S. Department of Labor. The Plan is not required to disclose the significant investment strategies of DFE investments. Redemptions of the stable value fund are available on a daily basis without notice.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

Note 6. Risks and Uncertainties (continued)

Due to inherent uncertainties involved in the valuations of investments that are not publicly traded, estimated fair values may differ materially from the values that would have been used had a ready market for the underlying securities existed.

As of December 31, 2024 and 2023, the Plan held units in the Vanguard Wellington Fund with a fair value of \$111,816,697 and \$101,565,700, respectively (approximately 32% and 33%, respectively, of net assets available for benefits). The mutual fund has an objective to provide long-term capital appreciation and moderate current income by investing in equity and fixed income securities. It is reasonably possible that changes in the value of this investment could materially affect the participants' account balances and amounts reported in the statements of net assets available for benefits. The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across the participant directed fund elections. Additionally, the investments within each participant directed fund election are further diversified into varied financial instruments. Investment decisions are made, and the resulting risks are borne, exclusively by the Plan participant who made such decisions.

Note 7. Property and Equipment

Depreciation expense was \$406 for the year ended December 31, 2023. Fully depreciated assets totaling \$10,590 were disposed of during the year ended December 31, 2024. Computer software costs of \$999 represent software being developed and not yet placed in service. No depreciation is taken on such capitalized costs until the asset is in use.

Note 8. Related Organizations

The Plan is related to several organizations including a local union, two welfare plans, a savings plan and a training fund.

Office Lease

Prior to its move to third-party administration in October 2023, the Plan leased office space in Chicago, Illinois from the local union under an operating lease agreement which was terminated effective October 1, 2023. The Plan was also required to pay a proportionate share of real estate taxes and operating costs of the building. Total rent expense, including the Plan's share of real estate taxes and operating costs was \$8,089 for the year ended December 31, 2023.

Note 8. Related Organizations (continued)

Shared Administrative Expenses

Prior to its move to third-party administration in October 2023, the Plan shared office facilities, equipment and staff with the local union through September 2023. Most related expenses were initially paid by the local union and reimbursed by the Plan on a monthly basis. During the years ended December 31, 2024 and 2023, the Plan reimbursed the local union \$4,263 and \$30,366 respectively, for various shared expenses, which are included with administrative expenses in the statements of changes in net asset available for benefits. No amounts were owed to the local union as of either December 31, 2024 or 2023.

Note 9. Administrative Service Agreement

The Plan had an administrative service agreement with John Hancock Life Insurance Company, which provided that John Hancock Life Insurance Company reimbursed the Plan, through September 2023, for a portion of administrative expenses on a monthly basis. Total amounts received from John Hancock Life Insurance Company were \$169,078 for the year ended December 31, 2023. No reimbursements were received for the year ended December 31, 2024.

Note 10. Exempt Party-in-Interest Transactions

The Plan's investments are held by John Hancock Trust Company LLC, who provides certain custodial and recordkeeping services to the Plan. Additionally, certain investments are owned and managed by John Hancock. These transactions qualify as party-in-interest transactions under ERISA.

Note 11. Participant Contributions

Employers withhold participants' contributions and loan repayments from their payroll. During the years ended December 31, 2024 and 2023, certain employers remitted contributions to the Plan more than 15 days after the following month, which did not meet the timeliness requirements prescribed by U.S. Department of Labor (DOL) regulations. These late remittances constitute prohibited transactions with a party-in-interest. During the years ended December 31, 2024 and 2023, contributions that were not timely remitted to the Plan totaled \$919,280 and \$1,594,563 respectively.

The Plan has a collection program that pursues legal action against delinquent employers. As part of its collection program, the Plan may collect contributions, liquidated damages, interest and attorney fees from delinquent employers.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.


