Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements



NOTE 1. DESCRIPTION OF PLAN

The following description of the Aldrich Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan with a cash or deferred arrangement under Code §401(k), effective July 1, 1990, and most recently amended and restated on December 29, 2021 with an effective date of January 1, 2021 to comply with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Covers all full-time employees of AKT Services, LLP (the “Company”) who have reached the age of 18 and completed one day of qualifying service. Affiliates and adopting employers are counted as a single employer in determining eligibility. AKT Services, LLP (Plan Sponsor), Aldrich Wealth, LP, Aldrich CPAs and Advisors LLP, Aldrich Services, LLP, and Aldrich Capital Advisors LP were counted in determining eligibility. Employment governed by a union contract, leased employees, and independent contractors or other persons not “common law employees” are not eligible to participate in the Plan. Upon becoming eligible, plan entry dates are the first of every month.

Contributions – Participants may elect to contribute up to 100% of their compensation to the Plan up to the maximum allowed by the Plan each calendar year. Participants can make changes to contribution rates monthly, effective the first day of the month following. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from another qualified plan with written approval from the plan administrator. Notwithstanding the catch-up provisions, the statutory limit on each participant’s contributions for calendar year 2024 was \$23,000.

The Company may make a discretionary matching contribution each year. Additionally, the Company may make other discretionary non-elective contributions to the Plan. Beginning January 1, 2022, participants become eligible for discretionary non-elective contributions at the earlier of (A) reaching age 18 and being credited with 1 year of eligibility service or (B) reaching age 18 and being credited with 1 day of employment during an eligibility computation period.

Investment Elections – Participants may choose any combination of investments as presented in Plan documents, which include options to choose from funds that are designed for specific risk tolerances. When a participant does not make a timely election to direct the investment of his or her permitted accounts, then those accounts will be invested by the Trustee in a default investment, which has been selected by the Administrator. Participants can change investment combinations as often as permitted under the particular investment vehicle.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts – Each participant’s account is credited with the participant’s elective deferral and allocations of the Company’s contribution and Plan earnings. Allocations are on participant compensation or account balances, as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. From time-to-time compliance testing adjustments create excess aggregate contributions, which result in refunds to participants, or forfeitures of non-vested amounts. Any amounts still to be paid are charged on a pro-rata basis to the participant accounts, then deducted from the Plan.

At December 31, 2024 and 2023, there were no unallocated employer profit sharing contributions. Unallocated plan assets total \$2 as of the years ended December 31, 2024 and 2023. Unclaimed property amounts totaled \$0 as of December 31, 2024 and 2023, and are included in the Key Guaranteed Portfolio Fund (Note 4). When applicable, these amounts are subsequently allocated to participant accounts after each respective year-end.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in Company contributions is based on years of credited service. Participants are 0% vested until the third year of service, at which point they become 100% vested.

Notes Receivable from Participants – Participants may borrow from their vested accounts in the event of a financial hardship. The financial hardship reason must comply with the IRS safe harbor reasons for a hardship withdrawal. A participant that meets these requirements may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50 percent of the participant’s vested interest in their aggregate account balance. Loans are secured by the balance in the participant’s account and bear a fixed interest rate as determined by the plan administrator when the loan is made. Principal and interest are paid ratably through payroll deductions for a period not to exceed five years, unless loan proceeds are used to purchase a principal residence. Participants can only have one loan outstanding at any time.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, rollover their account balance to another qualified plan or individual retirement account, or receive an annuity as specified by Plan provisions.

Qualifying hardship distributions may only be requested through the Custodian, are subject to approval, and must comply with applicable IRS regulations. Hardship distributions can be taken from the Plan by participants before being required to request a loan. Participants are required to prove financial need, and the extent of the distribution cannot exceed the financial need.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Mandatory force-out distributions can only be made if a participant's vested aggregate account on or after the date of termination of employment does not exceed \$7,000, which will be determined by including the participant's rollover contribution account. These will be treated as a lump sum or rollover as designated by the participant. If the participant makes no designation, the distribution will be made in a lump sum.

Forfeited Accounts – At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$74,540 and \$78,863, respectively. These accounts will be used to either reduce future employer contributions or pay Plan expenses. The Plan utilized \$109,980 of forfeitures to fund employer contributions during the year ended December 31, 2024.

NOTE 2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – Shares of registered investment companies are valued at fair value based on published market prices. See Note 3 for further discussion of fair value measurement. The investment contract held in a general account is reported at contract value. Fair value and contract value for the investments of the Plan are certified by the custodians and insurance company.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance in addition to any accrued but unpaid interest. Delinquent amounts are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits – Benefits are recorded when paid. As of December 31, 2024, there were no distributions requested by participants, but not yet processed, that would require disclosure in these financial statements.

Administrative Expenses – Certain administrative activities are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Substantially all administrative expenses are paid by the Plan Sponsor.

NOTE 2. SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Some investment options used by the Plan generate revenue sharing. The Plan is set up to return revenue sharing back to the participant account that generated it. This setup is taken into consideration by the Plan when evaluating the net expense of investment options used or being considered by the plan.

Date of Management's Review – Subsequent events were evaluated through September 29, 2025, which is the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Registered Investment Companies (Mutual Funds) – Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4. GUARANTEED INVESTMENT CONTRACT

The Plan has a fully benefit responsive group annuity contract with Empower Annuity Insurance Company of America (Empower) which is called the Key Guaranteed Portfolio Fund. Empower maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Since the group annuity contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (1) premature termination of the contracts by the Plan, (2) Plan termination, (3) plant closings, (4) bankruptcy, (5) layoffs, (6) mergers, and (7) early retirement incentives. The Plan may cease contributions and participation in the contract by written notice to the issuer 90 days ahead of the contribution cessation date. The Plan will then elect a cessation option to transfer at contract value the holdings in the contract. The plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer, and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE 4. GUARANTEED INVESTMENT CONTRACT (CONTINUED)

The insurance company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The average yield earned by the Plan for the years ended December 31, 2024 and 2023, was 1.41% and 1.23%, respectively. The actual average yield earned by the Plan for the benefit responsive fund was 1.56% and 1.38% for the Plan years ended December 31, 2024 and 2023, respectively.

NOTE 5. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS

The Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan, have certified the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, line 4i-Schedule of Assets (Held at End of Year) as of December 31, 2024; and related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 6. PARTIES-IN-INTEREST

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Plan Sponsor. The Plan Sponsor provides to the Plan certain accounting and administrative services for which no fees are charged. Fees paid during the year to third party administrators or custodians for services rendered by parties-in-interest are based on customary and reasonable rates for such services and are paid by the Plan Sponsor. The Plan issues loans to participants, which are secured by balances in the participants' accounts. These transactions qualify as exempt parties-in-interest transactions.

The Plan holds units in the Key Guaranteed Portfolio Fund, a general account managed by Empower Annuity Insurance Company of America. These transactions and management of this fund qualify as exempt party-in-interest transactions.

NOTE 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would be one hundred percent vested in the amounts credited to their accounts.

NOTE 8. TAX STATUS

The Plan is an IRS pre-approved defined contribution plan. The Plan sponsor adopted a specimen plan from a volume submitter practitioner, Saalfeld Griggs, PC, and as designed, it is in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adoption. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
