## INDEPENDENT AUDITOR'S REPORT

To the Participants, Members and  
The Plan Administrator of the Axle Logistics 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Axle Logistics 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 and 2023**

**NOTE 1 - PLAN DESCRIPTION**

The following brief description of the Axle Logistics (the “Company” and “Plan Sponsor”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** - The Plan is a defined contribution plan covering all employees of the Company who have completed 500 hours of service in a 6-month period and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Members are responsible for oversight of the Plan. The Members and management of the Company determine the appropriateness of the Plan’s investment offerings and monitor investment performance. The original effective date of the Plan was January 1, 2019. The Plan was amended and restated on December 31, 2023.

**Contributions** - Each year, participants may contribute up to the maximum amount allowed by the Internal Revenue Code of pre-tax annual compensation or as after-tax compensation (Roth), as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan on the first of the month following their date of eligibility unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated fund until changed by the participant. The Company makes safe harbor contributions to match 100% of the participants’ contributions that do not exceed 3% of eligible compensation plus 50% of the participants’ contributions that exceed 3% of eligible compensation, limited to 5% of eligible compensation. The Company may also make profit-sharing contributions at its discretion. There were no profit-sharing contributions made for the year ended December 31, 2024.

**Participant Accounts** - Each participant’s account is credited with the participant’s contributions and any Company safe harbor contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the participant on a quarterly basis. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** - Participants are vested immediately in their contributions, Company safe harbor contributions, rollover contributions, plus actual earnings thereon. Vesting in the Company’s profit-sharing contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

**Payment of Benefits** - On retirement, death, disability or termination of service, a participant (or participant’s beneficiary in the event of death) may receive the vested portion of the participant’s account. The Plan also permits distributions prior to termination of employment (in-service and hardship) upon meeting certain requirements. A participant who has attained the Plan’s normal retirement age and who has not separated from service may also request distribution of his or her account balance. Distributions are made in the form of lump sum payments or installment payments.

**Forfeited Accounts** - At December 31, 2024, the balance of forfeited non-vested accounts was \$4,941 (\$0 at December 31, 2023). Forfeited account balances are used to restore forfeitures, reduce Company contributions, or to pay reasonable Plan expenses.

## NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions** - Contributions from Plan participants and matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits** - Benefits are recorded when paid.

**Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

**Subsequent Events** - Management has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued, and has determined that there are no subsequent events that require disclosure.

## NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**NOTE 3 - FAIR VALUE MEASUREMENTS (Continued)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 4 - INFORMATION CERTIFIED BY THE TRUSTEES**

The Plan has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan has obtained certifications from Empower Annuity Insurance Company of America and Empower Trust Company, LLC (Empower), the current trustee and custodian, and The Trust Company of Tennessee, the former trustee and custodian, that the information in the accompanying financial statements and supplementary schedule, with respect to investments and related investment activity, is complete and accurate as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The investment information certified by the trustees is presented based on their certifications and is summarized below.

**NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan has a benefit-responsive investment contract issued by Empower totaling \$42,555 at December 31, 2024. The Empower Investments Fixed Account is a general account product. The fixed interest investment option guarantees principal and a minimum guaranteed interest rate for the life of the contract.

The value of the account is calculated by combining all contributions and deposits to the fixed account option, interest credited to the fixed account, any amounts transferred in and out of the account, and any applicable charges. Interest is credited to the account daily on a portfolio basis. The interest rate credited to the account varies based on contract and is guaranteed by the trustee to exceed 1.00% The interest-crediting rate is reset quarterly.

The fixed interest investment meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if there were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits, plus accrued interest, less withdrawals. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The Plan's ability to receive amounts due is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

#### **NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (Continued)**

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (e.g., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreements without the consent of the issuer.

#### **NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are held by Empower, the trustee and custodian, and therefore, qualifies as a party-in-interest.

During 2024, the Plan paid \$23,480 in investment management fees to the Plan's investment advisor and \$3,100 in administrative fees to the Plan's third-party administrator. These fees can be offset by forfeited account balances.

The Plan Sponsor also provides the Plan with certain accounting, auditing and administrative services for which no fees are charged to the Plan.

#### **NOTE 7 - TAX STATUS**

The Plan Sponsor adopted a non-standardized pre-approved profit sharing plan sponsored by Tennessee Pension Administrators. Tennessee Pension Administrators received a determination letter dated June 30, 2020 which covers the plan. Although the Plan has not applied for its own opinion letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 10 - CHANGE IN SERVICE PROVIDERS**

In 2024, the Plan changed its custodian, trustee, and recordkeeper to Empower and changed its third-party administrator to Tennessee Pension Administrators. With the change in providers, the Plan was amended effective December 31, 2023.
