INDEPENDENT AUDITOR'S REPORT

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 

NOTE 1. DESCRIPTION OF PLAN

The following description of Pence Construction 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – LCG Pence, LLC (the “Plan Sponsor”) sponsors a 401(k) profit sharing plan, which was originally effective on January 1, 2001, and most recently amended and restated effective January 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a defined contribution plan covering full-time employees of LCG Pence, LLC, Pence/Kelly Construction, LLC, Pence Contractors, LLC and Beaver Equipment Company, LLC.

To participate and make elective deferrals, employees must be at least 21 years of age, have completed 30 days of service, and not be considered excluded employees as defined by the Plan document. In addition, the Plan Sponsor may make employer safe-harbor matching and discretionary non-elective contributions (profit-sharing). For eligibility in the employer contributions, employees must have completed one year of service (including 1,000 hours). Employees may enter the Plan and begin receiving safe-harbor matching contributions on the first day of the month following the date they satisfy the eligibility requirements.

Contributions – Participants may contribute up to 100 percent of annual compensation as a pre-tax or post-tax (Roth) contribution, as defined in the Plan, not to exceed statutory limits. Notwithstanding the catch-up provisions, the statutory limit on each participant’s contributions for 2024 was \$23,000. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions up to \$7,500 annually. Participants may also contribute amounts representing rollovers from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor makes safe-harbor contributions each year whereby the Plan Sponsor matches 100% of salary deferrals on the first 3% of Plan compensation, plus 50% of salary deferrals on the next 2% of Plan Compensation. This provides a maximum matching contribution of 4%. Management elected not to make discretionary, non-elective profit-sharing contributions for Plan years ending in December 31, 2024 and 2023, respectively.

Investment Elections – Participants may choose any combination of investments as presented in Plan documents. Participants can change investment combinations as often as permitted under the particular investment vehicle. The accounts of participants who do not select an investment option are automatically invested in the appropriate Vanguard Target Retirement Fund for the year closest to the year of the participant’s normal retirement age.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of the Plan Sponsor’s contributions, Plan earnings (losses), and charged with an allocation of administrative expenses when applicable. Allocations are based on participant earnings or account balances, as defined by the Plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their contributions and actual earnings thereon. Participants are also immediately vested in the Plan Sponsor’s safe-harbor matching contributions plus earnings thereon. Vesting in any employer discretionary contribution is based on years of service and occurs gradually. After one, two, three, and four years of credited services, the Plan Sponsor’s discretionary profit sharing contribution portion becomes 25%, 50%, 75%, and 100% vested, respectively, to the participant. Participants shall become 100% vested upon attainment of early retirement age (attainment of age 55, with six years of experience), death, or disability.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, installments, or annuity contracts. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or roll it over to another qualified plan. Account balances under \$5,000 may be automatically distributed at the discretion of the Sponsor. Hardship withdrawals are allowable if certain conditions are met.

Forfeited Accounts – At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3 and \$49,126, respectively. Forfeitures are used first to pay administrative expenses if there are outstanding invoices at the time and then to offset employer matching contributions. In 2024, \$10,683 of forfeitures were used to pay Plan expenses, and \$98,943 were used to offset employer contributions.

Notes Receivable from Participants – Participants may borrow from their accounts \$1,000 up to the lesser of \$50,000 or 50% of their vested account in cases where a “financial hardship or specific financial need” can be demonstrated. Loan transactions are treated as participant-directed investments. The loans are secured by the remaining balance in the participant’s account and bear interest at one percentage point higher than the prime lending rate. Principal and interest are paid ratably through payroll deductions for a period generally not to exceed five years and are subject to a processing fee to initiate the loan.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – Shares of registered investment companies are valued at fair value based on published market prices. See Note 3 for further discussion of fair value measurement. The investment contract held in a general account is reported at contract value. Fair value and contract value for the investments of the Plan are certified by the custodians and insurance company. Purchases and sales of securities are recorded on a trade-date basis. Interest income, including interest on outstanding loan balances, is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent amounts are reclassified as distributions based upon the terms of the Plan document. There were outstanding notes to participants of \$5,580 and \$0 at December 31, 2024 and 2023, respectively.

Payment of Benefits – Benefits are recorded when paid. As of December 31, 2024, there were no distributions requested by participants, but not yet processed, that would require disclosure in these financial statements.

Administrative Expenses – Certain administrative activities are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. The Plan pays substantially all administrative expenses to third-parties for services including recordkeeping, investment advising and other administrative services. Investment expenses are netted against investment income.

Date of Management's Review – Subsequent events were evaluated through August 22, 2025, which is the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

NOTE 3. FAIR VALUE MEASUREMENTS (CONTINUED)

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Registered Investment Companies (Mutual Funds) – Investments in mutual funds are valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4. GUARANTEED INVESTMENT CONTRACT

In 2019, the Plan entered into a fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America (Empower). Empower maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attributable for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented at contract value on the face of the statements of net assets available for benefits. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, which is stipulated by the contract as one percent, and prevailing market conditions. The interest crediting rate is reset quarterly. The average yield earned by the Plan for the year ended December 31, 2024 and 2023 was 1.41% and 1.23%, respectively.

The Plan may cease contributions and participation in the contract by written notice to the issuer 90 days ahead of the contribution cessation date. The Plan will then elect a cessation option to transfer at contract value the holdings in the contract. The Plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer, and that also would limit the ability of the Plan to transact at contract value with the participants. These include but are not limited to premature termination of the contract by the Plan, plant closings, layoffs, Plan termination, bankruptcy, and mergers.

NOTE 5. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 and 29 CFR 2520.103-12(d) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the custodians of the Plan, have certified the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024; and related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 6. RELATED PARTY TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Plan Sponsor. The Plan Sponsor provides to the Plan certain accounting and administrative services for which no fees are charged. Fees paid during the year to third party administrators or trustees for services rendered by parties-in-interest were based on customary and reasonable rates for such services. These transactions qualify as exempt parties-in-interest transactions.

The Plan issues loans to participants, which are secured by balances in the participants' accounts. The Plan holds units in the Key Guaranteed Portfolio Fund, a General Account managed by Empower Annuity Insurance Company of America. These transactions qualify as exempt parties-in-interest transactions.

NOTE 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their accounts.

NOTE 8. TAX STATUS

The Internal Revenue Service (IRS) informed the Sponsor by a letter dated June 30, 2020, that the prototype adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401. Although the Plan has been amended since its adoption of the prototype plan for subsequent changes in applicable tax laws and regulations, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

NOTE 8. TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
