Opinion

NOTE 1 DESCRIPTION OF PLAN

The following description of the NGMEO Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Nyemaster Goode, P.C. (Plan Sponsor or Employer), as the plan sponsor, who have one year of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute a portion of their annual compensation, as defined in the Plan, on a pre-tax basis up to the maximum limitations imposed by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants also have the option to contribute post-tax compensation through Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. For the years ended December 31, 2024 and 2023, the employer contributed 100% of the first 6% of compensation that a participant (other than an associate attorney or law clerk) contributed to the Plan, and a fixed profit-sharing contribution (except for associate attorneys and law clerks) of 7% of compensation, plus 5.7% of compensation above the social security wage base. Additional profit-sharing contributions may be contributed at the option of the Plan Sponsor. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, the employer's contribution, and an allocation of Plan earnings or losses, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the employer's qualified matching contributions, plus actual earnings thereon. Vesting in the employer's discretionary profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service.

Investment Options

Upon enrollment in the Plan, a participant may invest in government securities, corporate bonds, common stock, a collective investment trust, partnership interests, shares of registered investment companies, pooled separate accounts, and other investment products offered by the investment or insurance company of their choice, provided the investments are readily tradable on an established market. Participants may change their investment options at any time.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance resulting from employer discretionary contributions. Loan terms range from 1-5 years or up to 10 years for the purchase of a primary residence. The loans are secured by the vested portion of the participant's account and bear interest at the Wall Street Journal prime rate + 1% at the time of the loan, which range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Distribution of Benefits

On termination of service a participant whose vested account balance exceeds \$1,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested account balance, or annual installments over specified times, not exceeding the life expectancy or joint life expectancy of the participant and/or the beneficiary or an annuity. A participant whose vested account balance does not exceed \$1,000 on termination date will receive his or her vested account balance as a lump-sum distribution.

The Plan allows for hardship withdrawals to participants who meet an immediate and severe financial need which are limited to certain portions of a participant's account balance, as defined in the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited unallocated nonvested accounts totaled \$54 and \$130, respectively.

The nonvested portion of a terminated participant's account balance will be forfeited and allocated to reduce the Employer's contributions for the Plan year in which the forfeiture occurs. During the years ended December 31, 2024 and 2023, forfeitures of \$5,460 and \$4,121, respectively, were used to reduce employer contributions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Money market accounts are valued at cost plus earnings. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the collective investment trust, mutual funds, and pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Notes Receivable from Participants (continued)

In accordance with the Plan document, loans are considered to be in default if any scheduled loan payment remains unpaid beyond the last day of the calendar quarter following the calendar quarter in which the participant missed the scheduled payment. Defaulted loans will be reported as taxable deemed distributions in the year in which default occurs. During the years ended December 31, 2024 and 2023, there were no such amounts reported in distributions to participants in the accompanying statements of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid. There were no amounts allocated to accounts of persons who had elected to withdraw from the Plan but had not yet been paid at December 31, 2024 or 2023.

Administration of Plan Assets

Certain administrative functions are performed by officers or employees of the Plan Sponsor. The amount of such expenses and cost of such services have not been determined. No such officer or employee receives compensation from the Plan. Other administrative expenses are paid directly by the Plan Sponsor and include audit fees.

Uncertain Tax Position

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has evaluated their material tax positions and determined there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 3 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2—Inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly, such as:

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes to the valuation methodologies used during the years ended December 31, 2024 and 2023.

Mutual funds—Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Participant-directed brokerage accounts—Participant-directed brokerage accounts consist of: (a) cash, money market funds, mutual funds, common and preferred stocks, exchange traded funds, and closed-end funds that are valued on the basis of readily determinable market prices; (b) corporate debt valued based on quoted prices in active markets; (c) pooled separate accounts valued based on the underlying investments comprising the funds; and (d) life insurance contracts valued based on cash value provided by the insurance company.

Collective investment trust—The collective investment trust is composed primarily of fully benefit-responsive investment contracts and is valued at the net asset value of units of the issuer's collective trust. While not publicly quoted, the net asset value is considered to have a readily determinable fair value.

Pooled separate accounts—Pooled separate accounts invest primarily in domestic and international long-term bonds, domestic and international stocks, or single mutual funds. The fair value of the underlying bonds, stocks, or mutual funds is a publicly quoted pricing input used in determining the net asset value (NAV) of the pooled separate accounts, which is not publicly quoted but is available to current investors when Plan participants access their account values via the custodian's website. Pooled separate accounts are deemed to have readily determinable fair values which are calculated on a daily basis and are actively traded within the Plan.

The following tables set forth by level within the fair value hierarchy the Plan's investments at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

NOTE 4 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 5 TAX EXEMPT STATUS

The Internal Revenue Service has determined and informed the Plan Sponsor by letter dated June 30, 2020, that the Plan and the related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since the request for a determination letter. However, because the Plan uses an approved prototype document, the Plan administrator and the Plan's management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

NOTE 6 RISKS AND UNCERTAINTIES

Participants invest their account balances in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments are shares of pooled separate accounts and a collective investment trust managed by Principal Life Insurance Company, the custodian of the non-brokerage account investments as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Trustees of the Plan are participants in the Plan. Employees of the Plan Sponsor participate in the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 8 SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through August 15, 2025, the date which the financial statements were available to be issued. There were no subsequent events which required accrual or disclosure.
