The disclosure of investments which represent 5% or more of total Plan net assets in Note 3 to the financial statements was derived by comparing the trustee's schedule of investments held at year end to the calculation of 5% of net assets available for benefits. It is considered to be a more sensitive disclosure as it is currently a specific disclosure required by the Department of Labor.

The disclosure of information certified by the trustee in Note 3 to the financial statements was derived from the certification statement and its reports attached thereto. The information was considered in determining the necessary audit procedures to apply to the certified and non-certified elements of the financial statements.

Note 1 – Description of the Plan

The following description of the Van Hook Service Co., Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide retirement benefits for employees of Van Hook Service Co., Inc. (the Company). The Plan also provides certain benefits in the event of death, disability, or other termination of employment. The Plan became effective on January 1, 1988, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

The Company is the plan administrator. Fidelity Management Trust Company (Fidelity) is the trustee of the Plan's assets and also provides record-keeping and other administrative services to the Plan. Fidelity is also the Plan's financial advisor, primarily providing investment management services to the Plan.

Eligibility

Employees who have attained 18 years of age and have completed three months of service are eligible to participate in the Plan. Employer non-elective contributions cannot be made to an eligible employee until they have attained 21 years of age and have completed at least one year of employment with 1,000 hours of service.

Participant Contributions

Participants may make tax-deferred contributions or after-tax (Roth) contributions to the Plan of up to 100% of their compensation, subject to statutory limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan includes an automatic enrollment feature whereby all employees are automatically enrolled in the Plan with a deferral rate of 6%, unless they choose not to participate or elect a different deferral percentage. In addition, participants may make rollover contributions to the Plan.

Employer Contributions

The Company may make discretionary matching contributions on behalf of participants that have made contributions during the plan year and are employed on the last day of the plan year. For participants that are employed on the last day of the plan year and have completed at least 1,000 hours of service during the plan year, the employer can also make Non-Elective contributions at their discretion.

Participant Accounts

Participants direct the investment of their accounts into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions, employer contributions, and actual earnings thereon. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and actual earnings/losses thereon. Employer contributions and actual earnings/losses thereon vest 20% after each year of service starting with the second year of service and are fully vested after six years. Participants with a frozen money purchase account balance become fully vested with less than one year of service.

Forfeitures

Forfeitures of non-vested account balances are first used to pay administrative expenses, and then subsequently used to reduce future employer contributions. During both of the years ended December 31, 2024 and 2023, there were no forfeited amounts used to reduce the employer's matching contribution.

Note 1 – Description of the Plan, Continued

Notes Receivable from Participants

Participants may borrow funds from \$1,000 up to the lesser of \$50,000, or one-half of their vested account balance. Loans must be repaid within 5 years, unless the participant takes a loan out for the purchase of their principal residence, in which case this extends to 10 years. The repayment requirement can be waived for a qualified leave of absence. Amounts borrowed are secured by the vested balance in the participant's account and bear interest at the prime rate plus 1%, which is 8.50% at December 31, 2024. Principal and interest are paid through bi-weekly payroll deductions.

Distribution of Benefits

Upon disability, death, retirement, or separation of service from the Company, a participant may elect to receive a lump sum payment or to have their account rolled over to another qualifying investment. The Plan may also make involuntary lump-sum distributions to terminated participants with vested account balances of \$5,000 or less. In-service withdrawals from the Plan are permitted from vested accounts by participants that have attained the age of 59 ½ or if the participant qualifies for a hardship withdrawal.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted under certain circumstances.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of plan termination, all participant accounts would become fully vested.

Plan Amendments

The Company made modifications to the Plan that were effective in the Summary Plan Description on September 1, 2024. These amendments did not significantly affect benefits and net assets during 2024.

Note 2 – Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the accompanying financial statements.

Benefit Payments

Benefits are recorded when paid.

Note 2 – Summary of Significant Accounting Policies, Continued

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in registered investment companies are reported at fair value as reported by the custodian. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Subsequent Events

Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

Note 5 – Tax Status

The Plan adopted a prototype plan document sponsored by Fidelity. An opinion letter was received by Fidelity from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the prototype plan satisfies the applicable provisions of the Internal Revenue Code. The Plan itself has not received a determination letter from the IRS. However, although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the accompanying financial statements.

Note 6 – Party-In-Interest Transactions

The Company is the Plan sponsor. As such, transactions between the Company and the Plan qualify as party-in-interest transactions. Transactions involving various service providers as well as notes receivable from participants also qualify as party-in-interest transactions.
