Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matters

NOTE 1 DESCRIPTION OF PLAN

The following brief description of Mack-UAW 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan established January 1, 1999, covering full-time employees of Mack Trucks, Inc. (the Company) who are represented by the International Union, UAW, and its Locals #171, #677, #1247, #2301, and #2420 and have seniority on or after January 1, 1999. The Plan has been amended throughout the years to comply with tax legislation and was most recently restated effective January 1, 2014, and most recently amended February 1, 2024. The Plan is subject to the provisions of ERISA, as amended. The Benefit Plans Committee is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Benefit Plans Committee.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) deferrals. Effective February 1, 2024, the Plan allows for Roth contributions. The Plan includes an auto-enrollment provision whereby all employees are automatically enrolled in the Plan upon hire at 3% of eligible compensation unless they affirmatively elect to either contribute an amount other than 3% or opt out of the Plan. Auto-enrollment deferral percentages will increase 1% each year up to a maximum of 6% unless another election is made. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participants may also make separate elections each Plan year to contribute from 10% to 75% of a cash payment (if received) from the Mack-UAW Profit Sharing Plan, from 10% to 75% of a ratification bonus, and from 10% to 75% of a lump sum bonus. Separate elections are required for each such election.

The Plan allows for Company matching contributions of 60% of the participant's 401(k) deferrals that do not exceed 6% of compensation for the Plan year. The Plan also allows for a 4% nonelective Company contribution. Employees are not required to be deferring to the Plan in order to receive this contribution. Effective January 1, 2024 through December 31, 2028, an additional annual \$1,000 employer contribution will be made for match eligible employees who are employed at least one year.

Only employees hired on or after June 1, 2009, are eligible for Company contributions.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Subject to certain eligibility requirements outlined in the Plan document, participant accounts are credited with the participant's contributions and the Company's contributions. Participant accounts are also credited with an allocation of Plan earnings and charged with an allocation of administrative expenses based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled to is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contributions portion of their accounts, plus actual earnings thereon, is based on years of vesting service. A participant vests 20% per year and is 100% vested after five years of vesting service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, upon death, or upon permanent disability.

Master Trust

Volvo Group North America, LLC (VGNA) has established Volvo Group North America, LLC Target Retirement Fund Trust (the Master Trust) for the Plan and other retirement plans of affiliates of VGNA. The purpose of the Master Trust is to pool investment transactions and achieve uniform rates of return on comparable funds under all the affiliated plans. The Plan deposits funds in the Master Trust and owns an undivided interest in the net assets of the Master Trust.

Notes Receivable from Participants

Participants may borrow from their vested account balances at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested balance. Notes are secured by the balance in the participant's account and bear interest at market rates. Principal and interest are paid ratably through payroll deductions.

Benefit Payments

Upon termination of service, death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution. If a participant terminated employment and the participant's account balance is less than \$1,000, the Plan administrator may authorize the benefit payment without the participant's consent. Participants may receive in-service distributions of their account when they attain age 59½. The Plan also allows for hardship withdrawals under the provisions of the IRC. The Plan also allows participants to receive certain transferred benefits in equal monthly installments over a period of up to 10 years.

Forfeited Accounts

Forfeited nonvested accounts are used to reduce future Company contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023 were approximately \$507,700 and \$51,900, respectively. Approximately \$180,000 of forfeitures were used to reduce Company contributions during the year ended December 31, 2024.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustees. See Note 5 for discussion of fair value measurements.

The Plan's investment in the Master Trust represents the fair value of the Plan's proportionate share of the underlying net assets of the Master Trust. The prorata share of investment income represents the Plan's proportionate share of total investment income of the Master Trust. Investment income includes recognition and allocation of interest income, dividend income, and realized and unrealized gains and losses, based upon each participating plan's share of the underlying net assets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Master Trust Investment Fund

The value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the trust plus actual contributions and allocated investment income less actual distributions and allocated administrative expenses. Investment income and administrative expenses relating to the Master Trust are allocated to individual plans based upon the amount of time the Plan's assets were invested in the Master Trust.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Benefit Payments

Benefit payments are recorded upon distribution.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investment presented in the accompanying statement of changes in net assets available for benefits.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through September 8, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

State Street Bank and Trust Company, the trustee of the Plan through August 31, 2024, has supplied the Plan administrator with a certification as to the completeness and accuracy of notes receivable from participants and investment information reflected on the accompanying statement of net assets available for benefits as of December 31, 2023, and the related investment activity reflected in the statement of changes in net assets available for benefits for the period from January 1, 2024 through August 31, 2024.

Empower Trust Company, LLC, the trustee of the Plan effective September 1, 2024, has supplied the Plan administrator with a certification as to the completeness and accuracy of notes receivable from participants and investment information reflected on the accompanying statement of net assets available for benefits as of December 31, 2024, the schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the period from September 1, 2024 through December 31, 2024.

NOTE 5 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included, within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Collective Trust Funds: Valued at the net asset value (NAV) of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions in and of ERISA. Participants should refer to the Plan agreement for a more complete description of Plan termination policies.

NOTE 8 PLAN TAX STATUS

The Plan is placing reliance on a determination letter, dated August 11, 2015, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by Empower Trust, Transamerica Retirement Solutions, and State Street Bank and Trust Company, the trustees and former trustees, respectively, as defined by the Plan, and therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 10 TRANSFERS WITH OTHER PLANS

Certain employees participating in retirement plans sponsored by subsidiaries of AB Volvo may transfer their employment from one subsidiary to another. Upon transferring employment, their retirement plan balances may also be transferred to a related subsidiary's plan. These transfers between plans are included in net transfers from affiliated plans on the statement of changes in net assets available for benefits.
