## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Trustees of  
United Medical Center 403(b) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of United Medical Centers 403(b) Employee Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about United Medical Centers 403(b) Employee Benefit Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedules Required by ERISA**

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**1. Description of Plan**

---

The following description of the United Medical Center 403(b) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all employees of the United Medical Center (the “Center”), except for employees who normally work less than 20 hours per week for the Center. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The type of plan is a 403(b) Plan with the Plan original effective date of January 1, 2009, and a year-end of December 31. The Company and/or Participants, in accordance with the Plan terms, can make Pre-Tax and Roth Deferral Contributions to the Plan. Employer contributions are increased by Elective Deferral through the employee’s W-2 wages. The Plan was restated January 10, 2010 and later amended February 27, 2020 to implement hardship distribution provisions of the bipartisan budget act of 2018.

**Contributions**

Participants may elect to make both pre-tax and Roth salary reduction contributions, subject to an annual limit of the lesser of 100% of the eligible compensation or statutory limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participant contributions may not exceed the limits established by Internal Revenue Service guidelines which were \$23,000 and \$22,500 for 2024 and 2023, respectfully. Participants who are at least age 50 or will attain age 50 before the end of a calendar year are eligible to defer additional amounts (“catch-up contribution”) to the Plan. The maximum catch-up contribution that an eligible participant can make was \$7,000 in 2024 and \$6,500 for 2023. Eligible employees may also contribute amounts representing distributions from other plans and certain IRAs. Participants direct the investment of their contributions into the various investment options offered by the Plan.

The Plan also allows the employer to make discretionary matching contributions. During 2024 and 2023, the employer made discretionary matching contributions equal to the sum of 100% of the first 6% of annual contributions made to the Plan by the participant. As a result, discretionary matching contributions in the amount of \$584,850 and \$453,969 were recorded for the years ended December 31, 2024 and 2023, respectively. Employer contributions are subject to certain statutory limitations.

**Contributions (Continued)**

Participants are eligible for the employer contribution upon completion of six months of employment service.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Center's contribution, if any, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants have a 100% vested interest at all times in their accounts attributable to elective deferrals, employee contributions, and rollover contributions. Participants' vesting in employer matching contributions are based on years of service as follows:

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balance and no less than \$500. The notes are secured by the balance in the participant's account and bear interest at rates determined by reviewing similar types of loans by other lenders (3.25% - 8.50%). Loan terms range from 1 to 5 years, or longer for the purchase of a primary residence. Principal and interest are paid through payroll deductions. Participants are limited by the Plan to only two loans outstanding at any given time.

**Investment Options**

Upon enrollment in the Plan, a participant directs both the participant and Center contributions in any or all of the investment options offered by the Plan. Participants may change their investment options at will.

**Payment of Benefits**

Vested benefits are paid to participants upon death, disability, retirement or termination of employment by either arranging for a rollover to another plan, lump sum payment, or installments. Hardship withdrawals are available and subject to certain limitations.

Additionally, upon attaining age 59 ½, a participant employed by the Center may elect certain in-service withdrawals from their vested account balance. For terminated participants' account balances that are less than \$5,000, the Plan administrator may distribute the entire amount in a lump sum without the participant's consent. If the participant's vested portion is greater than \$5,000, the participant may elect to maintain the vested portion in the Plan.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,546 and \$32,824, respectively. These accounts can be used to reduce employer contributions. During the Year Ended December 31, 2024, employer contributions were reduced by \$9,546 from forfeited nonvested accounts.

**Administrative Expenses**

The Plan Sponsor pays for certain direct Plan administrative and other expenses, but this is discretionary, and such expenses are excluded from these financial statements. Additionally, Plan Sponsor employees provide certain administrative duties at no charge to the Plan. At the Plan Sponsor's option, Plan administrative expenses may be paid by the Plan Sponsor or charged to the Plan and deducted from participant's individual accounts. Participants are charged directly for loan and distribution fees.

Certain fees are also paid through revenue sharing from Plan investments to Matrix Trust Company and the Plan's investment advisor and the third-party administrator, which are generally included in investment appreciation. For the years ended December 31, 2024 and 2023, the Plan paid \$29,447 and \$25,675, respectively, in administrative expenses.

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. No fully benefit responsive investments contracts are currently held by the plan as of December 31, 2024 or 2023 .

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reports amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The fair value of the above investments is disclosed further at Note 8.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded on the ex-dividend date on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowances for credit losses has been recorded.

**Notes Receivable from Participants (Continued)**

If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with corresponding reduction to contributions. There were no excess contributions in 2024 or in 2023.

**Payment of Benefits**

Benefits are recorded when paid.

**Terminated Employees with Vested Benefits**

As of December 31, 2024, terminated participants with vested balances in the amount of \$131,595 remains in the Plan. The benefit payments are not reflected in the financial statements until benefit claims have been processed and approved for payment.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to participant's account.

**Date of Management's Review of Subsequent Events**

Subsequent events were evaluated through October 6, 2025, which is the date the financial statements were available to be issued.

**3. Information Prepared and Certified by Custodians**

---

The following information, which Matrix Trust Company (Matrix) and CMFG Life Insurance Company (CMFG) have certified as complete and accurate, has not been subject to audit procedures:

- Investments in mutual funds, interest bearing cash, net appreciation (depreciation) in investments, and other investment income (Matrix)
- Notes receivable from participants and related interest income (CMFG)
- Information in the accompanying supplemental schedules (Matrix and CMFG)

---

**4. Tax and Plan Status**

---

The Internal Revenue Service has determined and informed the Center that the United Medical Center 403(b) Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the Plan's effective date, The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by tax authorities, however, there are currently no audits for any tax periods in progress.

---

**5. Plan Termination**

---

Although the Center had not expressed any intent to do so, the Center has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts and distributions would be made as soon as administratively practicable after the Plan terminates.

**6. Related-Party Transactions and Party-in-Interest Transactions**

---

Certain Plan investments are shares of mutual funds managed by Matrix Trust Company. Additionally, the cash received and applied to participant loans, loan activity, and loan balances is managed by CMFG Life Insurance Company. Matrix Trust Company and CMFG Life Insurance Company are the trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the custodial and record-keeping services amounted to \$29,447 for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**7. Risk and Uncertainties**

---

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the near-term could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

**8. Fair Value Measurements**

---

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Plan Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds including money market funds:* Reported at fair value based on quoted market price of the fund and classified within Level 1 of the valuation hierarchy, as of December 31, 2024 and 2023. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.
