Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Cambria Residential Services 403(b) Tax Deferred Annuity Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Cambria Residential Services 403(b) Tax Deferred Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

Effective January 1, 2009, the Plan was established for the purpose of providing the employees of Cambria Residential Services (the Organization) with an employee retirement savings program. The Plan is a 403(b) tax deferred annuity plan covering substantially all employees of the Organization. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute the maximum amount of pretax annual compensation, as defined in the Plan, not to exceed certain IRS limits. Participants who have attained age fifty (50) by the end of the plan year are eligible to make catch-up contributions. There is no service requirement for employees to make pretax contributions.

Effective August 1, 2018, the plan was amended to allow employer contributions. The Plan is funded through monthly contributions equal to ten percent (10%) of each eligible employee's compensation, not to exceed the maximum amount allowable under the Internal Revenue Service Code Section 404 and 415. Compensation is defined as regular base pay excluding overtime, bonuses and other earnings. It also includes contributions made by a salary reduction agreement with the Organization. All union employees covered under the Service Employees International bargaining agreement (the bargaining agreement) and non-union employees are permitted to receive employer contributions under the plan, except for those classified under the bargaining agreement as "regular part-time employees." In order to be eligible to receive employer contributions under the plan employees must have completed one (1) year of service with the Organization. A year of service is defined as a consecutive twelve (12) month period beginning on the day the employee first performs an hour of service in which the employee had at least one thousand (1,000) hours of service.

Participants may also contribute amounts representing distributions from other qualified plans.

Investment Options

The Plan is entirely participant-directed and, as such, upon enrollment in the Plan, a participant may direct contributions in any investment option offered in the Plan. Participants may change their investment options at any time. The Plan offers various pooled separate accounts as well as an investment contract with an insurance company.

Participant Accounts

Each participant's account is credited with (a) the participant's contribution, (b) employer contribution, (c) investment earnings, and (d) charged administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always one hundred percent (100%) vested in their voluntary contributions, rollover contributions, and any earnings thereon.

A participant becomes one hundred percent (100%) vested in employer contributions upon completion of three (3) years of vesting service.

Regardless of the number of years of service, a participant's account balance becomes fully vested when the participant reaches age fifty-five (55), becomes totally and permanently disabled, or dies.

Forfeitures

Forfeitures may be used to reduce future employer contributions. At December 31, 2024 and 2023, there were no forfeited non-vested account balances. Approximately \$1,141 of the forfeitures were used to fund employer contributions in 2024.

Notes Receivable from Participants

Participants may borrow from Mutual of America a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or fifty percent (50%) of their vested account balance. Loans are secured by the vested balance in the participant's account and are charged interest at a rate comparable to rates charged by area banks for similar loans. Loans must be repaid within five (5) years. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant will receive a distribution under the method of payment selected by the participant and permitted by the affected annuity contracts. All distributions are in the form of a qualified joint and survivor annuity unless an optional form of benefit payment is selected pursuant to a qualified election, as defined in the Plan agreement. If a participant's account balance is less than \$1,000, the balance is distributed in the form of a single lump sum. The Plan also maintains a provision for hardship withdrawals.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments in pooled separate accounts are measured at fair value on a recurring basis, based on the most current quoted market prices of the underlying investments. The Plan's investments in the guaranteed investment contract are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan is either credited or charged for the change in unit values of its pooled separate account. See Note 3 for fair value measurements and Note 4 for further information on the guaranteed investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Substantially all administrative expenses of the Plan are paid by the Organization.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

NOTE 3 FAIR VALUE MEASUREMENTS

The Plan performs fair value measurements in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, which defines fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance. ASC 820 also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy establishes three (3) levels of inputs that may be used to measure fair value:

- Level 1 – inputs are unadjusted quoted prices in active markets for identical assets or liabilities;
- Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, or 2023.

Pooled Separate Accounts: Valued at the close of each business day based on market value and expressed in units as determined by dividing the value of the entire account by the total number of units in the account.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statement of net assets available for benefits.

Investments Whose Fair Value is Calculated Using Net Asset Value Per Share

Separate accounts offered are proprietary to Mutual of America Life Insurance Company (Mutual) and mainly invest in underlying investment funds or portfolios offered by registered management investment companies. As such, Mutual calculates a daily unit value, based on the underlying market value of the investments. Mutual uses accumulation units to represent account values in each separate account fund and separately values the accumulation unit for each fund of the separate account. The account value in the separate account as of any valuation day is determined by multiplying the number of accumulation units credited in each fund of the separate account by the accumulation unit value of that fund at the end of the valuation day (generally at the close of the New York Stock Exchange). The changes in accumulation unit values for the separate account funds will reflect changes in the net asset values of the underlying fund and separate account charges under the contracts, with the annual rates calculated as a daily charge.

NOTE 4 INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds investments with Mutual of America Life Insurance Company within the insurance company's Interest Accumulation account totaling \$2,420,533 and \$2,437,389 as of December 31, 2024 and 2023, respectively. The Interest Accumulation account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Mutual of America. Mutual of America is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The investment in the Interest Accumulation account is considered to be fully benefit responsive; therefore, it is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Mutual, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

NOTE 5 RELIANCE ON INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual of America Life Insurance Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023
- Investment income as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024
- Investment information included in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA required supplemental schedule.

NOTE 6 TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The plan administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investments securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 RELATED PARTY TRANSACTIONS

Certain Plan investments are managed by Mutual of America Life Insurance Company, the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

NOTE 10 SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued. The plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
