Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Empower LGA, Inc. 403(b) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the Plan's financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 2 to the financial statements, the Plan has excluded from investments in the accompanying statements of net assets available for benefits (modified cash basis) certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits (modified cash basis). The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. The modified cash basis of accounting requires that these accounts and related income and distributions be included in the accompanying financial statements.

Emphasis of Matter - Basis of Accounting

We draw attention to Note 3 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 3, and for determining that the modified cash basis of accounting is an acceptable basis for the presentation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct audits of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue our auditor's report. However, because of the matters described in the *Basis for Disclaimer of Opinion* section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Other Matters

Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i) (Modified Cash Basis) as of December 31, 2024 and Schedule of Delinquent Participant Contributions (Schedule H, Line 4a) for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the *Basis for Disclaimer of Opinion* section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedules.

Note 1 - Description of Plan

The following description of the Empower LGA, Inc. 403(b) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that provides benefits to all employees of Empower LGA, Inc. (the "Company") as of their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Management is responsible for oversight of the Plan. The Plan administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's management.

Contributions

Each year, participants may contribute up to the maximum percentage of compensation and dollar amount permissible under Section 403(b) of the Internal Revenue Code ("IRC") not to exceed the limits of Code Section 402(g) and 415. Participants may designate all or a portion of their contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their accounts into various investment options permitted under the Plan.

In addition to the pre-tax contributions under the Plan, the Company may make discretionary nonelective contributions to the participants of the Plan, excluding drivers and highly-compensated employees. For the year ended December 31, 2022, the Company elected to calculate a discretionary nonelective contributions in six-month increments. The contribution will be calculated equal to the difference between (a) and (b) where (a) is 21% of each active participant's gross taxable income (including for this purpose 403(b) deferrals and Code Section 125 pre-tax reductions) less the sum of the participant's employer-paid employment taxes, allocable share of employer reserved amount for Massachusetts unemployment insurance, and employer-paid workers' compensation premium and (b) is the sum of employee-elected premiums for life, disability, and health insurance. Total contributions funded in 2024 related to contributions from 2022 was \$301,988. For the year ended December 31, 2023, the Company will contribute a safe harbor matching contribution equal to 3% of participants' eligible compensation, as defined, and certain employees are eligible to receive nonelective contributions. The employer contribution will be funded annually and contributions related to 2023 funded in 2024 were \$265,289. The Company will additionally contribute a discretionary matching contribution of 50% of participants' deferrals up to a maximum of 6% of eligible compensation, as defined, on a pay period basis. Total matching and safe harbor matching contributions funded during the year ended December 31, 2024 totaled \$130,007. Participants also direct the investment of all Company contributions. Contributions are subject to certain Internal Revenue Service ("IRS") limits.

Participant accounts

Each participant's account is credited with the participant's contributions plus any employer contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, employer nonelective contributions and safe harbor contributions plus their actual earnings. For employer matching contributions, vesting is based on credited years of service, as defined in the Plan, according to the following schedule:

<u>Years of service</u>	<u>Vested percentage</u>
1	25%
2	50%
3	75%
4	100%

In the event of termination due to death or total and permanent disability, participants shall become 100% vested in the Company matching contribution portion of their account.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested value of their account. The participant loans are secured by the balance in the participant's account and bear interest at the Moody's corporate bond yield average-monthly corporate rate as of the loan election date. Principal and interest are paid ratably throughout the note term.

Plan loans

Participants may borrow directly from Lincoln Financial Group ("Lincoln") and The Variable Annuity Life Insurance Company ("Valic"), subject to certain limitations. Such a loan, referred to as a Plan loan, is issued directly from funds owned by Lincoln or Valic and not from a participant's account. The loans are not shown in the Plan's statements of net assets available for benefits (modified cash basis) as the loans are not made from Plan assets and therefore are not considered assets of the Plan. Adequate security is required and a portion of the participant's account is reserved, or held in collateral, to cover 100% of the outstanding loan in case of default. Participants had outstanding Plan loan balances due to Lincoln of \$67,086 and \$68,709 and there were no loan balances due to Valic as of December 31, 2024 and 2023, respectively, which serve as collateral for the related loans, which are included in investments in the accompanying statements of net assets available for benefits (modified cash basis).

Payment of benefits

Upon termination of service for any reason, any participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or annuity distributions. A participant with an account balance of \$7,000 or less will receive a lump-sum distribution. Participants with an account balance greater than \$7,000 may elect to receive a single lump-sum amount, installment payments for a specified term or purchase of an annuity contract equal to the value of the participant's interest in his or her account.

Withdrawals from the salary deferral portion of a participant's account may be made in the event of a financial hardship, disability, qualified reservist distribution, or deemed severance distribution in accordance with the provisions specified in the Plan. Withdrawals from a participant's rollover account may also be made at any time in accordance with the provisions specified in the Plan. Additionally, in-service withdrawals are allowed in accordance with the provisions specified in the Plan for participants who have attained age 59½.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,391 and \$2,024, respectively. These forfeited balances will be used to reduce employer contributions or pay administrative expenses. During 2024, no forfeitures were used to offset employer contributions or pay plan administrative expenses.

Note 2 - Record retention

In November 2007, the U.S. Department of Labor (the "DOL") issued amended regulations eliminating an exemption granted to 403(b) plans from the annual Form 5500 reporting and disclosure requirements under Part I of Subtitle B of Title I of ERISA. Prior to the amended regulation, the Plan was not viewed as a separate reporting entity. Historically, the Plan was viewed as a collection of individual contracts with which participants could engage in a range of actions with limited involvement, if any, by the Plan Sponsor. Accordingly, various accounting records related to the Plan's 403(b) annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, were not sufficiently maintained by the Plan. Consequently, the financial statements and supplemental schedules have been prepared based on available records analyzed by Plan management. As certain records were not available from the inception of the Plan, the effect, if any, on the completeness and accuracy of the Plan's financial statements cannot be determined.

Note 3 - Summary of accounting policies

Basis of accounting

The financial statements of the Plan have been prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America ("U.S. GAAP"). The primary differences from financial statements prepared under U.S. GAAP arise from accounting for contributions and administrative expenses on the cash basis. Accordingly, the accompanying financial statements are not intended to be presented in conformity with U.S. GAAP.

Investments held by a defined contribution plan are required to be reported at fair value except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance companies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when received. Related fees are recorded as administrative expenses and are expensed when they are paid. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Payment of benefits

Benefits are recorded when paid.

Plan expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. Plan expenses of an insurer or mutual fund sponsor are charged to each annuity policy or custodial account in accordance with its terms.

Subsequent events

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

Mutual funds and money market fund: Valued at the daily closing price as reported by the fund. Mutual funds and the money market fund held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

Variable annuities: Valued at the NAV of accumulation units held by the Plan at year end. NAV, calculated daily, is applied to daily purchase and sale transactions in addition to being used to value ending market values. Accumulation units are valued using market quotations or independent pricing services to value securities and other instruments.

Pooled separate accounts: Valued using the net unit value, which is based on the fair value of the underlying assets of the account.

Cash surrender value from insurance product: Individual insurance policies that primarily consist of mutual funds that are valued on the basis of readily determinable market prices.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Note 5 - Fully benefit-responsive investment contracts

The Plan has interests in guaranteed annuity contracts with Security Benefit Life Inc. ("Security Benefit"), Lincoln and Voya Retirement Insurance and Annuity Company ("Voya"). These contracts meet the fully-benefit responsive investment contract criteria and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Security Benefit Life Inc.

The Security Benefit contract guarantees principal and a 1% minimum interest rate for all premiums remitted since 2006. The account also offers the opportunity for additional amounts in excess of the guaranteed rate. When declared, additional amounts remain in effect for the 12-month period that begins each quarter. Guaranteed interest is set on a quarterly basis. As of December 31, 2024, the crediting rate was set at 0.60%.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contracts is fully guaranteed by Security Benefit's General Account in the event that the assets are not sufficient to meet the Fixed Account obligations.

Lincoln Financial Group (group fixed annuity contract)

The Lincoln contract guarantees principal and a 3% minimum interest rate for all premiums remitted. The account also offers the opportunity for additional amounts in excess of the guaranteed rate. The annual interest rate for each year is declared in advance at the start of the calendar year. When declared, the interest rate remains in effect for a 12-month period. Guaranteed interest is set on a quarterly basis. As of December 31, 2024, the crediting rate was set at 3%.

The Plan's ability to receive principal and interest due in accordance with the fully benefit-responsive investment contract is fully guaranteed by The Lincoln National Life Insurance Company ("Lincoln National").

Voya Retirement Insurance and Annuity Company

The Plan holds a fixed annuity contract with Voya, an insurance company, referred to as the Voya Fixed Account. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.0%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Security Benefit reserves the right to, at the participant level: (1) limit the amount that may be subject to transfer of \$1,000,000 per transfer without home office approval; (2) limit transfers to six per contract year; and (3) prohibit transfers to any competing fund. Lincoln reserves the right to, at the participant level: (1) limit transfers to one per 30-day period and (2) limit cumulative transfers to 20% in any 365-day period.

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

As of December 31, 2024, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to amend or terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, each participant is entitled to his or her share of the Plan's net assets.

Note 7 - Tax status

The prototype plan document, which the Plan has adopted via a non-standardized adoption agreement, obtained its latest opinion letter dated June 30, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC.

Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, the Plan is qualified and deemed to be tax-exempt.

Note 8 - Party-in-interest transactions

Certain Plan investments are managed by New York Life Insurance and Annuity Corporation ("New York Life"), Security Benefit, Valic, Ameriprise Trust Company and RiverSource Life Insurance Company (an affiliate of Ameriprise Trust Company) (collectively, "Ameriprise"), Lincoln National, and Voya, the Plan's custodians. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. Indirect fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments. For the year ended December 31, 2024, fees incurred and paid directly by the Plan for related transactions were \$79,233. The Plan allows participants to take loans against their account balances, which are also considered exempt party-in-interest transactions.

Note 9 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and Schedule of Assets (Held at End of year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by New York Life, Security Benefit, Valic, Ameriprise, Lincoln National and Voya, the custodians of the Plan.

Note 10 - Risks and uncertainties

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

Note 11 - Nonexempt transactions

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), certain participant contributions were not remitted to the Plan within the time frame specified by DOL Regulation 29 CFR 2510.3-102 during the year ended December 31, 2024, thus constituting nonexempt transactions between the Plan and Company. The lost earnings corrective contribution was funded during 2024.
