Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the JF Martin Family Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C)(ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the JF Martin Family Corporation 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above, related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Responsibilities of Management for the Financial Statements

Notes To Financial Statements

Note 1 – Plan Description

The following description of the JF Martin Family Corporation 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan with a 401(k) provision. The Plan, established as of January 1, 2017, covers all employees of JF Martin Family Corporation, John F. Martin & Sons LLC, JFM Logistics LLC, and Martin’s Country Market LLC (the “Companies”). The Plan covers all employees of the Companies who have completed two months of service and have attained the age of 21 or older.

Eligible employees may enter the Plan on the 1st day of the month following completion of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Participants may contribute up to 100% of eligible compensation, not to exceed the annual amount permitted by Federal law. Catch-up contributions are permitted for eligible participants age 50 or older by the end of the calendar year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Companies may make discretionary matching contributions as determined by management. For the years ended December 31, 2024 and 2023, the Companies matched 50% of the first 4% of employee elective deferrals. The Companies made matching contributions of \$190,362 and \$201,409 for the years ended December 31, 2024 and 2023, respectively.

The Companies may also make a discretionary employer profit sharing contribution. No profit sharing contribution was made for either of the years ended December 31, 2024 and 2023. This discretionary contribution is allocated on an integrated basis to those eligible employees who have worked at least 1,000 hours during the Plan year and are employed by the Companies on the last day of the Plan year. Contributions are subject to certain limitations.

Participant Accounts – Each participant's account is credited with the participant's contribution and the participant's share of (a) the employer contributions, (b) an allocation of Plan earnings or losses based on the participant's directed investment accounts and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investments for their account.

Note 1 – Plan Description – Continued

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are vested in discretionary employer matching and profit sharing contributions plus actual earnings thereon based on years of continuous service:

Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years or more	100%

A participant is 100% vested after six years of credited service. Special vesting rules apply for participants who die or become disabled.

Years of vesting service earned before the employer maintained this Plan are excluded, except for employees that were active at the initial effective date of the Plan, January 1, 2017. These employees were grandfathered in and their years of vesting service earned before January 1, 2017 are included.

Payment of Benefits – Upon termination of service, a participant may elect to receive a lump-sum distribution equal to the vested value of his or her account. Automatic distributions will be made to terminated participants with vested balances less than \$5,000. The automatic distribution will be made to an individual retirement account (IRA) absent a distribution directive from the participant. If the terminated participant's vested balance exceeds \$5,000, a written request from the participant is required. A participant may also elect to have the amount rolled into an IRA account or another qualified plan. Hardship withdrawals are permitted from fully vested employee deferral accounts and any rollover contributions plus their earnings.

Forfeitures – Forfeitures shall be used first for payment of Plan expenses. Next, forfeitures will be used to reduce employer matching contributions. Afterwards, forfeitures will be used to reduce employer profit sharing contributions. Any remaining balance will then be allocated to participants. A participant is eligible for the allocation of forfeitures if they are eligible to participate in the Plan and have elected to make deferrals. The allocation is determined by eligible compensation of each participant in proportion to the total eligible compensation.

Forfeitures used to offset employer matching contributions and Plan expenses for the years ended December 31, 2024 and 2023 totaled \$15,309 and \$5,151, respectively. The balance in the forfeitures account was \$1,103 and \$1,196, as of December 31, 2024 and 2023.

Note 2 – Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared under the accrual basis of accounting.

Note 2 – Significant Accounting Policies – Continued

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value as determined and certified by the Plan's Trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – All administrative expenses will be paid by the Plan unless paid by the Companies. Certain administrative expenses associated with the Plan were paid by the Plan.

Subsequent Events – Events that occurred subsequent to December 31, 2024 have been evaluated by the Plan's management through August 28, 2025, which is the date the financial statements were available to be issued.

Note 3 – New Accounting Standards

Pronouncements issued by the Financial Accounting Standards Board (FASB) with future effective dates are either not applicable or are not expected to be significant to the Plan's financial statements.

Note 4 – Investments

During the years ended December 31, 2024 and 2023, the Plan's investments, including gains and losses on investments bought, sold, and held during the year, appreciated in value by \$350,108 and \$306,423, respectively.

Note 5 – Fair Value Measurements

Generally accepted accounting principles in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at quoted market prices, which represent the net asset value (“NAV”) of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 – Plan Termination

Although they have not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination or partial plan termination, affected participants will become 100 percent vested in their accounts.

Note 7 – Parties-In-Interest Transactions

Professional Capital Services, the record keeper of the Plan, provided record keeping services to the Plan. Fees paid by the Plan for these services totaled \$13,816 and \$13,868 for the years ended December 31, 2024 and 2023, respectively.

Note 8 – Tax Status

The Companies adopted a prototype non-standardized profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The prototype has been amended since receiving the determination letter for various amendments. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan continues to be tax-exempt. Therefore, no provisions for income taxes are included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and the Department of Labor. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023 there are no uncertain tax positions taken or expected to be taken that would require a recognition of a liability or asset disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10 – Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
