### **NOTE 1      DESCRIPTION OF THE PLAN**

The following description of the U.S. Facilities, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of U.S. Facilities, Inc. (the Company) who have attained the age of 21 and who have completed three months and one hour of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Each year, participants in the Plan may contribute at least 1% up to 80% of pretax compensation, as defined by the Plan, limited to the maximum contribution allowable under the Internal Revenue Code (IRC). Effective January 1, 2016, the Plan was amended to exclude employee bonuses from eligible compensation. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Effective January 1, 2024, the Plan was amended to allow for both pre-tax and after-tax contributions, via a Roth deferral option. The Plan also provides for a Company matching contribution equal to 100% of the first 3% of the participant's deferral contribution, then 50% up to the next 2% of the participant's deferral contribution, for a maximum matching contribution of 4%. Effective January 1, 2010, the Plan elected a Safe Harbor matching contribution. Participants direct all contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### Participant Accounts

Each participant's account is credited with his or her contributions and allocations of (a) the Company's contribution and (b) the Plan's earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is as follows: 20% after one year of service, 40% after two years of service, 60% after three years of service, 80% after four years of service, and 100% after five years of service. Participants are immediately 100% vested in the Safe Harbor contribution.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000, or 50%, of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates as of December 31, 2024 range from 4.25% to 9.50%. Participants may not have more than one outstanding loan at any given time. Terms range from one to five years unless the loan is used for the purchase of a primary residence. Terms for the purchase of a primary residence may not exceed 10 years.

#### Payment of Benefits

On termination of service for any reason, a participant is eligible to receive a distribution of their vested account balance. The normal form of benefit payment is a lump-sum distribution. For vested account balances over \$5,000, a participant may elect to receive their benefit payments over a period not to exceed the life expectancy of the participant or beneficiary. The Plan also provides for in-service withdrawals for hardships.

#### Forfeited Accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account balances is forfeited. Forfeitures can be used to offset Plan administrative fees or Company matching contributions. At December 31, 2024 and 2023, available forfeited nonvested accounts totaled \$5,404 and \$121,003, respectively. During 2024, \$4,116 was used to pay administrative expenses of the Plan.

### **NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES *(continued)*

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are recorded as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

#### Payment of Benefits

Benefits paid to participants are recorded when paid.

#### Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through October 7, 2025, the date the financial statements were available to be issued. The Plan identified no subsequent events that would require recognition or disclosure in the financial statements.

**NOTE 3 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Money market fund* is valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

*Mutual funds* are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust fund* includes a stable value fund valued at the NAV of units of the collective trust. The NAV is calculated by the fund based on net assets, which includes fully benefit-responsive investment contracts at contract value. The NAV represents the Plan's fair value since this is the amount at which the Plan transacts with the fund and is used as a practical expedient to estimate fair value. There are no unfunded commitments or redemption restrictions related to the collective trust fund.

Although it has not expressed any such intent, the Company has the right to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 5 TAX STATUS**

The Company adopted a non-standardized prototype plan Safe Harbor and Profit Sharing Plan (the Prototype Plan) with CODA (cash or deferred arrangement). The IRS determined and informed the Prototype Plan author by letter dated June 30, 2020, that the Prototype Plan was acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to the applicable statute of limitations.

**NOTE 6 RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain of the Plan's investments are managed by Fidelity Management Trust Company (Fidelity), the trustee and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment manager services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**NOTE 7 INFORMATION CERTIFIED BY TRUSTEE**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Fidelity, the trustee, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule H, Line 4(i)—schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**NOTE 8        RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities that are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term. The changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

**NOTE 9        ADMINISTRATION OF PLAN ASSETS**

The Plan's assets are administered under a contract with Fidelity, the trustee of the Plan. The trustee invests funds received from contributions, investment sales, interest, and dividend income and makes distribution payments to participants.

### **NOTE 1      DESCRIPTION OF THE PLAN**

The following description of the U.S. Facilities, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of U.S. Facilities, Inc. (the Company) who have attained the age of 21 and who have completed three months and one hour of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Each year, participants in the Plan may contribute at least 1% up to 80% of pretax compensation, as defined by the Plan, limited to the maximum contribution allowable under the Internal Revenue Code (IRC). Effective January 1, 2016, the Plan was amended to exclude employee bonuses from eligible compensation. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Effective January 1, 2024, the Plan was amended to allow for both pre-tax and after-tax contributions, via a Roth deferral option. The Plan also provides for a Company matching contribution equal to 100% of the first 3% of the participant's deferral contribution, then 50% up to the next 2% of the participant's deferral contribution, for a maximum matching contribution of 4%. Effective January 1, 2010, the Plan elected a Safe Harbor matching contribution. Participants direct all contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### Participant Accounts

Each participant's account is credited with his or her contributions and allocations of (a) the Company's contribution and (b) the Plan's earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is as follows: 20% after one year of service, 40% after two years of service, 60% after three years of service, 80% after four years of service, and 100% after five years of service. Participants are immediately 100% vested in the Safe Harbor contribution.

### NOTE 1 DESCRIPTION OF THE PLAN *(continued)*

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000, or 50%, of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates as of December 31, 2024 range from 4.25% to 9.50%. Participants may not have more than one outstanding loan at any given time. Terms range from one to five years unless the loan is used for the purchase of a primary residence. Terms for the purchase of a primary residence may not exceed 10 years.

#### Payment of Benefits

On termination of service for any reason, a participant is eligible to receive a distribution of their vested account balance. The normal form of benefit payment is a lump-sum distribution. For vested account balances over \$5,000, a participant may elect to receive their benefit payments over a period not to exceed the life expectancy of the participant or beneficiary. The Plan also provides for in-service withdrawals for hardships.

#### Forfeited Accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account balances is forfeited. Forfeitures can be used to offset Plan administrative fees or Company matching contributions. At December 31, 2024 and 2023, available forfeited nonvested accounts totaled \$5,404 and \$121,003, respectively. During 2024, \$4,116 was used to pay administrative expenses of the Plan.

### NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES *(continued)*

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are recorded as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

#### Payment of Benefits

Benefits paid to participants are recorded when paid.

#### Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through October 7, 2025, the date the financial statements were available to be issued. The Plan identified no subsequent events that would require recognition or disclosure in the financial statements.

**NOTE 3 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Money market fund* is valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

*Mutual funds* are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust fund* includes a stable value fund valued at the NAV of units of the collective trust. The NAV is calculated by the fund based on net assets, which includes fully benefit-responsive investment contracts at contract value. The NAV represents the Plan's fair value since this is the amount at which the Plan transacts with the fund and is used as a practical expedient to estimate fair value. There are no unfunded commitments or redemption restrictions related to the collective trust fund.

Although it has not expressed any such intent, the Company has the right to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 5 TAX STATUS**

The Company adopted a non-standardized prototype plan Safe Harbor and Profit Sharing Plan (the Prototype Plan) with CODA (cash or deferred arrangement). The IRS determined and informed the Prototype Plan author by letter dated June 30, 2020, that the Prototype Plan was acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to the applicable statute of limitations.

**NOTE 6 RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain of the Plan's investments are managed by Fidelity Management Trust Company (Fidelity), the trustee and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment manager services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**NOTE 7 INFORMATION CERTIFIED BY TRUSTEE**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Fidelity, the trustee, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule H, Line 4(i)—schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**NOTE 8        RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities that are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term. The changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

**NOTE 9        ADMINISTRATION OF PLAN ASSETS**

The Plan's assets are administered under a contract with Fidelity, the trustee of the Plan. The trustee invests funds received from contributions, investment sales, interest, and dividend income and makes distribution payments to participants.
