#### **1. Description of the Plan**

The following description of the A & P Technology, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

##### General

The Plan, as amended, is a defined contribution plan covering all eligible employees of A&P Technology, Inc. (the Company) who are age 21 and older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Investment Committee is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

##### Contributions

Each year, participants may contribute up to 90% of pre-tax or after-tax compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company matches 100% of participant contributions up to \$1,000 per participant. The Company may also make discretionary nonelective contributions. If made, discretionary non-elective contributions are allocated among eligible participants employed on the last day of the Plan year. There were no discretionary non-elective contributions made during 2024 or 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

##### Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined, and the participant's selection of investments. The participants direct the investment of their account balances among certain investment options offered by the Plan. The Company's contributions are invested in accordance with the participant's investment selection.

##### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account plus actual earnings thereon is based on years of continuous service. The Plan follows a six-year graded vesting schedule in which a participant is 100% vested after six years of credited service.

##### Payment of benefits

Upon termination of service due to death, disability or retirement, a participant whose account balance exceeds \$5,000 may elect to receive either a lump-sum amount equal to the value of his or her account, or a partial distribution. Upon termination, a participant whose account balance is between \$1,000 and \$5,000 may elect to take a lump sum distribution, or, if no election is made, the account will automatically be rolled over to an IRA selected by the Plan Administrator. If the total balance in the account upon termination is \$1,000 or less, the entire balance will be automatically distributed to the participant in a lump-sum. In addition, hardships and in-service distributions are permitted if certain criteria are met.

#### 1. Description of the Plan (Continued)

##### Forfeitures

Forfeitures are created when participants terminate employment before becoming fully vested in certain nonelective Company's contributions. Forfeited amounts may be used to reduce Company's contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$400 and \$547, respectively. During 2024, Company contributions and Plan expenses of \$11,744 were paid from forfeited nonvested accounts.

#### 2. Summary of Significant Accounting Policies

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

##### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 4).

The Plan presents in the statement of changes in net assets available for benefits, the net investment gain from common/collective trust, which consists of interest, dividends, realized gains or losses and unrealized appreciation on that investment. The Plan also presents in the statements of changes in net assets available for benefits, the net investment gain from registered investment companies, which consists of realized gains or losses and unrealized appreciation (depreciation) on those investments. Purchases and sales of securities are reflected on a trade-date basis. Interest is recorded on the accrual basis and dividend income is recorded on the ex-dividend rate. Capital gain distributions are included in dividend income.

##### Payment of Benefits

Benefits are recorded when paid.

##### Payment of Expenses

All expenses of administration may be paid out of the Plan unless paid by the Company. Such expenses shall include any expenses incident to the functioning of the administrator, including, but not limited to, fees of accountants, counsel, and other specialists and their agents, and other costs of administering the Plan. Until paid, the expenses shall constitute a liability of the Plan. However, the Company may reimburse the Plan for any administration expenses incurred. Any administration expenses paid to the Plan as a reimbursement shall not be considered Company's contributions. The Company elected to pay some administration expenses incurred in 2024 and 2023.

#### 3. Risks and Uncertainties

The Plan invests in various investment options. These investment options are exposed to risks, such as interest rate, credit and market risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### 4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan utilizes a three-level fair value hierarchy that prioritizes the inputs used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and lowest priority to unobservable inputs. The three levels of inputs used to measure fair value under this accounting standard are described as follows:

- Level 1 - Quoted prices in active markets that are accessible at the measurement date for identical assets or liabilities.
- Level 2 - Observable inputs other than quoted prices included within Level 1. Inputs that are principally derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value measurement of the assets or liabilities. These include certain pricing models, discounted cash flow methodologies and similar techniques that use significant unobservable inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies the Plan used for assets measured at fair value.

Common/collective trust: Valued at the net asset value (NAV) of units of the common/collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the investment will be sold for an amount different from the reported net asset value. Transactions (purchases and sales) may occur daily.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. The funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

#### **6. Tax Status**

The Company adopted a non-standardized, pre-approved profit sharing plan which received a favorable opinion letter from the IRS dated June 30, 2020. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has since been amended. Since receiving the letter, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **7. Plan Termination**

While the Company has not expressed any intent to terminate the Plan, it is free to do so at any time. Upon termination of the Plan by the Company, the accounts of the affected participants shall become fully vested, and assets remaining in the fund after payment of appropriate expenses shall be distributed to participants in proportion to their respective account balances.

#### **8. Related Parties and Parties-In-Interest**

Certain Plan investments are managed by Fidelity Investments, an affiliate of the Trustee. Any purchases and sales of these investments are open market transactions at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

During 2024, fees paid by the Plan to parties-in-interest for investment advisory, recordkeeping, and administrative services totaled \$19,179.

#### **9. Subsequent Events**

The Plan's management evaluated the activity of the Plan through September 30, 2025 (the date the financial statements were available to be issued) and concluded that no subsequent events have occurred that would require recognition in the financial statements or disclosure in the notes to the financial statements.
