Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of ProMinent Fluid Controls, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1 – Description of Plan

The following description of the ProMinent Fluid Controls, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering substantially all full-time employees of ProMinent Fluid Controls, Inc. (the “Company”) who have met the plan participation requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions – Each year, participants may contribute up to the maximum amount allowed by law of their pre-tax annual compensation, as defined in the Plan, or as a post-tax Roth deferral. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations. The aggregate contributions to each participant account may not exceed \$69,000 (\$76,500 including catch-up contributions) and \$66,000 (\$73,500 including catch-up contributions) for the years ended December 31, 2024 and 2023, respectively. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts and a deferred annuity contract as investment options for participants.

Participant 401(k) Deferral

Eligibility and Participation – Employees are deemed eligible for participation in the Plan immediately upon hire. Entry into the Plan is the date eligibility requirements are met.

Effective January 1, 2023, the Plan features an automatic contribution arrangement in which an eligible participant will automatically defer 6% of included compensation for each payroll period, unless the eligible participant makes a contrary salary reduction agreement election on or after a 30-day notification. The Plan’s automatic contribution arrangement also includes a feature in which the automatic deferral will increase by 1% of compensation up to a maximum of 6% of compensation, scheduled to occur as of January 1st of each Plan year.

Participant Contributions – Participants may elect to contribute up to 100%, in whole percentage increments, of their compensation, as defined, as a pre-tax or post-tax Roth contribution up to the limits established by the Internal Revenue Service (“IRS”) of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants may direct their contributions or reallocate their account balance quarterly into one of the investment options offered. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Discretionary Employer Contribution

Eligibility and Participation – Employees are deemed eligible for participation in the Plan immediately upon hire. Entry into the Plan is the date eligibility requirements are met.

Company Contributions – Company contributions to the Plan are discretionary and are determined by the Investment Committee. Discretionary contributions are based on the eligible employee's annual compensation earned while a participant in the Plan and may be in the form of a percentage match of the participant deferral or as a profit sharing-component based on Company earnings, or as a combination of both. The Company elected to match participant deferrals at a rate of \$0.50 for every \$1.00 of the participants' deferral for 2024 and 2023, up to 6% of the participant's compensation. ERISA guidelines limit maximum compensation to \$345,000 and \$330,000 for the years ended December 31, 2024 and 2023, respectively.

Profit Sharing Contribution

Eligibility and Participation – Employees are deemed eligible to share in the profit sharing contribution if they have completed at least 1,000 hours of service during the Plan year and are employed on the last day of the Plan year and, or, regardless of service time in the year of the employee's death, disability, or retirement.

Company Contributions – Each year, the Company may make a discretionary profit sharing contribution to the Plan. The profit sharing contribution will be allocated to the participant's account in the same proportion that the participant's compensation plus compensation in excess of \$30,000 (called "excess compensation") bears to the total compensation plus "excess compensation" of all eligible participants. However, the maximum amount which can be allocated to a participant in this first step is 4.3% of their compensation plus their "excess compensation". If the "excess compensation" dollar amount in the immediately preceding step is less than 20% or more than 80% of the Social Security Taxable Wage Base, the maximum percentage in the immediately preceding step will be adjusted to 5.7% or 5.4%, respectively. If after the first step of the allocation process there still remains a portion of the contribution which has not yet been allocated, then the remainder will be allocated to the participant in the same proportion that the participant's compensation bears to the total compensation of all participants. The Company did not declare a profit sharing contribution for each of the years ended December 31, 2024 and 2023.

Forfeitures – Forfeitures of non-vested accounts can be used to pay administrative expenses or can be applied to reduce the Company contribution. Forfeitures from all participants that terminated employment before they became fully vested, in respect to their mandatory account balance, amounted to \$35,800 and \$8,183 and for the years ended December 31, 2024 and 2023, respectively. The Company applied accumulated forfeitures of \$30,041 and \$8,183 against their employer contribution into the Plan for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts – Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's discretionary contribution and (b) earnings of participants' self-directed investments and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are vested immediately in their voluntary contributions, plus actual earnings thereon. Vesting in the Company’s discretionary contribution, plus actual earnings thereon, is based on years of service under a graduated vesting schedule listed below, whereby a participant is 100% vested after six years of credited service.

Notes Receivable from Participants – Participants may borrow from their combined vested 401(k) and discretionary funds accounts a minimum of \$1,000, up to a maximum equal to the lesser of 1) \$50,000 or 2) 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at prime (7.50% and 8.50% as of December 31, 2024 and 2023), respectively plus 1.0%. Principal and interest are both paid ratably through payroll deductions.

Payment of Benefits – Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments for a specific period of time. For termination of service for other reasons, a participant may receive the value of their vested interest in his or her account as a lump-sum distribution of their entire vested account balance, a single-sum distribution of a portion of their vested account balance, or installments for a specific period of time. Participants with vested account balances of \$7,000 or less will receive a lump-sum distribution. Those participants with vested account balances in excess of \$7,000 may elect a single-sum distribution for a portion of the vested account balance, a lump-sum distribution of the entire vested portion, or installments for a specified period.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan have been prepared using the accrual method of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition – Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in mutual funds are recorded at fair value based on the funds' reported closing net asset values as of the last business day of the year, times the number of shares held by the Plan. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants – Participant loans are reported as a separate line item titled "Notes Receivable from Participants" on the Statement of Net Assets Available for Benefits, and are measured at unpaid principal, plus accrued interest. The Plan is required to report interest income from notes receivable from participants separately from investment income on the Statement of Changes in Net Assets Available for Benefits. However, the Department of Labor still requires Notes Receivable from Participants to be reported as Participant Loans on Schedule H, Line 4i of Form 5500. As such, this presentation is used in the Supplemental Schedule included with the financial statements.

Benefits Paid to Participants – Benefits are recorded when paid.

Administrative Expenses – Certain administrative expenses of the Plan totaling \$43,762 and \$38,401 during the years ended December 31, 2024 and 2023, respectively, were paid by the Company and are not reflected in the accompanying financial statements, and are not considered an employer contribution.

Use of Estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Note 3 – Information Prepared and Certified by Custodian

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements and the supplemental schedules that are prepared by or derived from information provided by American United Life Insurance Company, a OneAmerica Financial Partner, custodian of the Plan's assets and furnished to the Plan administrator. The Plan administrator has obtained certifications from the custodian that such information is complete and accurate.

All investment and investment income information is noted within Note 4.

All information included is located within the supplemental schedule.

Note 4 – Fair Value Measurements

The Plan reports investments at fair value. Market price observability is impacted by a number of factors, including the type of investment, the characteristics specific to the investment, and the state of the marketplace (including the existence and transparency of transactions between market participants). Investments with readily-available, actively-quoted prices, or for which fair value can be measured from actively quoted prices in an orderly market, will generally have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value.

Investments measured and reported at fair value are classified and disclosed in one of the following categories based on inputs:

Level I – Quoted prices are available in active markets for identical investments as of the reporting date. The type of investments which would generally be included in Level I include listed equity securities and listed derivatives. The Plan, to the extent that it holds such investments, does not adjust the quoted price for these investments, even in situations where the Plan holds a large position and a sale could reasonably impact the quoted price.

Level II – Pricing inputs are observable for the investments, either directly or indirectly, as of the reporting date, but are not the same as those used in Level I. Fair value is determined through the use of models or other valuation methodologies. The types of investments which would generally be included in this category include publicly-traded securities with restrictions on disposition, debt securities and partnerships that hold Level I assets and real estate held for investment if measured by a current appraisal.

Level III – Pricing inputs are unobservable for the investment and include situations where there is little, if any, market activity for the investment. The inputs into the determination of fair value require significant judgment or estimation by the Plan. The types of investments which would generally be included in this category include debt and equity securities issued by private entities, and real estate held for investment if measured using management estimates.

Note 4 – Fair Value Measurements – Continued

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, the determination of which category within the fair value hierarchy is appropriate for any given investment is based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the investment.

The Plan's investments are in variable investment accounts, or "pooled separate accounts", which are considered Level 2 investments. Amounts allocated to a variable investment account within an American United Life Insurance Company ("AUL") separate account are credited to a participant's account in the form of accumulation units. The value of an accumulation unit of any investment account is determined at the close of each business day and is directly related to the net asset value of the shares of the underlying investment adjusted for any dividends or distributions received by AUL and the daily equivalent of any fee charged by AUL pursuant to the contract. Each investment account is invested by AUL exclusively in shares of a specific mutual fund or other investment entity as directed by the contract holder and/or participant.

The Plan has a deferred annuity contract with AUL that invests contributions in the Stable Value Account. The fund is an interest-earning investment option, backed by AUL's general account assets. An interest rate is declared prior to the beginning of the calendar year and is guaranteed for that year until the new rate is set for the next year. The interest rate was declared to be 2.00% and 1.25% for the years ended December 31, 2024 and 2023, respectively.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the deferred annuity contract since the contract was determined to be fully benefit-responsive. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

- (a) amendments to the Plan document (including complete or partial Plan termination or merger with another plan),
- (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions,
- (c) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or
- (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

Note 5 – Party-In-Interest Transactions

Certain Plan investments are shares of pooled separate accounts managed by American United Life Insurance Company as the prototype sponsor of the Plan. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services were netted against net appreciation or depreciation in fair value of investments during the years ended December 31, 2024 and 2023.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

Note 7 – Tax Status

The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Note 7 – Tax Status – Continued

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in process.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 – Subsequent Events

Management has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued, and determined that no material subsequent events have occurred that would require recognition in the financial statements.
