Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of GIIR America Inc. 401(K) Profit Sharing Plan, (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. (1) Description of the Plan

a) General

The Plan, effective January 1, 2018, is a defined contribution plan covering eligible employees of GIIR America Inc. (the “Employer” or the “Company”). The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the information certified by the Trustee, as complete and accurate, except for comparing the information certified by the Trustee to information included in the financial statement.

b) Eligibility

Employees are generally eligible to participate in the Plan on the first day of the month, following completion of 90 days of service as defined by the Plan. In case of employees transfers from an affiliate, a digital production department lead, or a manager for special programs in the ecommerce business department, 90 days of service requirement is waived. Non-resident alien employees who have no U.S. source of earned income are not eligible to participate in the Plan.

c) Contributions

Employee - Eligible employees are permitted to make combined pre-tax and Roth after tax contributions at a rate of up to 100% of employees’ compensation each year. However, employee's total deferrals in any taxable year may not exceed a dollar limit by the Plan, and subject to Internal Revenue Code (the Code) limitations on deferral contributions of \$23,000 for 2024. Participants aged 50, or older or who will turn 50 during the plan year are allowed to make additional pretax catch-up contributions up to a maximum of \$7,500 for 2024. The maximum catch-up contribution may be indexed each year for inflation. Effective January 1, 2018, the plan permits participants to make Roth 401(k) contributions, Roth rollovers, and in-plan Roth conversions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer - The Employer reserves the right to make a discretionary matching contribution to participants’ accounts. The Employer shall contribute to the Plan up to 3% of compensation and plus 50% of salary deferrals between 3% and 5% of compensation as part of the safe harbor provision. The profit-sharing contribution, which is allocated annually, also can be made to all eligible employees at the Employer discretion.

Each year, the employer may make a discretionary profit-sharing contribution to the employees’ account. A profit-sharing contribution was not made for 2024.

d) *Participants' Accounts*

Each participant's account is credited with the participant's deferral contribution, allocations of the Company's matching contributions, allocations of Company discretionary contributions, participant forfeitures and Plan earnings, and charged with withdrawals, allocation of Plan losses and administrative expenses. Earnings are allocated to each participant's account based on the share of the investment fund they each own at a given period of time.

e) *Investments*

Participants direct the investment of their contributions into various investment options offered by the Plan. Company matching contributions are automatically invested in the same funds as the participant contributions.

f) *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of participant's vested interest in the Plan, whichever is less.

The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 2%. Interest rates on outstanding participant loans ranged from 5.25% to 10.50% with maturities through 2029 as of December 31, 2024. Loans are to be paid in no later than five years, except for loans made for the purchase of a principal residence in which case the term of the loan can be longer than five years.

g) *Vesting*

Participants' contributions and employer's safe harbor contributions are 100% vested immediately in their contributions plus actual earnings thereon. Employer matching and profit-sharing contributions are vested as following schedule.

h) *Forfeited Accounts*

Forfeited balances of terminated participants may be used to reduce future Employer matching contributions or to pay certain Plan expenses. As of December 31, 2024 and 2023, the forfeited balances were \$39,294 and \$2,241 respectively.

i) Payment of Benefits

On termination of services due to death, disability or retirement, a participant may elect to receive a distribution amount equal to the value of the participant's interest in his or her account or a series of installments (as defined by the Plan). Participants with a vested account balance equal to or less than \$5,000 are immediately distributed as a lump-sum under the terms of the Plan, without the participant's consent, unless the participant has made a timely rollover election to an Individual Retirement Account or other qualified arrangement. In times of financial hardship, the funds in the participant's account are available for withdrawal if a condition is satisfied in terms of emergency medical care, principal for a residence, and educational fees. Such withdrawals may be subject to tax as ordinary income.

(2) Summary of Significant Accounting Policies

a) Basis of Presentation

The accompanying financial statements are prepared in conformity with accounting principles generally accepted in the United States of America ("GAAP").

b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c) Risks and Uncertainties

The Plan provides for the various investment options as described in Notes (1), (3) and (4). Any investment is exposed to various risks, such as interest rate, market, and credit risks. These risks could have a material effect on the participant's account balance and the amounts reported in the statements of net assets available for benefits.

d) Investment Valuation

The Plan's investments are stated at contract value. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year-end, which are based on quoted market values and the terms defined under the benefit-responsive group annuity contract described in Note (4). Purchases and sales of securities are recorded on a trade-date basis.

e) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis.

f) Administrative Expenses

The Plan's expenses are paid by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as benefits paid to participants in the accompanying statement of changes in net assets available for benefits.

(3) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) Topic 820, "Fair Value Measurements and Disclosures", establishes a framework for measuring fair value. That framework provides a fair value hierarchy that requires assets and liabilities measured at fair value to be categorized into one of the three levels based on the priority of inputs used in the valuation. Assets and liabilities are classified in their entirety based on the lowest level of input significant to the fair value measurement. The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset's and liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value pursuant to the fair value hierarchy:

Money market fund: Valued at the net asset value (NAV) as reported at year-end.

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. The value is based on the quoted market prices of the underlying shares owned by the fund, minus its liabilities, then divided by the number of shares outstanding.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(4) Investment Contract with MassMutual Life Insurance Company

The Plan has a benefit-responsive group annuity contract with Massachusetts Mutual Life Insurance Company (MassMutual). MassMutual maintains the contributions in a separate account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The average yield and crediting interest rates were 2.80% for the year ended December 31, 2024.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by MassMutual, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to the following: (1) temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor's business; (5) removal from the Plan of one or more groups or classifications of participants; (6) partial or complete Plan termination; or (7) Plan disqualification. Plan administration believes the occurrence of such events that would limit the Plan's ability to transact at contract value is not probable.

(5) Income Tax Status

The Internal Revenue Service has determined and informed the Company that the Plan and related trust, the Company adopted, are designed in accordance with applicable sections of the Internal Revenue Code (IRC) by a letter originally dated March 31, 2014. Although the Plan has been amended since receiving the opinion letter at November 30, 2020, the Plan administrator and the Company believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or derecognize an asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator believes that there are no uncertain tax positions that would have a material impact on the financial statement of the Plan. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2021.

(6) Plan Termination

Although it is intended to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. If terminated, no further contributions will be made to the Plan and all amounts credited to participants' accounts will become 100% vested. The distribution will be directed to employees' accounts in a manner permitted by the Plan as soon as practicable.

(7) Related Party and Party-in-Interest Transactions

Empower Annuity Insurance Company of America ("Empower") serves as a recordkeeper. Fees paid by the Plan to Empower Annuity Insurance Company of America for certain recordkeeping and administrative services for the year ended December 31, 2024, amounted to \$3,096.

The Plan issues loans to participants, which are secured by the balances in the participants' accounts and therefore, these transactions qualify as party-in-interest transactions.

Other notable related party transactions and party-in-interest transactions for services provided to the Plan by the affiliated parties disclosed.

(8) Concentration of Credit Risks

The Plan's exposure to a concentration of credit risk is limited by diversification of investments across all participant-directed fund elections. Additionally, the investments within each participant-directed fund election are generally diversified into various financial instruments.
