INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Taylor Machine Works, Inc. Bargaining Unit 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Taylor Machine Works, Inc. Bargaining Unit 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO THE FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Taylor Machine Works, Inc. Bargaining Unit 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which became effective January 1, 1997, is a defined contribution plan, which covers collectively bargained employees or employees treated as collectively bargained of Taylor Machine Works, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employees who are covered by the bargaining unit agreement between the Company and the United States Steel Workers of America AFL-CIO on behalf of Local No. 7772 are eligible to participate in the Plan after completion of one year of service. One year of service is defined as 12 consecutive months in which an employee is credited with at least 1,000 hours of service. An eligible employee may become a participant on the first quarterly entry date following the date the employee meets the Plan's eligibility requirements. Participants may contribute up to 10% of their eligible compensation, which includes wages, overtime pay, bonuses, and commissions to the Plan, subject to regulatory limitations. The Company contributes a matching contribution of 50% of the participants first 9% of elective deferral, not to exceed 5% of the participant's eligible compensation.

Participants may also transfer to the Plan certain vested account balances from other qualified plans, subject to regulatory requirements.

Participant Investment Programs

Contributions to the Plan are invested with Charles Schwab Bank, trustee of the Plan, in any of the investment funds available under the Plan's provisions, in such proportions as participants direct.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocation of (1) the Company's contribution, and (2) Plan earnings and losses, and is charged with an allocation of administrative expenses to the extent such expenses are paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Employee contributions, deferrals and earnings thereon are fully vested. Vesting in the Company's contributions and the corresponding earnings thereon is based on the participant's years of service according to the following schedule:

Payment of Benefits

Benefits are generally payable upon termination, retirement, death or disability. Benefits may be paid by either lump-sum payment, periodic payments over an actuarially determined period, rollover into a qualified plan (subject to regulatory requirements), a combination of lump-sum payment and rollover or periodic payments. Hardship distributions are also available from participants' elective deferral accounts, excluding earnings on such deferrals, subject to regulatory requirements.

Forfeited Accounts

Forfeitures, which result from employees withdrawing from the Plan prior to vesting in the Company's contributions and earnings thereon, are applied to reduce the Company's contributions to the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$19,364 and \$366, respectively. In 2024, employer contributions were reduced by \$2,994 from forfeited nonvested accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are generally paid by the Company and are excluded from these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through September 23, 2025, the date the financial statements were available to be issued.

3. CERTIFIED INFORMATION (UNAUDITED)

Certified information related to investments disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Charles Schwab Bank (the trustee of the Plan).

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) Topic 820 are described as follows:

- Level 1 – Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Money market and mutual funds: Valued at the net asset value of shares held by the Plan at year end as reflected in an active market (Level 1).

Cash equivalents: Valued using the evaluated pricing methodology for the commercial paper held by the Plan at year end as reflected by observable inputs other than quoted prices for identical assets in an active market (Level 2).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of money market and mutual funds managed by Charles Schwab Bank, the trustee, as defined by the Plan. Management has determined that these transactions qualify as exempt party-in-interest transactions under ERISA.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

7. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 19, 2014, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
