## INDEPENDENT AUDITOR'S REPORT

To the Trustee, Plan Administrator, and Plan Participants

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements***

We have performed an audit of the financial statements of Wallace Automotive Employee Savings & Protection Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit needs not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion on the Financial Statements***

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP);
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion on the Financial Statements***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.




### NOTE 1 – PLAN DESCRIPTION

The following description of Wallace Automotive Employee Savings & Protection Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

On February 22, 2016, Wallace Automotive Employee Savings & Protection Plan and Wallace Automotive Employee Savings & Protection Plan #2 were merged into one plan. On this day, the assets of Wallace Automotive Employee Savings & Protection Plan #2 were transferred into Wallace Automotive Employee Savings & Protection Plan.

The Plan is a defined contribution plan sponsored by Wallace Imports of Bristol, Inc. (the Company). The Plan provides benefits for all eligible employees of the Company and its participating related employers which include First Team Imports, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974.

#### **Eligibility**

Employees become eligible to participate in the Plan after three months of service and after attaining the age of twenty-one. After meeting the eligibility requirements, an employee may become a participant in the Plan on the next applicable entry date. Applicable entry dates are the first day of each quarter.

#### **Contributions**

Each year, participants may contribute up to 100% of their annual compensation, subject to maximum deferral limits set forth in the Internal Revenue Code. Participants may elect to defer eligible compensation on a pretax basis, an after-tax Roth basis, or a combination of both. Participants who have attained age fifty before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute rollover or transfer contributions from another qualified plan after becoming a participant in the Plan. The Company may contribute a discretionary amount. No matching or discretionary contributions by the Company were made in 2024 or 2023.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's discretionary contributions, (b) plan earnings or losses, and (c) charged with administrative expenses. Allocations are based on participant account balances, or eligible compensation, as defined by the Plan.

#### Notes Receivable from Participants

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of the vested interest in the participant's account balance reduced by any outstanding loan balance. The Plan allows participants to have up to two loans outstanding at any given time. Repayment of participant loans is over five years unless the loan is used for the purchase of a primary residence. The loans are secured by the balance in the participant's accounts and bear interest at the market rate in effect at the time the loans are issued. Interest rates range from 4.75% to 9.50%. Principal and interest are paid ratably through payroll deductions.

#### Vesting

Participants are immediately vested in their voluntary contributions, qualified rollover or transfer contributions, and earnings or losses thereon. All other contributions, and their associated earnings and losses, will vest in accordance with the following table:

Participants become fully vested, regardless of the vesting table, upon attainment of normal retirement age, disability, death, or termination of the Plan.

#### Payment of Benefits

Distributions from the Plan are available upon any of the following: (1) termination of employment with the Company; (2) retirement and in-service distributions upon or following age 59 1/2; and (3) disability or death. A participant (or the designated beneficiary) who qualifies for a distribution, will receive a lump-sum distribution equal to the vested balance of the account or transfer the vested balance of the account to an individual retirement account or other qualified retirement plan. Distributions from the Plan will normally be taxed as ordinary income for income tax purposes, unless the participant (or the designated beneficiary) elects to rollover his or her distributions into an individual retirement account or another qualified retirement plan.

Any part of a participant's nonvested contribution at the time of termination of employment is forfeited. Hardship withdrawals are allowed.

#### **Administrative Expenses**

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

#### **Forfeited Accounts**

Any non-vested portion of the Company's contributions credited to a participant's account who withdraws prior to becoming vested is forfeited and will be used to reduce administrative expenses. At December 31, 2024 and 2023, the available forfeitures were \$5,996 and \$4,576, respectively. For the year ended December 31, 2024, no forfeitures were used to reduce administrative expenses.

### NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting and Use of Estimates**

The financial statements of the Plan are prepared using the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP), which requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

The Financial Accounting Standards Board (FASB) has adopted the Accounting Standards Codification (ASC) as the sole source of authoritative GAAP. The FASB will issue Accounting Standards Updates (ASU) from time to time to make adjustments to GAAP.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value as reported by the trustee, Empower Annuity Insurance Company of America (Empower). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. The Plan's investments are valued daily. Fair value of common trust funds and pooled separate accounts is based on the net asset value of the underlying securities in the funds.

Net appreciation or depreciation of investments included in the accompanying statement of changes in net assets available for benefits includes realized gains or losses from the sale of investments and unrealized appreciation or depreciation in fair value of investments. Net unrealized appreciation or depreciation in the fair value of investments represents the net change in the fair value of the investments held during the year. The net realized gains or losses on the sale of investments represent the difference between the sale proceeds and the fair value of the investment as of the beginning of the year or the cost of the investment if purchased during the year.

#### Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### Payment of Benefits

Benefits are recorded when paid.

#### Expenses

Costs associated with the operation of the Plan, including trustee fees, are paid from the Plan and recorded as an expense. All other expenses are paid by the Company.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

### NOTE 4 – FAIR VALUE MEASUREMENTS

The Plan adopted FASB ASC 820, *Fair Value Measurement*. FASB ASC 820 defines fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

- **Level 1** consists of unadjusted quoted prices in active markets for identical assets or liabilities and has the highest priority.
- **Level 2** consists of inputs other than quoted prices within Level 1 that are observable for the asset or liability, either directly or indirectly.
- **Level 3** consists of significant unobservable inputs for the asset or liability and has the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit. Pooled separate accounts are valued using the net asset value (NAV) of the underlying securities in the fund.

### NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Plan investments include pooled separate accounts that are accounts and investment products provided by Empower. Empower is the recordkeeper as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Some of the fees paid to the trustee are netted against investment returns.

### NOTE 6 – TAX STATUS

The Plan, a volume submitter profit sharing plan with a cash or deferral arrangement, received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 1, 2021, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). In addition, the plan administrator believes the Plan, as restated, is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **NOTE 6 – TAX STATUS (Continued)**

The Plan follows the accounting guidance for uncertainty in income taxes using the provisions of FASB ASC Topic 740, *Income Taxes*. The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits. The Plan's evaluation was performed for tax years ended December 31, 2021 through December 31, 2024, the years that remain subject to examination by major tax jurisdictions as of December 31, 2024.

### **NOTE 7 – PROHIBITED TRANSACTIONS**

During 2024, the plan sponsor failed to remit all employee contributions to the Plan on a timely basis, which is a prohibited transaction under ERISA. The plan sponsor is in the process of calculating the lost earnings to the participants and will remit that amount to the Plan in order to correct the prohibited transaction.

### **NOTE 8 – AMOUNTS OWED TO WITHDRAWN PARTICIPANTS**

As of December 31, 2024, the amount of net assets available for benefits that were in accounts of participants that are no longer employees of the plan sponsor totaled \$548,349. None of these amounts had been requested to be repaid to those participants at December 31, 2024.

### **NOTE 9 – SUBSEQUENT EVENTS**

The plan administrator has evaluated events and transactions subsequent to December 31, 2024, through October 3, 2025, (the date the financial statements were available to be issued) for potential recognition or disclosure in the financial statements. The plan administrator has not identified any items requiring recognition or disclosure.

### **NOTE 10 – EXCESS CONTRIBUTIONS REFUNDABLE**

At December 31, 2024 and 2023, payables of \$28,130 and \$0, respectively, are recorded for amounts refundable by the Plan to participants for excess deferral contributions as required to satisfy the relevant nondiscrimination provisions of the Plan.
