In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about ANIBIC 403(b) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

**1. DESCRIPTION OF THE PLAN**

The following brief description of the ANIBIC 403(b) Plan (the Plan) is provided for general information purposes only. For a more complete description of the Plan's provisions, participants should refer to the Plan document.

**General**

The Plan is a defined contribution plan established to provide retirement benefits covering all eligible employees of Association for Neurologically Impaired Brain Injured Children, Inc. (the Company and Plan Sponsor). The Plan is funded by employee contributions. Investment management fees and a portion of administrative expenses are paid by the Plan. At December 31, 2024 and 2023, the assets of the Plan are held and managed by Ascensus Trust Company (the Custodian). The Plan is intended to conform to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent legislation, where applicable.

**Eligibility**

Employees of the Company are eligible to participate in the Plan upon their date of hire and are immediately vested in their contributions. Participants are eligible to receive Employer contributions after they have fulfilled one year of service and are at least 21 years of age.

**Contributions**

For each Plan year, eligible participants may make voluntary pre-tax contributions in the form of salary reductions and any applicable rollovers from other qualified plans, subject to certain limitations of the Plan and the Internal Revenue Code (IRC) under Section 403(b). Participants are also eligible to make Roth elective contributions to the Plan. Additionally, participants who are over the age of 50 are eligible to make an additional "catch up" contribution. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer may make discretionary matching or non-elective profit-sharing contributions which are allocated to the participant in accordance with the Plan documents. No discretionary or non-elective profit-sharing contributions were made in 2024 and 2023.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocation of (a) Plan earnings and losses, and (b) administrative expenses. Allocations are based on participant earnings/losses or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of all contributions into various investment options offered by the Plan.

**Vesting**

Employees are fully vested in their elective deferrals plus actual net earnings/losses thereon. Vesting for discretionary Employer discretionary matching and non-elective profit-sharing contributions become 20% vested upon completion of two years of service and continue to vest at the rate of 20% for each successive year of service until 100% vested after six years of service. Participants are considered to have completed one year of service for vesting purposes upon completion of 1,000 hours of service at any time during the plan year.

## 1. DESCRIPTION OF THE PLAN (Continued)

### **Benefit Payments**

Upon termination of employment, death, disability, hardship, or retirement, participants or their beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or in substantially equal installments over his or her lifetime. The Plan Administrator will make a mandatory distribution for participant account balances below \$5,000 following severance from employment.

Participants may also receive hardship distributions under certain circumstances, as defined in the Plan document. The Plan also allows for in-service withdrawals for employees who attain age 59  $\frac{1}{2}$ .

### **Notes Receivable from Participants**

Participants may borrow up to the lesser of \$50,000 or 50% of the participant's vested balance in the Plan. The minimum loan is \$1,000. Loans are repayable over periods not to exceed five years, except in the case of a loan taken for the purpose of purchasing a primary residence. The loans are secured by the participant's account and bear interest at the prime rate plus 1%.

### **Forfeitures**

If a participant's employment is terminated, the non-vested portion of their account balance will become subject to forfeiture in accordance with the provisions of the Plan document and shall be applied to reduce administrative expenses of the Plan and then used to reduce Employer matching contributions to the Plan. There were \$20,517 and \$13,888 held in forfeitures as of December 31, 2024 and 2023, respectively. During 2024 and 2023, no forfeitures were used to reduce administrative expenses or employer contributions.

### **Administrative Expenses**

Certain expenses attributable to the general plan administration are paid directly by the Company and are excluded from these financial statements. Administrative expenses paid by the Plan may include notes receivable and distribution fees charged to participants' accounts and administrative Plan fees.

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become fully vested in their account balances.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The Plan prepares its financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold or held during the year.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

### **Income Taxes**

The Plan adopted a volume submitter plan offered by Ascensus, LLC stating that the written form of the underlying specimen plan is qualified under Section 403(b) of the IRC. The volume submitter plan received an IRS Opinion Letter dated January 1, 2018, that the Plan is designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### **Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### 3. FINANCIAL CERTIFICATION

The following financial information relating to the Plan's assets at December 31, 2024 and 2023, as well as investment income and investment transactions for the years then ended, has been derived from information provided by Ascensus Trust Company, the Custodian of the Plan, and has been certified by them as complete and accurate.

### 4. FAIR VALUE MEASUREMENTS

The Plan uses various valuation techniques in determining fair value. ASC Section 820 established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### 4. FAIR VALUE MEASUREMENTS (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds and money market funds:* Values are determined based on quoted market prices in active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no changes to the valuation methodologies used during 2024 or 2023.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**1. DESCRIPTION OF THE PLAN**

The following brief description of the ANIBIC 403(b) Plan (the Plan) is provided for general information purposes only. For a more complete description of the Plan's provisions, participants should refer to the Plan document.

**General**

The Plan is a defined contribution plan established to provide retirement benefits covering all eligible employees of Association for Neurologically Impaired Brain Injured Children, Inc. (the Company and Plan Sponsor). The Plan is funded by employee contributions. Investment management fees and a portion of administrative expenses are paid by the Plan. At December 31, 2024 and 2023, the assets of the Plan are held and managed by Ascensus Trust Company (the Custodian). The Plan is intended to conform to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent legislation, where applicable.

**Eligibility**

Employees of the Company are eligible to participate in the Plan upon their date of hire and are immediately vested in their contributions. Participants are eligible to receive Employer contributions after they have fulfilled one year of service and are at least 21 years of age.

**Contributions**

For each Plan year, eligible participants may make voluntary pre-tax contributions in the form of salary reductions and any applicable rollovers from other qualified plans, subject to certain limitations of the Plan and the Internal Revenue Code (IRC) under Section 403(b). Participants are also eligible to make Roth elective contributions to the Plan. Additionally, participants who are over the age of 50 are eligible to make an additional "catch up" contribution. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer may make discretionary matching or non-elective profit-sharing contributions which are allocated to the participant in accordance with the Plan documents. No discretionary or non-elective profit-sharing contributions were made in 2024 and 2023.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocation of (a) Plan earnings and losses, and (b) administrative expenses. Allocations are based on participant earnings/losses or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of all contributions into various investment options offered by the Plan.

**Vesting**

Employees are fully vested in their elective deferrals plus actual net earnings/losses thereon. Vesting for discretionary Employer discretionary matching and non-elective profit-sharing contributions become 20% vested upon completion of two years of service and continue to vest at the rate of 20% for each successive year of service until 100% vested after six years of service. Participants are considered to have completed one year of service for vesting purposes upon completion of 1,000 hours of service at any time during the plan year.

## 1. DESCRIPTION OF THE PLAN (Continued)

### **Benefit Payments**

Upon termination of employment, death, disability, hardship, or retirement, participants or their beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or in substantially equal installments over his or her lifetime. The Plan Administrator will make a mandatory distribution for participant account balances below \$5,000 following severance from employment.

Participants may also receive hardship distributions under certain circumstances, as defined in the Plan document. The Plan also allows for in-service withdrawals for employees who attain age 59  $\frac{1}{2}$ .

### **Notes Receivable from Participants**

Participants may borrow up to the lesser of \$50,000 or 50% of the participant's vested balance in the Plan. The minimum loan is \$1,000. Loans are repayable over periods not to exceed five years, except in the case of a loan taken for the purpose of purchasing a primary residence. The loans are secured by the participant's account and bear interest at the prime rate plus 1%.

### **Forfeitures**

If a participant's employment is terminated, the non-vested portion of their account balance will become subject to forfeiture in accordance with the provisions of the Plan document and shall be applied to reduce administrative expenses of the Plan and then used to reduce Employer matching contributions to the Plan. There were \$20,517 and \$13,888 held in forfeitures as of December 31, 2024 and 2023, respectively. During 2024 and 2023, no forfeitures were used to reduce administrative expenses or employer contributions.

### **Administrative Expenses**

Certain expenses attributable to the general plan administration are paid directly by the Company and are excluded from these financial statements. Administrative expenses paid by the Plan may include notes receivable and distribution fees charged to participants' accounts and administrative Plan fees.

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become fully vested in their account balances.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The Plan prepares its financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold or held during the year.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

### **Income Taxes**

The Plan adopted a volume submitter plan offered by Ascensus, LLC stating that the written form of the underlying specimen plan is qualified under Section 403(b) of the IRC. The volume submitter plan received an IRS Opinion Letter dated January 1, 2018, that the Plan is designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### **Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### 3. FINANCIAL CERTIFICATION

The following financial information relating to the Plan's assets at December 31, 2024 and 2023, as well as investment income and investment transactions for the years then ended, has been derived from information provided by Ascensus Trust Company, the Custodian of the Plan, and has been certified by them as complete and accurate.

### 4. FAIR VALUE MEASUREMENTS

The Plan uses various valuation techniques in determining fair value. ASC Section 820 established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### 4. FAIR VALUE MEASUREMENTS (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds and money market funds:* Values are determined based on quoted market prices in active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no changes to the valuation methodologies used during 2024 or 2023.

#### 5. PARTY-IN-INTEREST TRANSACTIONS

Ascensus LLC is the record-keeper of the Plan and Ascensus Trust Company is the Custodian of the Plan. Therefore, any transactions with these parties qualify as party-in-interest. Fees incurred by the Plan for investment services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, and some fees are made by direct payments.

Plan assets consist of notes receivable from participants, which qualify as party-in-interest transactions.

#### 6. SUBSEQUENT EVENTS

Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued.
