Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of **Arion Care Solutions 401(k) Retirement Plan** ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

(1) Description of the Plan

The following description of Arion Care Solutions 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. **General** – The Plan is a defined contribution plan. The Plan was originally established May 1, 2019 by Arion Care Solutions, LLC (the "Sponsor"). The Plan covers substantially all employees that have completed one year of service unless such employee is (1) less than 21 years of age or (2) a person classified by the Sponsor as an independent contractor. A year of service is defined as at least 1,000 hours of service during the 12-month period beginning on an employee's hire date and the consecutive 12-month period ending on the last day of each following Plan year. Participants will enter the Plan on the first day of the quarter following their meeting the Plan's eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
- B. **Contributions** – Each year, participants may elect to make pre-tax and/or Roth contributions up to 100% of eligible compensation as defined in the Plan, subject to certain limitations established by the Internal Revenue Service. Participants may also contribute amounts representing qualified distributions from other plans. Participants who have attained age 50 before the end of the Plan year are eligible to make annual catch-up contributions up to \$7,500. The Sponsor may make a discretionary matching contribution equal to a percentage of employees' 401(k) elective deferral contributions, up to a certain percentage of eligible compensation. The Sponsor may also make a qualified non-elective contribution to eligible employees, as defined in the Plan document. For the year ended December 31, 2024, the Sponsor did not make discretionary matching contributions or qualified non-elective contributions.
- C. **Participant accounts** – Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contribution and allocations of the Sponsor's discretionary matching and qualified non-elective contributions, if any, and Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.
- D. **Vesting** – Participants are immediately vested in their pre-tax, Roth, and rollover contributions, qualified non-elective contributions and actual earnings thereon. Vesting in the Sponsor's discretionary matching contributions plus actual earnings thereon is based on years of service as follows:

- E. **Payment of benefits** – Participants may withdraw their vested account balances in full or partial lump sums or installments upon retirement, disability or termination. Beneficiaries may withdraw vested account balances upon the death of a Plan participant. Participants may also withdraw all or a portion of their contributed account balances for specific hardship reasons subject to approval by the Plan administrator.

(1) Description of the Plan (continued)

- F. **Notes receivable from participants** – Participants may borrow against their vested account balances a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The number of outstanding loans for a participant shall be limited to one for any 12-month period. The loans are secured by the vested balances in the participants' account and bear interest at a fixed rate based on the rates available for similar loans from commercial lending institutions. Loans are expected to be repaid over a period of no more than 5 years, unless such loan is used to acquire the principal residence of the participant. Payment due dates and length will be set out in the promissory note, with payments being due at least quarterly. As the participant repays the loan, the principal and interest will be credited to their account.
- G. **Forfeitures** – Forfeitures of non-vested Sponsor contributions can be used to pay Plan expenses with any forfeitures remaining after paying Plan expenses may be used to offset the Plan's next Sponsor contributions. If any forfeitures still remain, such forfeitures are reallocated. At December 31, 2024 and 2023, there were no forfeited non-vested accounts.
- H. **Administrative expenses** – Per-use fees include loan administration, withdrawal processing, distribution processing, and QDRO qualification fees. These fees are paid directly by the participant. Plan expenses for postage, audit fees, and investment management through a third party can be charged to participant accounts, but are paid by the Sponsor.
- I. **Plan termination** – Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(2) Significant accounting policies

The significant accounting policies followed by the Plan are as follows:

Basis of accounting – The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America. Accordingly, income is recognized when earned and expenses are recorded when incurred.

Management's use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amount of net assets available for benefits and changes therein. Actual results may differ from those estimates.

Investment valuation – The Plan's investments are valued as described in Note 3. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and uncertainties – The Plan provides for various investment fund options which in turn invest in any combination of stocks, bonds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

(2) Significant accounting policies (continued)

Payment of benefits – Benefit payments to participants are recorded when paid.

Subsequent events – Plan management has evaluated subsequent events through October 7, 2025, which is the date the financial statements of the Plan were available to be issued.

(3) Fair value measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodology used for investments.

Mutual funds: Valued at the net asset value (“NAV”) of shares held by the Plan at year end, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions.

Pooled separate account: Investments in sub-accounts of the Plan’s group annuity contract with Principal Life Insurance Company (U.S.A.) are valued at unit value, which is based on the aggregate fair value of the underlying assets in relation to the total number of units outstanding. Unit value is the equivalent of NAV, which is a practical expedient for estimating the fair values of these investments. Each of these investments may be redeemed daily with a notice period of one day and the Plan had no unfunded commitments as of December 31, 2024 and 2023.

Common collective trust: Investments in a common collective trust are valued at the NAV of units of the collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Participant withdrawals will be paid promptly. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments as of December 31, 2024 and 2023.

Certain Plan investments are held in funds managed by Principal, which also functions as the record keeper for the Plan; therefore, transactions with this party qualify as party-in-interest transactions. Fees for the year ended December 31, 2024 in the amount of \$52,635 paid to Principal qualify as exempt party-in-interest transactions and are presented as administrative expenses in the statement of changes in net assets available for benefits.

(6) Income tax status

The Internal Revenue Service issued an opinion letter dated June 30, 2020 stating that the Plan was designed in accordance with the applicable Internal Revenue Code ("IRC") requirements as of that date. The Plan administrator and the Sponsor believe that the Plan is currently operating in compliance with the applicable requirements of the IRC and that the Plan was qualified and the related trust was tax-exempt as of and for the year ended December 31, 2024.

(7) Excess contributions refundable

The Plan is required to return contributions received during the year in excess of the IRC limits. At December 31, 2024 and 2023, amounts refundable by the Plan to participants for contributions made in excess of amounts allowed totaled \$34,466 and \$3,761, respectively. The amounts have been reflected as excess contributions refundable in the accompanying statements of net assets available for benefits.

The loan repayments and late contributions totaled \$683 for the year ended December 31, 2023, were fully corrected, including lost earnings, during the year ended December 31, 2024.

For the year ended December 31, 2024, the Company failed to remit loan repayments to the Plan in a timely manner constituting a lending of such monies to the Company. The loan repayments totaled \$160 for the year ended December 31, 2024, were fully corrected, including lost earnings, during the year ended December 31, 2024.
