Notes to Financial Statements

Note 1: Plan Description

The following description of Good Shepherd Manor, Inc. Retirement Plan ("Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established for a not-for-profit organization, commonly known as a Code Section 403(b) savings plan. Good Shepherd Manor, Inc. ("Organization") is the Plan sponsor and is a not-for-profit corporation as described in Section 501(c)(3) of the Internal Revenue Code (IRC). Employees who normally work at least 20 hours per week are eligible to participate immediately upon employment for purposes of making pre-tax contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA and, therefore, provides that participants may choose to direct their contributions and all or part of their account balances among the Plan's investment alternatives. All investments are participant-directed.

Contributions

Each year, participants may contribute up to the maximum percentage allowable of pretax annual compensation, as defined by the Plan, not to exceed the maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers). The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, and their contributions are invested in a designated balanced fund until changed by the participant.

The Organization may make discretionary matching contributions. For the year ended December 31, 2024, the Organization made matching contributions equal to 100% of the first 2% of eligible compensation that a participant contributes to the Plan, totaling \$98,802. The Organization may also make discretionary non-elective contributions. For the year ended December 31, 2024, the Organization did not make any non-elective contributions. To be eligible for discretionary matching and non-elective contributions, a participant must be 16 years old and have completed one year of service. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Organization matching contributions, if any, and allocations of (a) Organization non-elective contributions, if any, and (b) Plan earnings (losses). Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Plan Description (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's matching and non-elective contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant earns 20 percent vesting for each year of service, and is 100 percent vested after five years of credited service. In addition, 100 percent vesting occurs upon the normal retirement, death, or disability of a participant.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of the participant's vested account balance as of the valuation date preceding the making of such note receivable. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50% percent, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. The term of the note cannot exceed five years, unless the purpose of the note, as determined at the time of the application, is to acquire or construct a principal residence for the participant, then the repayment of the note shall not exceed twenty years. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, the participant or their beneficiary will receive 100 percent of the participant's vested account balance. If the value of the vested benefit is \$5,000 or less, a lump-sum distribution will be made; otherwise, they may elect to receive the benefit as a lump-sum amount equal to the value of the participant's vested interest in his or her account or in installments as prescribed by the Plan document. For termination of service due to other reasons, a participant may receive the vested portion of their account balance as a lump-sum distribution. In addition, hardship distributions out of the participant's voluntary contributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59½.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Organization before becoming 100% vested in the Organization's contributions. These forfeitures may be applied to reduce the contributions of the Organization or may be used to pay administrative expenses in accordance with the Plan document. At December 31, 2024 and 2023, unallocated forfeitures from non-vested accounts totaled \$2,433 and \$813, respectively. During the year ended December 31, 2024, forfeitures were used to reduce employer contributions by \$1,298. Forfeitures were not used to reduce administration expenses during the year ended December 31, 2024.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 (“SECURE 2.0”), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine which optional provisions, if any, to elect in the future.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared based on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for fully benefit-responsive investment contracts (FBRICs). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in total investment income.

Subsequent Events

The Plan has evaluated subsequent events through September 24, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within level 1 that are observable for the asset or liability, either directly or indirectly, such as: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Note 3: Fair Value Measurements (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities Exchange commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Note 4: Fully Benefit-Responsive Investment Contracts (FBRICS)

The Plan invests in a FBRIC with Empower Annuity Insurance Company of America (EAIC) in the form of a guaranteed investment contract (GIC) that invests in fixed income securities. The GIC is a general account product offered through a group annuity contract where participant principal and interest is backed by the entire general account assets of EAIC. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. EAIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1%. Such interest rates are reviewed on a semi-annual basis for resetting.

Note 4: Fully Benefit-Responsive Investment Contracts (FBRICS) (Continued)

Certain events limit the Plan's ability to transact at contract value with EAIC including Plan termination and other events as specified in the GIC. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The GIC does not permit EAIC to terminate the agreement prior to the scheduled maturity date.

Note 5: Information Prepared and Certified by Custodians

The Plan administrator has elected the method of annually reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Trust Company (ETC) and EAIC, the Custodians of the Plan.

Note 6: Related Party and Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds and a GIC managed by ETC and EAIC. ETC and EAIC are the Custodians and recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees for the investment management services during the Plan year ended December 31, 2024 were offset and included in total investment income.

In addition the Plan pays certain expenses related to administrative fees and investment advisory services to various providers. These transactions also qualify as party-in-interest transactions. Fees paid by the Plan for administrative services and investment advisory services amounted to \$23,770 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their Organization's contributions.

Note 8: Tax Status

The Organization adopted a nonstandard volume submitter plan document with an IRS notification letter dated March 31, 2017 which states the volume submitter plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan, as amended, is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
