INDEPENDENT AUDITOR'S REPORT

To the Trustee of
The Citizens National Bank of Meridian 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of The Citizens National Bank of Meridian 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Citizens National Bank of Meridian 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Citizens National Bank of Meridian 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Citizens National Bank of Meridian 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

1. PLAN DESCRIPTION

The Citizens National Bank of Meridian 401(k) Profit Sharing Plan (the Plan) has adopted the provisions of the Corporate Financial Services, LLC Non-Standardized Defined Contribution Pre-Approved Plan. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan, effective January 1, 2004, is a defined contribution plan with participant deferral options under Section 401(k) of the Internal Revenue Code. Substantially all employees of The Citizens National Bank of Meridian (the Employer) become eligible to make salary reduction contributions on the 1st of the month, immediately following their completion of 90 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Participants may elect to defer from 1% to 100% of their annual eligible compensation from the Employer, subject to regulatory limitations, as contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to regulatory limitations. Participants may also contribute amounts (rollover contributions) representing distributions from other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund that is a Qualified Default Investment Alternative, until changed by the participant. The Plan also includes auto-escalation on the first day of the Plan year. At each interval, the contribution amount is increased by 1% every year until it reaches the preset maximum of 6%.

1. PLAN DESCRIPTION (Continued)

Contributions (Continued) - The Employer contributes a safe harbor matching contribution equal to 100% of the participant's salary deferrals per pay period that do not exceed 3% of their total eligible compensation plus 50% of the participant's salary deferrals per pay period between 3% and 5% of their total eligible compensation during the plan year. Additional Employer contributions may be made to the Plan at the discretion of management of the Employer.

Benefits - On termination of service, the participant may receive the vested value of their account in one lump-sum payment or partial withdrawals. Rollovers are permitted. A participant's account is also available for distribution prior to termination of employment with the Employer in the following circumstances: in the event of hardship or after the participant reaches the age of 59 ½.

Participant Accounts - Each participant's account is credited with the participant's contributions, the Employer's safe harbor matching contributions, an allocation of the Employer's discretionary contributions, if any, plus the earnings thereon and charged with an allocation of any administrative expenses paid by the Plan. The allocation method for Employer discretionary contributions is defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately 100% vested in their elective deferral contributions, Employer safe harbor matching contributions and earnings thereon. Vesting in Employer discretionary profit sharing contributions is based on years of service. A participant is 100% vested in any Employer discretionary contributions and earnings thereon after six years of service. A participant will become 100% vested in all accounts upon death or disability.

1. PLAN DESCRIPTION (Continued)

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are collateralized by the balance in the participant's account and bear interest at a rate of prime plus 1%, as published in the Wall Street Journal on the first business day of the month the note is originated. Principal and interest is paid ratably through monthly payroll deductions.

Investment Options –Participants direct the investment of their contributions into various investment options offered under John Hancock's group annuity contract. The contract offers a number of variable investment options under the John Hancock Pooled Separate Account (PSA). The PSA is not designed for short-term trading. Participants are allowed a maximum of two exchanges per calendar month. John Hancock will allow a participant to move 100% of their assets to a Money Market or Stable Value Fund (as available under the contract after the exchange limit has been reached; no subsequent exchanges may be made for 30 days). These restrictions do not apply to regular allocations or withdrawals.

Forfeitures – At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. In accordance with the Plan's provisions, forfeited balances may be used to offset Plan expenses and Employer matching and discretionary contributions, except for those Employer contributions that are required to be fully vested when contributed to the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting- The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Employer to make estimates and assumptions for the Plan that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits - Benefits are recorded when paid.

Plan Expenses - Substantially all expenses associated with the administration of the Plan are paid by the Participants, assessed on an individual basis. These expenses include investment fund transaction fees or expenses associated with the investments held by a participant, distribution charges and other fees, as applicable. Administrative fees assessed to the Plan as a whole, such as report processing fees, are also paid by the Participants.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Each participant account is valued on a daily basis for all funds invested with John Hancock. See Note 3 for further discussion of fair value. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Units of interest for the variable investment options are revalued daily to reflect the performance of the underlying mutual fund minus any applicable fees and charges.

Notes Receivable from Participants – Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded. If a participant does not make loan payments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Subsequent Events – In preparing the financial statements, Plan management has reviewed all known events that have occurred after December 31, 2024, and through the date of the Independent Auditor’s Report, which is the date the financial statements were available to be issued, for inclusion in the financial statements and footnotes.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) No. 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement).

The three levels of the fair value hierarchy under FASB ASC No. 820 are described as follows:

- inputs other than quoted prices that are observable for the asset;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

Pooled Separate Account – The John Hancock Pooled Separate Account (PSA) invests in open-ended mutual funds that are valued at the daily closing price as reported by the fund. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain investment options of the Plan are invested in a pooled separate account managed by John Hancock, the Plan's custodian. Therefore, these transactions qualify as exempt party-in-interest transactions. Recordkeeping and administrative expenses paid to John Hancock by the Plan were \$89,209 for the year ended December 31, 2024.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as changes in interest rate, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of assets available for benefits.

8. TAX STATUS

The non-standardized defined contribution pre-approved plan obtained its latest determination letter on June 30, 2020, in which the Internal revenue Service stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

8. TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
