As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Notes to Financial Statements

1. Description of the Plan

The following description of the Salt Lake Brewing Co., LC 401(k) P/S Plan (the Plan) provides only general information. Participants and other users of the financial statements should refer to the Plan document, adoption agreement and summary plan description for a complete description of the Plan's provisions.

General

The Plan was created on January 1, 2022 and is a defined contribution plan covering all eligible employees of Salt Lake Brewing Co., (collectively the Employer, or Company) who complete three months of service. Employees are eligible to participate in the Company matching contribution and profit-sharing contribution upon initial eligibility in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Contributions to the Plan may include: (i) salary reduction contributions authorized by participants, (ii) safe harbor contributions made by the Company, (iii) matching contributions made by the Company, (iv) discretionary profit-sharing contributions made by the Company, and (v) participant rollovers from other plans.

Participants may elect to contribute a percentage of their eligible compensation, as defined by the Plan document, to the Plan each year, subject to the limitations of the Internal Revenue Code (IRC). Regular 401(k) contributions are excluded from the participant's taxable income for federal income tax purposes until received as a withdrawal or distribution from the Plan. Roth 401(k) contributions are not excluded from the participant's taxable income for federal income tax purposes, but withdrawals of contributions and earnings thereon at retirement are tax free. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions.

The Company makes a safe harbor matching contribution to each participant's account equal to 100% of the first 4% of each participant's contribution. Additional profit-sharing and employer match amounts may be contributed at the discretion of the Company's Board of Directors. During the year ended December 31, 2024, the Company did not make profit-sharing or additional employer matching contributions to the Plan.

Participants may also contribute to the Plan amounts representing distributions from other qualified defined benefit or defined contribution plans.

Participant Accounts

Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participants may direct the investment of their account balance into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of one-half of the vested account balance or \$50,000. The loans are secured by an assignment of a participant's vested interest in the Plan, and bear interest at a rate commensurate with local prevailing rates at the time funds are borrowed as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions or as a lump sum for the outstanding loan balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence.

As of December 31, 2024, the plan had multiple participant loans with maturities ranging from 2025 to 2029, with interest rate ranging from of 4.50% to 9.50%.

Vesting

Participants are vested immediately in their contributions and safe harbor employer matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary and profit-sharing contributions portion are based on years of continuous service. A participant becomes vested based on years of credited service, as follows:

Years of Service	Vested Percentage
0 - 1	0%
1 - 2	25%
2 - 3	50%
3 - 4	75%
4 or more	100%

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture. The Plan document permits the use of forfeitures in any manner at the discretion of the Company. As of December 31, 2024 and 2023, the forfeiture balance was \$0 and \$23, respectively.

Administrative Expenses

Plan administrative expenses may be charged directly to the Plan (either allocated to the participants or using forfeiture funds) or paid by the Employer. During the year ended December 31, 2024, the Plan paid \$28,318 of administrative expenses. Certain administrative expenses are paid by the Company. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in securities that are exposed to various risks, such as interest rate, currency exchange rate, credit, and the overall fluctuation in the market. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Investments in exchange-traded funds are stated at fair value based upon quoted market prices. Investments in cash are stated at carrying value, which approximates fair value. Investments in stable value fund are stated at net asset value (NAV) per share as a practical expedient, which is based on the fair value of the underlying investments.

Net appreciation (depreciation) in fair value of investments includes realized and unrealized gains or losses on investments and is recognized in income currently. Amounts invested may earn interest and dividends, which in turn are reinvested. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions when the participant has a distributable event.

Payment of Benefits

Benefits are recorded when paid by the Plan.

Subsequent Events

Plan management has evaluated events occurring subsequent to year-end through October 3, 2025, which is the date the financial statements were available to be issued.

3. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Financial Accounting Standards Board established a framework for measuring fair value in the form of a fair value hierarchy, which prioritizes inputs into valuation techniques used to measure fair value into three broad levels. This hierarchy requires assets to be classified by level in their entirety based upon the lowest level of input that was significant to the fair value measurement. The three levels of the fair value hierarchy are as follows:

- Level 1 Quoted prices in active markets for identical assets or liabilities.
- Level 2 Observable inputs other than Level 1, including quoted prices for similar assets or liabilities, quoted prices in less active markets, or other observable inputs that can be corroborated by observable market data.
- Level 3 Unobservable inputs supported by little or no market data for financial instruments whose value is determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

4. Exempt Party in Interest Transactions

PAi Trust Company, Inc., from January 1, 2022 through September 14, 2023 and Ascensus, LLC, an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC, from September 15, 2023 through August 30, 2024, were the trustees of the Plan that provided recordkeeping services to the Plan. Effective August 31, 2024, the Plan changed its trustee and recordkeeper to Transamerica Life Insurance Company Inc. which was the trustee of the Plan and provided recordkeeping services to the Plan for the period from August 30, 2024 to December 31, 2024. These transactions qualify as exempt party-in-interest transactions. The notes receivable from participants are also exempt party-in-interest transactions.

5. Federal Income Tax Status

The Company adopted a non-standardized prototype profit sharing plan which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, that the Plan is qualified to operate under an exemption from federal income taxes, pursuant to Section 501(a) of the Internal Revenue Code (IRC), and as a qualified trust under Section 401(a). The Plan Administrators believe that the Plan continues to be designed and operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrators believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement dates.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan Administrator has analyzed the tax positions of the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure

in the financial statements. The Plan is subject to routine audits in tax jurisdictions for tax years for which the applicable statutes of limitations have not expired; however, there are currently no audits for any tax periods in progress.

6. Information Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under that election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by PAi Trust Company, Inc. for the period of January 1, 2022 through September 14, 2023, Ascensus, LLC, an authorized representative of Ascensus Trust Company and Newport Trust Company LLC, for the period of September 15, 2023 through August 30, 2024 and Transamerica Life Insurance Company Inc. from August 30, 2024, through the year ended December 31, 2024, the trustees of the Plan, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplemental schedule:

- All investment assets held by the Plan
- The recording of transactions related to all investment assets, including related earnings (losses) and interest and dividends
- The recording of transactions related to all investment assets and notes receivable from participants, including related earnings (losses) and interest and dividends.
