NOTE A: DESCRIPTION OF THE PLAN

The following description of the Gleason Corporation Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Company reserves the right to amend the Plan at any time, in its sole discretion.

General

The Plan is a retirement savings plan which covers employees of Gleason Corporation and its participating affiliates (the "Company"). Effective January 1, 2023, an Eligible Employee shall become a Participant in the Plan for purposes of all contribution types as of the first day of the month coinciding with or next following the date they become an Eligible Employee. Prior to January 1, 2023, an Eligible Employee became a Participant in the Elective Deferral Contribution, Catch-up Contribution, Roth Contribution and Roth Catch-up Contribution components of the Plan as of the first day of the month coinciding with or next following the date they become an Eligible Employee, and became a Participant in the Matching Contributions or Qualified Matching Contributions (as applicable for a given Plan Year) and Employer Nonelective Contributions components of the Plan on the first day of the month coinciding with or next following the day after the date the Eligible Employee completes a Year of Eligibility Service. If an Eligible Employee was hired on or before December 31, 2022 and had not yet completed the Year of Eligibility Service as of the effective date of the elimination of the Year of Eligibility Service requirement on January 1, 2023, the Eligible Employee shall become a Participant in the Qualified Matching Contributions and Employer Nonelective Contributions components of the Plan on January 1, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employees may contribute up to 75% of their eligible compensation, as defined in the Plan, to the Plan through payroll deductions, subject to Internal Revenue Code (IRC) limitations. Contributions may be made to the Plan on a pre-tax or Roth basis. Newly eligible employees are automatically enrolled in the Plan at a pre-tax contribution rate of 6% of eligible compensation, unless the employee has elected to defer another amount to the Plan, to contribute on a Roth basis, or not to contribute at all. An automatically enrolled employee's contribution rate is subsequently increased by 1% per year until it reaches 10% of eligible compensation, unless the employee makes a contrary election.

Effective January 1, 2018, the Plan added a special automatic increase program which applies to any contributing Participant whose combined contributions total less than 10% of their compensation as of November 27, 2017, and who does not already have an automatic increase election in effect. Under this program, the amount of a Participant's elective deferral contributions shall automatically increase by 1% per year, until it reaches 10% of eligible compensation, unless the employee makes a contrary election.

The Company currently provides an employer match of 100% of an eligible participant's pre-tax and Roth elective contributions, up to an aggregate maximum of 6% of eligible compensation.

The Plan no longer accepts any after-tax contributions, but maintains accounts for after-tax contributions contributed prior to January 1, 2008 until such time as those contributions are distributed in accordance with the terms of the Plan.

Non-elective employer contributions are discretionary. There were no non-elective employer contributions made for the 2024 and 2023 plan years.

Vesting

Employee, employer matching and rollover contributions from another qualified plan to this Plan are fully vested at all times. Non-elective employer contributions for plan years beginning on and after January 1, 2007 vest 20% per year, beginning upon completion of two years of service, with full vesting occurring upon completion of six years of service or (if earlier) in the event that an employee attains normal retirement age (age 60) while still employed or terminates employment due to death or disability. Different vesting schedules apply to non-elective employer contributions made in prior years and to certain participants who participated in the American Pfauter Integrated Money Purchase Pension Plan.

Participant accounts

Each participant account is credited with contribution amounts, participant loan activity, expenses and any attributable investment earnings and market appreciation or depreciation. The benefit to which a participant is entitled is the final market value of the participant's account.

Participants may direct the investment of contributions into any of the Plan's designated investment funds. Changes in investment choices and transfers among funds are made directly between the participant and the trustee and may be made at any time.

Forfeitures

Forfeitures of terminated participants may be used to reduce Company contributions or applicable plan expenses. At December 31, 2024 and 2023, the Plan had \$2,685 and \$13,579, respectively, of non-vested forfeitures.

Benefit payments

The full value of the participant's vested account is payable in a lump sum or required annual payments upon termination of employment (whether due to retirement, disability, death or other cause). Participant accounts attributable to the American Pfauter Integrated Money Purchase Pension Plan can also be distributed in the form of installments or an annuity contract. Employee pre-tax and Roth contributions may be withdrawn in case of financial hardship, subject to the Retirement Committee's approval and within the scope of the IRC regulations. Amounts attributable to certain predecessor plans may be available for in-service withdrawal under other conditions.

As of April 1, 2017, the Plan no longer allows for Special Circumstances Hardship Withdrawals. Notwithstanding that change, the Plan will continue to allow for Safe Harbor Hardship Withdrawals, provided that the requirements for obtaining a Safe Harbor Hardship Withdrawal from the Plan are satisfied.

Effective January 1, 2018, for amounts held under a Participant's Pfauter Account, a Participant who is entitled to a distribution from the Plan can request a partial distribution from their vested account.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements have been prepared on the accrual basis of accounting.

Investment valuation and income recognition

The Plan's investment in registered investment companies are stated at fair value. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end. The common collective trusts are valued at NAV as a practical expedient.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. The net appreciation or depreciation in fair value of investments consists of realized gains or losses and the unrealized appreciation or depreciation on those investments.

Administrative expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported and changes therein, in the financial statements and accompanying footnotes. Actual results could differ from those estimates.

Payment of benefits

Benefits are recorded when paid.

Subsequent events

Management evaluated subsequent events, occurring after the date of the statement of net assets available for benefits through September 22, 2025, which is the date the financial statements are available to be issued. No subsequent events requiring disclosure were noted.

NOTE D: FAIR VALUE MEASUREMENTS

FASB ASC 820-10 *Fair Value Measurements* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
  
- Level 2 - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

NOTE D: FAIR VALUE MEASUREMENTS, Cont'd

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies:* Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan.

Registered Investment Companies are registered with the SEC and are required to report their policies and financial conditions, much like a publicly-traded company. Most investment companies in the United States must register with the SEC; they are regulated by the Investment Company Act of 1940.

*Common Collective Trusts:* Valued at the net asset value ("NAV") of shares held by the Plan at year end.

The Trusts provide for the collective investment of assets of tax-exempt pension and profit-sharing plans, primarily in a pool of investment contracts that are issued by insurance companies and commercial banks and in contracts that are backed by high quality bonds, bond trusts and bond mutual funds that are selected by the Trustees.

Additional Common Collective Trust information:

The fair values of these funds have been estimated using the net asset value per share, as a practical expedient as determined by the issuer. There are no unfunded commitments for the common collective trust funds as of December 31, 2024 or 2023. There are no waiting periods or other restrictions on redemptions from the common collective trust funds.

NOTE E: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100% vested in their accounts, and their accounts will be paid to them as provided for in the plan document.

#### NOTE F: TAX STATUS

The Plan obtained its latest opinion letter for the Vanguard Group Non-Standardized Pre-Approved Profit Sharing Plan with CODA in June 2020, in which the Internal Revenue Service stated that the Non-Standardized Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or other applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE G: PARTICIPANT NOTES RECEIVABLE

Participant notes receivable are measured and valued at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow against their vested account balances. The principal amount of the note must be between \$1,000 and \$50,000 and cannot exceed 50% of the participant's vested account balance. A participant may have up to two outstanding notes at one time, as long as the total of the notes does not exceed 50% of the participant's vested account balance and the total notes do not exceed \$50,000. The interest rate applied to the note equals the prime rate plus 1%; the interest rate is established on January 1 and July 1 of each year. The interest rate applied to a participant's note will remain fixed for the life of the note. Loans must be repaid within five years, except notes used to purchase a participant's principal residence, which may be repaid over fifteen years.

The note must be repaid by payroll deductions over the term of the note. If a participant's employment terminates for any reason, the total balance of the note will be due 90 days after the participant's termination (different rules apply to loans issued prior to January 1, 2011). Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

#### NOTE H: TRANSACTIONS WITH PARTIES-IN-INTEREST

All legal, accounting, and trustee services, except for loan administration and purchase fees, may be paid by the Company, although the Retirement Committee is authorized to pay permissible administrative expenses from available forfeitures to the extent any expense is not paid by the Company. The Plan invests in shares of funds managed by an affiliate of Vanguard Fiduciary Trust Company (VFTC). VFTC acts as trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. As described in Note B, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.
