Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Befesa Zinc US Inc. Hourly Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Befesa Zinc US Inc. NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF PLAN

The following description of the Befesa Zinc US Inc. Hourly Retirement Savings Plan (the “Plan”) only provides general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

Management has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued and has no material subsequent events to report.

General

The Plan is a defined contribution plan covering certain hourly paid employees of Befesa Zinc US Inc (Company, Employer, or Sponsor). The Plan is qualified under the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Hourly employees become eligible participants in the Plan after 90 days of employment and are eligible for Company contributions on the first of the month following completion of 12 months of continuous service with the Company, except employees at the Palmerton division, who are eligible for Company contributions after 90 days of employment.

Contributions

Participants may make pretax contributions and Roth contributions to the Plan up to the maximum percentage allowable by the IRC. Plan limits are indexed to follow changes in the federal limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. If a participant has not changed their salary deferral percentage upon meeting the eligibility requirements, the Plan Sponsor will automatically withhold 6% of a participant’s compensation and contribute that amount as a salary deferral. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, pooled separate accounts, and a collective trust as investment options for participants.

The Company’s contributions to the Plan on behalf of each group of participants are made in accordance with the schedule of payments specified by the basic labor agreement covering the specific group of represented employees at each of the Company’s divisions. The Company will make matching contributions in an amount equal to the amounts specified in each labor agreement. The Company will also make nonelective contributions for all eligible employees in an amount specified in the labor agreements.

For employees not covered by a basic labor agreement, the Company may elect to match an employee’s contributions in an amount equal to a discretionary percentage or amount of the employee’s deferrals, to be determined annually by the Company. The Company may also elect to make nonelective contributions, which are determined annually by management.

Participant Accounts

Each participant account is credited with the participant’s contribution and an allocation of (a) the Employer’s matching contribution, if any, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are immediately vested in their contributions and associated earnings thereon. Participants are 100% vested in Company contributions and earnings thereon upon completion of three years of continuous service, using a cliff vesting scale.

Notes Receivable from Participants

The Plan allows for a participant loan in amounts not less than \$1,000. The maximum amount of any loan is the lesser of: (i) 50% of the participant's vested account, reduced by any outstanding loan balance or (ii) \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. The loans are secured by the balance in the participant's account and bear interest at an agreed-upon percentage based on prevailing market rates. Loans must be repaid in level payments through payroll deductions over a five-year period unless for the purchase of a principal residence, in which case the note repayment period shall be limited to a period consistent with commercial home loan practices. The loans outstanding at December 31, 2024 have interest rates of 4.25% to 9.50%.

Payment of Benefits

Participants receive benefit payments based on the vested portion of their account balance upon death, retirement or attainment of age 59½, disability, or termination of employment. Benefit payments in amounts defined by law as "required minimum distributions" must commence by age 73, unless the participant is an active employee. All benefits other than "required minimum distributions" may be paid in the form of a lump sum, or in installment payments over a period not to exceed the participant's and beneficiary's expected life expectancies.

Employees may request a distribution of a portion of their contributions in the event of a documented financial hardship. The distribution is limited to the amount of the hardship, which must arise from certain events prescribed by law.

Forfeited Accounts

Forfeited accounts may be used to offset Plan administrative expenses or to reduce future Employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$1, respectively. During the year ended December 31, 2024, \$7,663 and \$876 of forfeitures were used to reduce employer contributions and pay Plan administrative expenses, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Valuation of Investments and Investment Income

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Gains and losses are determined on the basis of specific identified cost. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Participant loans are presented at their unpaid principal balance plus accrued interest. Interest income is recognized monthly on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. When a borrower does not make a loan repayment by the end of the calendar quarter following the quarter when payment was due, the loan is deemed to be in default and is deemed a distribution to the participant.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

The Plan's custodian and third-party administrator charge various administrative fees relating to recordkeeping services performed under contract to the Plan. Under no circumstances will compensation be paid by the Plan to the Employer for services rendered as administrator. Certain expenses of maintaining the Plan may be paid by the Employer. The Employer paid \$13,900 in operating expenses on behalf of the Plan during the year ended December 31, 2024.

NOTE C - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820 - *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB Codification Topic 820 are described as follows:

Level 1 - Inputs in the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

Quoted prices for similar assets in active markets.

Quoted prices for identical or similar assets in inactive markets.

Inputs other than quoted prices that are observable for the asset.

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year end.

Pooled separate accounts: Valued at unit value calculated based on the net asset value of the underlying investments. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value.

Collective trusts: Valued at the NAV of units of the collective investment trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTES TO FINANCIAL STATEMENTS

NOTE D - INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)

Management has elected the method of annual reporting permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company and its affiliates, qualified institutions, have certified that the following information included in the accompanying financial statements and the ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Interest (including interest on notes receivable from participants), dividends and net appreciation of investments as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of the year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of management, the Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statement and ERISA-required supplemental schedule.

NOTE E - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE F - PLAN TERMINATION

Although it has not expressed any intention to do so, with the consent of the unions represented by the Plan, the Employer may discontinue its contributions to the Plan at any time, and terminate the Plan subject to regulations under ERISA. In the event of a Plan termination, participants will become 100% vested in their entire account balance.

NOTES TO FINANCIAL STATEMENTS

NOTE G - COMMITMENT

The Plan's investments include \$3,577,289 allocated to participants who have withdrawn from the Plan as of December 31, 2024 but have not yet been paid. These participants may elect to withdraw their vested balances at any time.

NOTE H - TAX STATUS

The Internal Revenue Service has determined and informed the Plan by letter dated June 30, 2020, that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE I - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments of the Plan are managed by the Principal Life Insurance Company and its affiliates, which is the custodian and record keeper of the Plan. Therefore, these transactions qualify as party-in-interest transactions.

The Plan Sponsor, Befesa Zinc US Inc (BZUS), also sponsors the Befesa Zinc US Inc. Salaried Retirement Savings Plan. Additionally, the parent of the Plan Sponsor owns Befesa Zinc Metal LLC (BZM), which sponsors the Befesa Zinc Metal LLC Salaried Retirement Savings Plan and the Befesa Zinc Metal LLC Hourly Retirement Savings Plan. From time-to-time, employees may transfer between hourly and salaried positions or in some instances between BZUS and BZM, resulting in asset transfers between the retirement plans. These transfers are reported as asset transfers on the accompanying Statement of Changes in Net Assets Available for Benefits.
