Note 1 – Description of the Plan

The following description of the Engrain 401(k) Plan (the "Plan") provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan that was established by Engrain, Inc. (the "Company," "Plan Sponsor," or "Plan Administrator") on January 1, 2018. The Plan is generally available to all employees of the Company and Participating Employers (collectively, the "Employer"). The Plan excludes leased employees and reclassified employees. To become eligible, an employee must complete one month of service. Employees may enter the Plan on the first day of each month coincident with or following the date the employee meets the Plan's eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation.

Contributions. The following types of contributions are allowable under the Plan:

- Elective Deferral Contributions – Participants may contribute a percentage of their pre-tax annual compensation, as defined in the Plan document, subject to limitations. Participants may also contribute a percentage of their after-tax compensation and designate it as a Roth elective deferral contribution. A participant's total elective deferral contributions cannot exceed \$23,000 (\$30,500 if age 50 or over) in calendar year 2024.
- Safe Harbor Employer Matching Contributions – The Employer makes safe harbor matching contributions each payroll period equal to 100% of the participant's elective deferrals that do not exceed 3% of their compensation plus 50% of the participant's elective deferrals that exceed 3% but that do not exceed 5% of their compensation.
- Additional Discretionary Employer Matching Contributions – The Employer may contribute additional matching amounts each Plan year to eligible participants based on such participants' elective deferrals contributed to the Plan. Such contribution is limited to elective deferrals that do not exceed 6% of a participant's compensation. During 2024, the Employer did not make an additional discretionary Employer matching contribution.
- Discretionary Employer Nonelective Contributions – The Employer may make a discretionary nonelective contribution each Plan year to eligible participants who have completed 1,000 hours of service and are employed on the last day of the Plan year. Participants who die, become disabled, or attain normal retirement age during the Plan year are also eligible to receive an allocation of discretionary Employer matching contributions. This contribution is allocated based on a classification method whereas each participant constitutes a separate classification. During 2024, the Employer did not make a discretionary nonelective contribution.
- Rollover Contributions – Certain amounts distributed to eligible participants from other qualified employee benefit plans may be rolled into the Plan.

All contributions are allocated to the Plan's investment funds at the direction of the participants.

Note 1 – Description of the Plan (continued)

Investment Options. Participants may direct their investments into various pooled separate accounts.

Participant Accounts. Each participant's account is credited with the participant's contributions (elective deferrals and rollovers, if any) and an allocation of (a) the Employer's contribution (safe harbor matching, additional discretionary matching, and discretionary nonelective), (b) fund earnings or losses, and (c) administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting. Participants are immediately vested in their salary deferral contributions, safe harbor Employer matching contributions, rollover contributions, and related earnings thereon. Participants vest in additional discretionary Employer matching and discretionary Employer nonelective contributions based on a three year graded vesting schedule, whereas a participant becomes fully vested after three years of service. Additionally, employed participants become 100% vested in their accounts upon attainment of normal retirement age, death, disability, and termination or partial termination of the Plan.

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (i) \$50,000, reduced by the participant's highest outstanding loan balance during the prior 12 month period, or (ii) 50% of their vested account balance. Loan terms range up to a maximum of 5 years (a longer term up to 15 years is available if used for the purchase of a principal residence). The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1% as determined by the Plan administrator at the date the loan is granted. Principal and interest payments are generally paid ratably through payroll deductions or an ACH agreement.

Payment of Benefits. Benefits to participants or beneficiaries generally are payable as a lump sum equal to the value of their vested account balance upon retirement, disability, death or termination of the participant. A terminated employee with a balance of less than a certain dollar threshold, as defined by the Plan document, may be automatically paid out by the Plan upon termination. Additionally, participants may request in-service withdrawals of their rollover contributions account or certain portions of their account upon attainment of age 59½, upon a deemed severance, for a qualified reservist distribution, or if they incur a financial hardship, as defined in the Plan document, if certain criteria are met.

Plan Expense Account. The Plan maintains a Plan Expense Account ("PEA") that is funded by revenue credits from the Plan's service provider and used to pay administrative expenses of the Plan. During 2024, the PEA paid \$6,240 in administrative expenses of the Plan. The balance in the PEA was \$0 and \$0 as of December 31, 2024 and 2023, respectively.

Note 2 – Summary of Significant Accounting Policies

Use of Estimates and Basis of Accounting. The accompanying financial statements are prepared on the accrual basis of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions. Participant contributions and the related Employer matching contributions are recognized in the period in which participant contributions are withheld from compensation.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefits Payments. Benefits are recorded when paid.

Expenses and Revenue Credits. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Also included in administrative expenses are recordkeeping, investment advisory, investment management, distribution, and other fees. Additionally, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments.

As further discussed in Note 1, the Plan provides for participant revenue credits which are used to offset the Plan's administrative expenses. For the year ended December 31, 2024, the Plan's administrative expenses and participant revenue credits netted to \$31,190, which consisted of \$37,430 in administrative expenses and \$6,240 in participant revenue credits.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

- Pooled Separate Accounts (“PSAs”) are valued at the NAV of units held by the Plan at year end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the PSAs less their liabilities. This practical expedient is not used when it is determined to be probable that the PSAs will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination or partial termination, affected participants will become 100% vested in their accounts.

Note 6 – Tax Status

The Company has adopted a Qualified Pension Services Inc Non-Standardized Pre-Approved Profit Sharing Plan ("pre-approved plan"). The pre-approved plan received an opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the pre-approved plan is qualified under the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan and pre-approved plan have been amended since receiving the IRS opinion letter, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified under Section 401(a) of the IRC and the related trust is tax exempt as of December 31, 2024 and 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Party-In-Interest Transactions

The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

Certain Plan investments are units of pooled separate accounts offered by John Hancock Life Insurance Company. As John Hancock Life Insurance Company is the custodian of the Plan, these transactions qualify as party-in-interest transactions. Additionally, the Plan provides for notes receivable from participants. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

Note 8 – Nonexempt Prohibited Transactions

During 2022, the Company had nonexempt prohibited transactions related to participant contributions not remitted to the trust in a timely manner as listed in the aggregate on Schedule H, Line 4a: Schedule of Delinquent Participant Contributions. The Company intends to correct these late contributions by remitting lost earnings into the Plan's trust as soon as administratively feasible.

Note 9 – Concentrations, Risks, and Uncertainties

The Plan provides for various investment options in pooled separate accounts. Investment securities, in general, are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts presented in the statements of net assets available for benefits. As of December 31, 2024 and 2023, there were three investments, which individually represented more than 10% of net assets available for Plan benefits. See supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at December 31, 2024.

Additionally, some investments held by the Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

Note 10 – Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 26, 2025, which is the date the financial statements were available to be issued.
