The plan sponsor(s) has operated the plan and trust or insurance contract in a manner that did not jeopardize this tax status.
36. The plan has complied with the fidelity bonding requirements of ERISA.
37. There are no:
 - Nonexempt party in interest transactions (as defined in ERISA Section 3(14) and regulations under that section) that were not disclosed in the supplemental schedule or financial statements.
 - Investments in default or considered to be uncollectible that were not disclosed in the supplemental schedule.
 - Reportable transactions (as defined in ERISA Section 103[b][3][H] and regulations under that section) that were not disclosed in the supplemental schedule.
38. We have been provided the required information from our Plan service providers relating to the 408(b)(2) rules and understand our responsibilities as it relates to fiduciary duties on Plan fees and have complied with the regulations.
39. Management has reviewed the valuation and agrees with the assumptions, and approach used and the value derived. We assume responsibility for the findings of the valuator in evaluating the present value of the fair value of employer stock and have adequately considered his or her qualifications in determining the amounts and disclosures used in the financial statements and underlying accounting records. We did not give nor cause any instructions to be given to the specialist with respect to the values or amounts derived in an attempt to bias his or her work, and we are not otherwise aware of any matters that have had an effect on the objectivity of the specialist.

40. We have obtained the service auditor's report from our service organizations. We have reviewed such reports, including the complementary user controls. We have implemented the relevant user controls, and they were in operation for the year ended December 31, 2024.
